

PARTICIPANT'S RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

2026-2027

BY SIGNING THIS AGREEMENT, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH, OR PROPERTY DAMAGE. READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. YOUR SIGNATURE INDICATES YOUR UNDERSTANDING AND AGREEMENT TO ITS TERMS.

This is an agreement between the Undersigned and Las Damas Incorporated, including any host ranch or landowner, its officers, directors, members, employees, agents, representatives, volunteers, sponsors, sanctioning organizations, successors, and assignees (hereinafter the "Releasees"). I (hereinafter the "Undersigned") on behalf of myself, my personal representatives, heirs, next-of-kin, spouse, and assignees hereby agree to make the following contractual representations pursuant to this agreement (the "Agreement"):

1. **RULES AND REGULATIONS:** I hereby agree that I have read, understood, and agree to be bound by all rules, instructions, and policies established or given by Las Damas Incorporated, any host ranch or landowner and/or any of their employees, agents, or volunteers with regard to my participation in any event, use of a horse, or any equipment or gear provided therewith.
2. **ACKNOWLEDGEMENT OF RISK:** I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with horseback riding and know that horseback riding and related equestrian activities are inherently dangerous, and that participation involves RISKS that may cause SERIOUS BODILY INJURY (including broken bones, head, or neck injuries) and in some cases DEATH because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance.
3. **ASSUMPTION OF RISK:** I understand that the aforementioned Risks may be caused in whole or in part, or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of other participants, or the negligent acts or omissions of the Released Parties defined within this agreement, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation. I hereby RELEASE, DISCHARGE, AND PROMISE NOT TO SUE the Releasees for any loss, liability, damage, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to my person or property. Additionally, I release the Releasees from any claim that such Releasees are or may be negligent in connection with my riding experience or ability including but not limited to training or selecting horses, maintenance, care, fit or adjustment of saddles or bridles, instruction on riding skills, or supervising riding activities.
4. **WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY:** I hereby indemnify and hold harmless the Releasees from and against any loss, liability, damage, or cost that they may incur arising out of or in any way connected with any event, my use of a horse, and any equipment or gear provided therewith or any acts or omissions of employees or agents.
5. **ALCOHOL RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS, AND INDEMNITY:** I hereby acknowledge that the Releasees do not provide, sell, or serve alcoholic beverages for any Las Damas functions, and that alcohol consumption is at my own discretion, risk, and liability. The Releasees are not responsible or liable for any damages to me or third parties that result from the consumption of alcohol by myself or others. I hereby assume all risks involved with the consumption of alcohol and unconditionally hold the Releasees harmless.
6. **COMPLETE AGREEMENT AND SEVERABILITY CLAUSE:** This agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements, or inducements have been made apart from this agreement. The Undersigned expressly agrees that the foregoing release and waiver of liability, assumption of risk, and indemnity agreement is governed by the State of Arizona and it is intended to be as broad and inclusive as is permitted by Arizona Law, and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect or impair the validity and enforceability of any remaining provisions.

By signing below, I affirm that I am at least twenty-one (21) years of age, and that I am of sound mind and not under the influence of any substance or condition affecting my mental ability to enter into this agreement. I hereby accept and agree to the terms and conditions of this Agreement in connection with my participation. I acknowledge that this document is a contract and agree that if, despite this agreement, I or anyone else on my behalf makes a claim for Liability against the Releasees, I will indemnify, defend, and hold harmless each of the Released Parties from any such Liabilities as a result of such claim. Additionally, the Undersigned will pay all attorney's fees and costs incurred by the Releasees in defending such an action.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY. I UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS. The parties agree that this agreement may be electronically signed. The parties agree that any electronic signatures appearing on this agreement are the same as handwritten signatures for the purposes of validity, enforceability, and admissibility.
