

PARTICIPANT'S RELEASE AND
WAIVER OF LIABILITY,
ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT (2026-27 fiscal year)

BY SIGNING THIS AGREEMENT, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH, OR PROPERTY DAMAGE. READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. YOUR SIGNATURE INDICATES YOUR UNDERSTANDING AND AGREEMENT TO ITS TERMS.

This is an agreement between me ("the Undersigned"), **Las Damas Incorporated**, its officers, directors, members, employees, agents, representatives, successors, heirs, and assignees (hereafter collectively referred to as **Las Damas Incorporated**), including any host ranch or landowner, its officers, directors, members, employees, agents representatives, volunteers, sponsors, sanctioning organizations, successors and assignees (hereinafter the **Releasees**). I, on behalf of myself, and my personal representatives:

1. Acknowledge that horseback riding is a dangerous activity and involves RISKS that may cause SERIOUS INJURY AND IN SOME CASES DEATH, because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance.

2. Knowing these facts and in consideration of your acceptance of this form, I voluntarily assume the risk and danger of injury or death inherent in horseback riding activities. I hereby RELEASE, DISCHARGE AND PROMISE NOT TO SUE **Las Damas Incorporated** and/or the **Releasees** for any loss, liability, damage, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to my person or property.

3. Release **Las Damas Incorporated** and/or the **Releasees** from any claim that **Las Damas Incorporated** and/or the **Releasees** are or may be negligent in connection with my riding experience or ability including but not limited to training or selecting horses, maintenance, care, fit or adjustment of saddles or bridles, instruction on riding skills or supervising riding activities.

4. INDEMNIFY AND SAVE AND HOLD HARMLESS **Las Damas Incorporated** and/or the **Releasees** from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with any event, my use of a horse and any equipment or gear provided therewith.

5. Agree to abide by and follow any instructions given or rules established by **Las Damas Incorporated** and/or the **Releasees**, regarding my participation in any event, use of a horse or any equipment or gear provided therewith.

6. Acknowledge that **Las Damas Incorporated** and/or the **Releasees** do not provide, sell, or serve alcoholic beverages for any Las Damas functions, and that alcohol consumption is at my own discretion, risk, and liability. **Las Damas Incorporated** and/or the **Releasees** are not responsible or liable for any damages to me or third parties that result from the consumption of alcohol by myself or others. I hereby assume all risks involved with the consumption of alcohol and unconditionally hold **Las Damas Incorporated** and/or the **Releasees** harmless.

7. The Undersigned expressly agrees that the foregoing Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement is governed by the State of Arizona and it is intended to be as broad and inclusive as is permitted by Arizona law, and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.

8. Acknowledge that this document is a contract and agree that if a lawsuit is filed against **Las Damas Incorporated** and/or the **Releasees** any injury or damage in breach of this contract, the Undersigned will pay all attorney's fees and costs incurred by **Las Damas Incorporated** and/or the **Releasees** in such an action.

9. THIS RELEASE AND WAIVER OF LIABILITY IS VALID FROM **October 1, 2026, THROUGH September 30, 2027**, AND APPLIES TO ALL LAS DAMAS INCORPORATED EVENTS AND ACTIVITIES, INCLUDING THE ANNUAL 2027 5-DAY RIDE.

10. I HAVE READ THIS DOCUMENT. I UNDERSTAND IT IS A PROMISE NOT TO SUE AND A RELEASE AND INDEMNITY FOR ALL CLAIMS.
