Rev. Moen opened the meeting with devotions and prayer.

It was m/s/c to have Greg Polzin act as Session Clerk pro tem in the absence of Deb Olson.

It was m/s/c to accept the Treasurer's report.

It was m/s/c to approve the June minutes.

Todd and Peg are scheduled to assist with communion on August 17th. Peg indicated she will be absent. Greg and Kevin both plan to be present so will fill in for Peg.

It was m/s/c to approve the baptism of Axton Thomas Reichter during worship service on August 17th. In addition, the Polzin family asked to use the fellowship hall after the baptism and this request was approved as well.

Session declined to participate in the advertising on a magnet that was brought forth by the Eagle Grove police department. It was m/s/c to renew the CDA membership at the Ambassador level at a cost of \$150.00, however.
