The Champion Township Board of Trustees met in Regular Meeting on October 5, 2020 at 6:30p.m. for the purpose of conducting the business of the township, via conference call under HB 197, Phone-In Meeting 978-990-5242, Participant Code 3519757. Chairman Emerine called the meeting to order with a full board present.

Read the Champion Township Board of Trustees statement concerning Halloween. See attached.

Reminder that all visitors to the Champion Township buildings must make an appointment, which includes employees who are in an off-duty status or someone coming to visit an employee who is on duty. There have been several instances of this although, due to the Governor's and Health Director's orders, our buildings remain closed to the public unless an appointment is made in advance. Employees and visitors should keep discussions limited to no more than 15 minutes and should follow proper social distancing guidelines, should wear a mask unless exempted and should not eat, drink or smoke while on Township grounds.

The meeting minutes for June, July and August 2020 were approved.

Tabled the acknowledgement of the receipt of the September financial reports due to IT difficulties Trustee Templeton was having.

Trustee Bogus made a motion to accept the retirement of John Osborne, Road Department employee, effective September 30, 2020. Mr. Osborne attained 30 year of service in this department. Trustee Templeton seconded. Bugos Yes, Emerine, Yes and Templeton Yes.

R2020-134 Trustee Templeton made a motion to approve the one-year contract extension with the AFSCME Union, retroactive to May 1, 2020. Trustee Emerine seconded. Bugos Yes, Emerine Yes, Templeton No.

G2020-135 Trustee Templeton made a motion to approve revised revenue budget \$4,941,229.03, down from \$5,077,480.28 for submission to the Trumbull County Auditor for approval, Trustee Bugos seconded. Templeton Yes, Emerine Yes, Bugos Yes.

G2020-136 Trustee Bugos made a motion to approve supplemental appropriations to the following funds: General, \$21,000; Cemetery, \$9,000.00; Police, \$20,500; Fire, \$10,000; Road Levy, \$33,200; Permissive MVL, \$12,500 for expenditure in the fourth quarter, Trustee Templeton seconded. Bugos Yes, Emerine Yes, Templeton Yes.

Tabled the discussion to approve Fiscal Office Staff at a rate of \$17.00 per hour from Road or Cemetery Funds for administration time spent on these tasks, not to exceed 350 hours this calendar year. Fiscal Office Staff have been overloaded doing the Road Supervisory tasks and learning the Cemetery for the last thirty-five days. Those hours should be tracked and accounted for from the funds for which they are being expended as these are substantially different tasks from what Fiscal Office Staff were hired to complete. Fiscal Office Staff was originally approved for 500 hours per year, but between unexpected tasks on COVID and Road/Cemetery, staff hours are already over 400.

R2020-137 Trustee Bugos made a motion to approve the final disbursement of the 2018 OPWC Resurfacing and Drainage Project in the amount of \$1,500 and to accept the grant amount of \$585 paid directly to Shelly and Sands by OPWC. The Township's share was \$915, Trustee Templeton seconded. Bugos Yes, Emerine Yes, Templeton Yes.

Tabled the discussion on the hauling of ICM or building a salt structure until the working foreman position has been filled and that person has a change to give the board their input.

Tabled the discussion on the purchase of a backhoe to replace our current John Deere 310EL.

Z2020-138 Trustee Bugos made a motion to approve the refund request submitted to the Board of Zoning Appeals per the legal counsel of Mark Finamore. William Templeton seconded. Bugos yes, Emerine Yes, Templeton Yes.

The workshop was scheduled for December 10, 2020 at 6pm

Reports by Department Heads:

Rhonda Fonce, Zoning Inspector questioned the use of mailbox in lobby while building is closed to the public due to the Pandemic. Fonce stated that she was unable to find a fence at 5212 Alva Ave. Trustee Emerine gave her the correct number to the house; Trustee Templeton said he believed the board had given her the incorrect address at the last meeting. Trustee Emerine questioned the call forwarding to her cell phone. Trustee Templeton questioned the 145 miles for grass cutting and pool liner removal, Trustee Templeton asked for a timeframe and vendor. Fonce responded A-1 Hauling.

Chief Hickey gave an update on the Champion Roller Rink fire. There is no update from the State Fire Marshall. The owner's insurance company did release their report. With snow coming the probability of the roller rink fire site to be cleaned up and removed is unlikely in the near future.

P2020-139 Trustee Templeton made a motion to hire Jarett M. Pishotti to fill the position of part time police officer, pending pre-employment drug screen and background check at a rate of \$12.50 per hour. Trustee Bugos seconded. Bugos Yes, Emerine Yes, Templeton Yes.

Old Business

Received Architect update - \sim \$21,500 proposal from Baker, Bednar and Snyder. There are some questions on the report that have not been answered yet. Discussed the need to request former Trustee Fee to help guide us if we skip in to phase 3 to put up a Coronavirus facility.

The Board authorized submittal of a lesser amount (\$2189) for the Scrap Tire Grant since the building had been closed and residents were not dropping off tires out of season like they usually have an opportunity to do.

Trustee Bugos made a motion to enter into Executive Session to discuss personnel matters, Road Department issues, lawsuit updates, zoning hours, and potential legal action. Trustee Templeton seconded. Passed unanimously.
