



Please read this document carefully. By signing and returning this form, you acknowledge and agree to adhere to the following policies, procedures, and consent agreement for the rental of our party equipment.

I. Booking and Payment

- All bookings must be made at least **5 days in advance**.
- A deposit is required at the time of booking to secure your reservation. The deposit amount will be \$100 and will be applied towards the total rental cost.
- The remaining balance must be paid before set up.
- We accept cash, card, venmo, cash app, chime, and applepay.

II. Equipment Rental and Setup Requirements

- Our rental equipment includes, but is not limited to, bounce houses, inflatable water slides, hot dog warmers, cotton candy machines, and bubble blowers.
- The customer is responsible for ensuring a **safe and suitable setup location** that meets the following requirements:
 - **Flat, level ground** free from rocks, debris, and overhead obstructions (e.g., trees, power lines).
 - Access to electrical outlets within **50 feet** of the setup area.
 - Sufficient space to accommodate the equipment size as specified in the rental agreement.
- We reserve the right to refuse setup if the location is deemed unsafe or unsuitable. In such cases, the deposit may be forfeited.

III. Usage and Safety Guidelines

- An adult (18+) must be present at all times to supervise the use of the equipment.
- **No food, drinks, or toys are allowed on or inside the inflatable equipment.**
- Users must remove shoes, jewelry, and any sharp objects before entering the equipment.
- The number of users inside the equipment at any given time must not exceed the specified limit based on the equipment's size and weight restrictions.
- Roughhousing, flips, and other dangerous activities are strictly prohibited.
- The customer is responsible for ensuring that all users adhere to these safety guidelines.

IV. Damage and Liability

- The customer is responsible for any damage to the equipment that occurs during the rental period, excluding normal wear and tear.
- A damage fee of **\$100-\$500** will be assessed for any significant damage, depending on the extent of the damage.
- Peanuts Jump And Play is **not liable for any injuries** that may occur during the use of the rented equipment. The customer assumes all responsibility for the safety of users.
- This includes, but is not limited to bodily injury, death, personal property damage, property damage.

V. Cancellation Policy

- Cancellations made 48 prior to the scheduled rental date will receive a full refund of the deposit.
- Cancellations made less than 48 hours of the scheduled rental date will forfeit the deposit.
- We reserve the right to cancel the rental due to inclement weather or other unforeseen circumstances. In such cases, a full refund will be provided.

VI. Consent and Agreement

By signing below, I acknowledge that I have read, understood, and agree to the terms and conditions outlined in this Party Rental Policy, Procedure, and Consent Form. I understand that I am responsible for ensuring the safety of all users of the rented equipment and that Peanuts Jump And Play is not liable for any injuries that may occur. I also understand that I am responsible for any damage to the equipment that occurs during the rental period.
