OUR WATER DISTRICT TAX EXPLAINED

A common misconception is that Tanglewood Forest Limited District is an HOA. We are not. We operate in partnership with The City of Austin under the Texas local government code as a Water District. As such, we manage our own neighborhood amenities such as the pool, tennis courts and parks. We also get to set our own tax rates for the maintenance, repair, upkeep and landscaping of these community owned assets.

For the last 40+ years, we have focused on "maintaining" our amenities. And we can continue to do so. However, the pool and tennis courts are in need of significant repairs.

Timing is the biggest issues we face: Now or Later?

In August, the TFLD Board voted to approve raising the limited district tax rate from \$0.1628/\$100 to \$0.28/\$100. If approved by district residents in the November election, revenue generated from the increase will be used for capital improvements. By doing this, the board effectively decided to LET THE NEIGHBORHOOD DECIDE if the timing is right to tackle these projects.

The debate at the August TFLD meeting centered on the fact that our residents will be voting on additional property tax requests from entities such as The City of Austin and Austin Independent School District. Instead of saying "NO" to our community needs, the board voted to let our district residents decide if we tackle capital improvements in our own neighborhood now or later.
