- 12. Discuss and consider contract with new general management company;
- 13. Discuss and consider contract with web designer;
- 14. Discuss and consider updates to District website and Director emails;
- 15. Discuss and consider setting the District's calendar for 2020;
- 16. Discuss and consider the City of Austin's plan to update its land development code and the impact on the District;
- 17. Discuss and consider the District's Park Rules;
- 18. Discuss and consider retaining an auditor for the FY19 audit;
- 19. Receive restrictive covenants report and consider any action regarding restrictive covenant enforcement, land use compliance, proposed land use and litigation matters, including District's process for legal action and legal action on covenant enforcement;
- 20. Receive General Counsel report, including, but not limited to, pending contract issues, open records requests, litigation matters, legal investigations, and other legal issues, if any;
- 21. Receive committee reports from Directors;
- 22. Discuss and consider time, date, and agenda items for the next Board meeting; and

PUBLIC COMMENT

23. Receive communications from the public on items not listed on the posted agenda; [Members of the public may sign up to speak for three (3) minutes regarding general topics or specific agenda items. If speaking on specific agenda items, citizens may speak one time per agenda item. Those desiring to speak must complete the citizen communication form supplied by the District so they may be recognized by the Board President. In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual

information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.]

The Board of Directors is authorized by the Texas Open Meetings Act to convene in closed or executive session for certain purposes. These purposes include receiving legal advice from its attorney pursuant to §551.071 of the Texas Government Code; discussing real property matters pursuant to §551.072 of the Texas Government Code; discussing gifts and donations pursuant to §551.073 of the Texas Government Code; discussing personnel matters pursuant to §551.074 of the Texas Government Code; discussing security personnel or devices pursuant to §551.076 of the Texas Government Code. If the Board determines to enter executive session regarding any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision from the Open Meetings Act that authorizes the closed or executive session.
