Individual members of the public wishing to address the Board at this meeting must register to speak in the 15-minute period before the meeting begins by signing up on the attendance form. Individual members of the public may address the Board for a maximum of 3 minutes on items not on the current agenda under public comment and for a maximum of 2 minutes per person per agenda item. Members of the public may collectively address the Board for a total of 15 minutes on items not on the current agenda under public comment. Individuals may address the Board once per item. No formal action, discussion, deliberation, or comment will be made for items not on this agenda.

### PUBLIC COMMENT

- 1. Receive communications from the public on items not listed on the posted agenda; [Members of the public may sign up to speak for three (3) minutes regarding general topics. Those desiring to speak must complete the citizen communication form supplied by the District so they may be recognized by the Board President. In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.]
- 2. Public Comment on Agenda Items; [Members of the public may comment on any agenda item listed below. Members of the public may speak for up to two minutes per agenda item on which they comment. Members of the public will speak on an agenda item after the item is called by the presiding officer, but before Board consideration of the item. Those desiring to speak must complete the citizen communication form supplied by the District so they may be recognized by the Board President.]

- 4. Discuss and consider taking action regarding 2024 tax rate, including;
  - (a) establishing proposed tax rate and taking record vote

- (b) authorizing expense and publication of "Notice of Hearing on Tax Rate" in the Newspaper; and
- (c) acknowledging and approving posting of "Notice of Hearing on Tax Rate" to home page of District website.
- 5. Discuss and consider action regarding time, date, and agenda items for the next Board meeting.

The Board of Directors is authorized by the Texas Open Meetings Act to convene in closed or executive session for certain purposes. These purposes include receiving legal advice from its attorney pursuant to \$551.071 of the Texas Government Code; discussing real property matters pursuant to \$551.072 of the Texas Government Code; discussing gifts and donations pursuant to \$551.073 of the Texas Government Code; discussing personnel matters pursuant to \$551.074 of the Texas Government Code; discussing security personnel or devices pursuant to \$551.076 of the Texas Government Code. If the Board decides to enter executive session regarding any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision from the Open Meetings Act that authorizes the closed or executive session.
