Your puppy must weigh at least 2 pounds or be 12 weeks old before the transfer from our kennel to you will occur. If you want to receive your puppy before these conditions are met, this entire contract will be considered null and void. (____) initial

A veterinarian will examine this puppy at least once, if not twice, and it will be free of any illnesses or health concerns. We do not cover patella luxation once the puppy leaves our premises, as this condition can occur from being dropped, jumping, or playing with other dogs, children, and adults.

KNJ Precious Paws LLC guarantees this puppy to be free of all communicable diseases for a period of 7 days from the date of sale other than Parvo as described in the above paragraph. KNJ Precious Paws LLC also guarantees this puppy to be free of genetic defects that make the puppy not suitable for the purpose of a family pet until the puppy reaches one year of age. Buyer understands that the following slight genetic defects are not considered serious or life-threatening and therefore are not covered: **any parasites or fleas/ticks picked up during travel, ear irritation/infection, Brachycephalic Obstructive Airway Syndrome, (BOAS), collapsing trachea, umbilical hernia, undescended testicle, underbite or overbite, Grade 1 or Grade 2 luxating patella.** This guarantee does not include any injuries or problems the puppy develops due to negligence or abuse by the owner. Buyer understands that the replacement option is only valid when health problems are attributed to a hereditary problem and not due to accident, contagious, and/or other illnesses. Buyer understands that any and all guarantees expire one year from the date of purchase. (____) initial

Your puppy should be taken to the vet within 72 hours of arrival for a Well Puppy Check-Up. This ensures confirmation of the puppy's condition upon arrival. If you do not do this, the contract will become null and void. KNJ Precious Paws LLC does not guarantee against Parvo after 72 hours from arrival. Additionally, KNJ Precious Paws LLC does not guarantee against the following parasitic illnesses: coronavirus, coccidiosis, or giardia, as these parasites can be contracted almost anywhere, and vaccinations will not protect your puppy from them. Furthermore, KNJ Precious Paws LLC cannot guarantee against hypoglycemia, also known as low blood sugar or sugar shock. (____) initial

Health Guarantee (continued)

If your veterinarian believes your puppy has any health defects that make it a poor health risk, you must notify KNJ Precious Paws LLC within seven days from purchase. Veterinary bills and/or medications are not covered in the guarantee. Credit will be given in the form of a replacement puppy of equal value or, if applicable, repair of the defect at the discretion of KNJ Precious Paws LLC. If the puppy is to be returned, the return should occur within ten days, including all papers and a signed statement from the veterinarian. (____) initial

In the unlikely event of the death of the puppy, the new owner will need to provide proof of death by a necropsy report stating the cause of death. The report must be completed by a licensed veterinarian and submitted on the veterinarian's letterhead. KNJ Precious Paws LLC will pay for transportation for the replacement puppy.

Guarantee of the actual mature weight of the puppy is not possible. We can estimate it based on the puppy's current weight and the parents' current weight, but other factors such as genetics, overall health, and diet also affect mature weight. (____) initial

KNJ Precious Paws LLC will provide registration papers when full payment is received from the Buyer. Transfer of ownership will not take place until all fees are paid in full. (____) initial

Health Insurance: PROOF OF INSURANCE IS A MUST!

Puppies are fast and unpredictable, which can lead to accidents. They are also susceptible to hypoglycemic crashes, coccidia, and other issues, which can result in expensive veterinary and hospital bills. To ensure your puppy receives any necessary medical care, we now require that your puppy/dog have health insurance before leaving our facility. (____) initial

You can select any pet health insurance company you prefer. Below is a company we recommend: Trupanion waives the typical 30-day waiting period for their insurance to start if you enroll during the specified timeframe and use the promo code I will provide.

Trupanion Pet Health Insurance offers a 30-day ***free trial*** of its insurance. When you sign up the day before your puppy leaves us, the insurance takes effect immediately without the usual 30-day waiting period. However, to qualify for the 30-day free trial, you must enroll and use my promo code during the specified time frame. This code will be sent to you. (____) initial

If you decide against insuring your puppy, this Health Guarantee becomes null and void. (____) initial
