

## **Study Placer LLC — Terms of Service**

### **1. Agreement to Terms**

These Terms of Service govern your use of the Study Placer mobile application.

By installing or using the App, you agree to these Terms.

If you do not agree, do not use the App.

### **2. Beta Disclaimer**

The App is a beta product provided for testing and evaluation.

Features may be incomplete, inaccurate, or unavailable. Errors, crashes, and interruptions may occur.

The App is provided “as is” and “as available,” without warranties of any kind, express or implied, including warranties of merchantability, fitness for a particular purpose, title, and non-infringement.

### **3. Eligibility**

You must be at least 13 years old, or the minimum age of digital consent in your jurisdiction, to use the App.

### **4. No Affiliation**

Study Placer is an independent product and is not affiliated with, endorsed by, or sponsored by any school, college, or university

Any institutional names or course labels that appear in the App reflect information you entered for organization purposes.

### **5. User Responsibilities**

You are responsible for complying with your institution's policies, maintaining the security of your device, and ensuring the courses, assignments, and scheduling information you enter are accurate for your needs.

If you participate through Apple TestFlight, Apple may collect crash logs, usage information, and feedback and share them with Study Placer as the application provider.

This collection is controlled by Apple and cannot be opted out of while using TestFlight.

## **8. Feedback License**

If you provide feedback, suggestions, or bug reports, you grant Study Placer LLC a perpetual, irrevocable, worldwide, royalty-free license to use, host, store, reproduce, modify, and create derivative works from the feedback to improve products and services, without obligation to you.

## **9. Termination**

Study Placer may suspend or terminate access to the App at any time during the beta period for maintenance, security, misuse, or at its discretion.

Upon termination you must cease using the App.

Data stored on your device may remain until you delete the App.

The state and federal courts located in Oktibbeha County, Mississippi will have exclusive jurisdiction and venue for disputes that are not subject to informal resolution.

If any provision of these Terms is found unenforceable, the remaining provisions will remain in full force.

These Terms constitute the entire agreement between you and Study Placer regarding the App and supersede all prior or contemporaneous understandings on that subject.
