

Noble Star Tours Policies & Procedures

Deposits, Payments, Refunds & Cancellations

The minimum deposit must be paid to reserve your spot on your chosen tour. Deposits amounts vary and are listed for each tour. Deposits are per person and are non-refundable. Payment in full must be made by the final payment date. Final payment date varies based on individual trips and may be 45 or 60 days prior to departure.

Cancellations made before the final payment date will be refunded the amount paid minus the deposit. Cancellations made 60-30 days prior to departure will receive a refund of 50%. Any cancellations made less than 30 days prior to departure date incur a 100% cancellation fee. You may choose to purchase separate travel insurance of your choice. (this is separate from Noble Star Tours)

If unforeseen circumstances cause any trip to be cancelled by Noble Star Tours we will provide a return of all participant funds. This may include tours cancelled due to lack of participation.

Any reservation made after the final payment date must be paid in full by credit card at the time of the reservation.

Reservations that have not been paid in full by the final payment date are subject to cancellation and loss of all funds paid.

Participant Restrictions

Age-All participants on any Noble Star Tour must be at least 12 years of age.

Health & Fitness-It is each person's responsibility to determine if a Noble Star Tour is suitable for their participation. If needed, consult with your physician before registering for a tour. Motorcoach transportation provided is not equipped with a wheelchair lift. Tours may require periods of standing in line and walking significant distances including stairs.

Itinerary Adjustments

Noble Star Tours reserves the right to adjust proposed itineraries if the need arises due to weather, participation, and unforeseen circumstances. Our best effort will be made to make the adjustment to the best alternative available at the time.

Understanding Risks

Participants in Noble Star Tours understand there are risks associated with travel including, but not limited to: loss or damage to baggage and belongings, natural disasters & weather changes, criminal acts of third parties, accidents, possible exposure to illness including Covid-19, and more than cannot be completely compiled into this statement. Participants accept and assume these risks, known and unknown when registering for a Noble Star Tour.

Participant Conduct

Tour participants agree that Noble Star Tours is not responsible for their behavior, damages or injuries they cause. Noble Star Tours reserves the right to decline or terminate a person's participation in a tour if they determine participants behavior causes hardship to Noble Star Tours, other tour participants, and/ or third parties doing business with Noble Star Tours.
