




# Florida Statutes

Domestic Violence, Child Abuse, & Abuse

### **Domestic Violence**

### - F.S. 741.28(2)

"Domestic violence" means any assault, aggravated assault, battery, aggravated battery, sexual assault, sexual battery, stalking, aggravated stalking, kidnapping, false imprisonment, or any criminal offense resulting in physical injury or death of one family or household member.

### **Child Abuse**

### - F.S. 827.03(1)(b)


"Child abuse" means:


- 1. Intentional infliction of physical or mental injury upon a child;
- 2. An intentional act that could reasonably be expected to result in physical or mental injury to a child; **or**
- 3. Active encouragement of any person to commit an act that results or could reasonably be expected to result in physical or mental injury to a child.


### **Abuse**

### - F.S. 39.01(2)

"Abuse" means any willful act or threatened act that results in any physical, mental, or sexual abuse, injury, or harm that causes or is likely to cause the child's physical, mental, or emotional health to be significantly impaired. Abuse of a child includes the birth of a new child into a family during the course of an open dependency case when the parent or caregiver has been determined to lack the protective capacity to safely care for the children in the home and has not substantially complied with the case plan towards successful reunification or met the conditions for return of the children into the home. Abuse of a child includes acts or omissions. Corporal discipline of a child by a parent or legal custodian for disciplinary purposes does not in itself constitute abuse when it does not result in harm to the child.

57% of the children who had witnessed domestic violence were also direct victims of child maltreatment

1 out of 15 children in the U.S. are exposed to DV each year per DOJ


#### **How Domestic Violence Affects Preteens**

- Children who witness domestic violence or are victims of abuse themselves are at serious risk for long-term physical and mental health problems.
- Children who witness violence between parents may also be at greater risk of being violent in their future relationships.
- Witnessing domestic violence is the single best predictor of domestic violence in adulthood.



 Globally, 1 out of 8 people have witnessed domestic violence as children.

 Annually, ≈ 3-15 million children witness domestic violence in the United States.





Males who batter their wives batter the children
 30% to 60% of the time.


 Living with domestic violence significantly alters a children's DNA, aging them prematurely 7-10 years.



### **How Domestic Violence Affects Preteens**

### **Symptoms**

Newborn to 5 Year Old	<u>Ages 6 to 12</u>
Bed-wetting	Depression
Thumb-sucking	Withdrawal
Increased crying	Low self-esteem
Whining	Low academic performance
Difficulty sleeping or staying asleep	Bad behavior at school
Stuttering	Nightmares
Hiding	Aggression and difficulty with peers
Severe separation anxiety	School avoidance/truancy


