# Flagstaff's Bulky Waste Collection Program

#### Collection instructions

Pile items at the curb no sooner than one week prior to the start date and no later than 6am on the Monday of your collection week Please keep piles neatly organized and less than 5x5x5 feet Piles must be kept a minimum 3 feet from all other objects, including utilities, mailboxes, and fences

Piles cannot block right-of-ways, sidewalks, or pedestrian access points

#### Acceptable items

Non-putrescible trash that doesn't fit in your bin Small furniture neatly stacked at the curb Tree limbs less than 5 feet long and 4-6 inches in diameter Yard debris that is bagged, boxed, or bundled

#### Unacceptable items

Appliances containing refrigerant/ freon
White goods (washer/dryer, dishwasher)
Dead animals, tires, auto parts
Hazardous waste, chemicals, liquids
Construction debris
Queen and king size mattresses
Plate glass, mirrors Amberwood is in Section 3 and our pickup dates are:

# **Flagstaff Property Taxes**

Our property taxes seem to increase each year. Flagstaff property taxes are based on four key factors:

- 1. Property's Limited Value (LPV)
- 2. Property's Full Cash Value (FCV)
- 3. Primary Tax Rate (PR)
- 4. Secondary Tax Rate (SR)

In 2012 Arizona voters approved Proposition 117 which limited the annual percentage increase in property values used to determine property taxes to no more than 5% and establised a single limited property value (LPV) as the basis for determining property taxes. The LPV cannot exceed the FCV. The new law went into effect in 2015. The Coconino County Assesor adjusts the FCV annually based on market conditions, improvements etc. You can see your property's FCV and LPV by searching your property at the County assessor's page <a href="here.">here.</a> Or, you can also see the FCV history at the Zillow site for your property. In Amberwood the typical increase in FCV was about 30% for 2023 and is 25% for 2024. A sampling of the county's FCV for Amberwood homes resulted in the following averages: The LPV goes up 5% annually but is capped at the FCV.

| • | 2025 | FCV up 1.3%   | LPV up 5% |

Primary rates are set to pay for the basic maintenance and operation of government entities, such as counties, cities, towns, and school districts. Secondary rates are set to pay for bonded debt, special district taxes, and property tax overrides. The state contributes some aid to education which reduces the tax bill. Primary and Secondary rates have remained relatively stable for the past few years so the annual tax increases are mostly a result of the 5% increase in LPV.

Assessed values are 1/10th of the value. Primary and Secondary rates are applied to the LPV which limits the annual tax increases.

$$Tax = (LPV/10) * PR + (LPV/10) * SR - (State Aid)$$

#### Safe Sidewalk Code

The City of Flagstaff municipal codes prohibit dirt, cinders, snow, ice, vegetation or any other obstruction from remaining on public sidewalks.

- Any owner, occupant, tenant or person caring for any building, lot or parcel of land that borders a public sidewalk is responsible for clearing those sidewalks.
- All accumulated snow, ice and debris must be removed within 24 hours after accumulation ends.
- Noncompliance: If sidewalks are not maintained, the City of Flagstaff may perform the required cleaning.

# **Firework Regulations**

Firework regulations are covered by Federal regulations (National Forest), Arizona Revised Statues (ARS), County code, and Flagstaff city code. The Flagstaff Fire Department provides a summary and FAQs here. All fireworks are prohibited in the City of Flagstaff except except from June 24th through July 6th and December 24th through January 3rd each year when **permissable** consumer fireworks are permitted.

Permissable consumer fireworks **include** ground and handheld sparkling devices, cylindrical fountains, cone fountains, illuminating torches, wheels, ground spinners, flitter sparklers, toy smoke devices, wire sparklers or dipped sticks, multiple tube ground and handheld sparkling devices, cylindrical fountains, cone fountains, and illuminating torches.

Permissable consumer fireworks **do not include** anything that is designed or intended to rise into the air and explode or to detonate in the air or to fly above the ground, including fireworks known as firecrackers, bottle rockets, sky rockets, missile-type rockets, helicopters, aerial spinners, torpedoes, roman candles, mine devices, shell devices and aerial shell kits or reloadable tubes. These items are NEVER allowed within the city of Flagstaff. If it makes a loud bang it is illegal and a disturbance to the neighboorhood. Be considerate of your neighbors.


#### **Amberwood Powerlines**

Electricity is generated at power plants and moves through a complex system, sometimes called the **grid**, of electricity substations, transformers, and power lines that connect electricity producers and consumers. In the United States, the entire electricity grid consists of hundreds of thousands of miles of high-voltage power lines and millions of miles of low-voltage power lines with distribution transformers that connect thousands of power plants to hundreds of millions of electricity customers all across the country. There are three power grids in the United States:

- The Eastern Interconnection, which operates in states east of the Rocky Mountains.
- The Western Interconnection, which covers the Pacific Ocean to the Rocky Mountain states.
- The Texas Interconnected system.

In our neighborhood we have two sets of powerlines. The larger set are transmission lines and the smaller set are distribution lines. For the most part, distribution lines for Amberwood and Country Club are underground.

The transmission line alongside Abbey Rd. is a 230 Kv three phase AC line. The smaller set of lines are distribution lines around 33 Kv AC. High voltages are used to keep power losses low and line size (diameter) small. AC is used because the voltage can be easily changed using transformers. To keep line weight low and inexpensive, lines are not insulated. Insulation disks are used between the line and the support structure. Insulation between lines and ground is provided by the air. Thus, higher voltage lines are higher above the ground and there is a greater distance between lines. For more information you could view this <u>Electric Transmission Video</u>.

# **Crispy Gingersnaps**

Classic Crispy Gingersnaps are thin and crunchy with the perfect amount of molasses and spice, this easy homemade recipe takes 30 minutes to make!

# **Ingredients**

- 1 ½ sticks unsalted butter, at cool room temperature
- 1 ¼ cups granulated sugar
- ¼ cup lightly packed light brown sugar
- ⅓ cup unsulphured molasses
- 1 large egg
- ½ teaspoon salt
- 2 teaspoons baking soda
- 1 ½ teaspoons ground ginger
- 1 teaspoon ground cinnamon
- ¼ teaspoon ground cloves
- ½ teaspoon white pepper
- 2 ¼ cups all-purpose flour

### **Instructions**

- Preheat the oven to 350°F. Line baking sheets with parchment paper.
- In a large bowl beat the butter, ¾ cup granulated sugar, and brown sugar until light and fluffy, about 2 minutes.
- Add the molasses and egg and beat until combined.
- Mix the salt, baking soda, ginger, cinnamon, cloves, white pepper, and flour. Add to sugar-molasses mixture and beat until combined.
- Place the remaining ½ cup sugar in a shallow dish. Scoop the dough into 1 ½ tablespoon balls and roll in the sugar before placing on the baking sheet, leaving plenty of room for spread.
- Bake for 15 minutes or until the cookies are spread and the surface looks crackled.
- Let cool on the baking sheets for 5 minutes before removing to wire racks to cool completely.
