Denise – what was the point of the partner feedback?

CE – 4 new families finish PSP enrollment, about 3 families sign up each week for help finding a good preschool for their child. CE partner meeting coming up this month.

12/29 Event – 21 parents, extensive notes coming soon. Rural families have trouble finding care, some families don't feel safe sending their children to care, they have safety concerns knowing that many in their communities are following health and safety guidelines. Extended care hours still a high need, shift work, overnight care.

Monitoring report 2017-19 is in final editing stage, we should expect to see it by the end of the month and can share with partners at that time.

Get Prepped for Preschool – ELHCC partnering with CPT on a virtual event this year. Please share with parents and other schools. Event will include live zoom panel and drive thru material pick up. Ready Set Go is partnering to help ELHCC with pick up distribution.

Adam – ELD working on Theory of Change. They shared a draft last week, not ready for distribution yet but it's very positive, it clarifies the system change role of the hubs across the state. I think it's very well done, it includes a one pager as well as additional pages citing Raise Up Oregon. It's exciting, looking forward to sharing out soon. Hope it will help inform some of the legislation.

Membership Committee Requirements

Time Commitment

The Membership Committee will meet as often as needed for membership vacancies to be filled and annually to select candidates for Chair Elect position.

Participation and Responsibilities: Excerpt from Governance Bylaws (Section 4)

- A. The Membership Committee shall consist of: at least one parent committee member; at least one Governance Council member, the Early Learning Systems Coordinator plus, when possible, the immediate past chair of the Governance Council who shall serve as an ex-officio member of the committee. The Membership Committee shall elect its own chair from among its members.
- B. Committee members will be selected by the committees they represent for a one year term, renewable.
- C. The duties of the Membership Committee regarding officer positions shall include:
 - Once yearly, ensuring that a qualified slate of candidates for the Chair Elect officer
 position is presented to the ELHCC Governance Council for election, no fewer than
 30 days prior to such election.
 - 2. Cultivating strong relationships with current members to develop future leaders within the council through mentoring and professional development.
 - 3. Employing all reasonable efforts to provide a pool of candidates that is representative and diverse in its composition, by dimensions such as age, gender, race and ethnicity, geographic dispersion, political perspective and/or affiliation and professional skill/discipline.
 - 4. Employing all reasonable efforts to provide that officer positions on the council are rotated amongst represented disciplines.
- D. The duties of the Membership Committee regarding council membership shall include:
 - 1. Throughout the year, ensuring that all sectors required by the Early Learning Division are represented on the Governance Council, the Membership Committee shall review potential member applications and present qualified applicants to the Governance Council for final approval. The sector representatives must be persons living or employed by an organization that provides services in Clackamas County and representative of:
 - Early care and education
 - o K-12
 - Department of Human Services
 - Business
 - Health Care services
 - 2. All reasonable efforts to provide a pool of candidates that is representative and diverse in its composition, by dimensions such as age, gender, race and ethnicity, geographic dispersion, political perspective and/or affiliation and professional skill/discipline.

Legislative/Hub Grant Committee

Time Commitment

The Legislative and Hub Grant Committee is a short term committee. Group will meet approximately five times, monthly from February to June 2021. Meetings will be virtual for about two hours and more meetings may be added as needed to meet deadlines.

Participation and Responsibilities

This Committee has arisen from the needs of the work and is not described in our bylaws. Instead the general framework for the work is below.

- A. Diversity in members of this group is important to be sure that decisions and grant request drafting are designed with an equity lens. The committee shall elect its own chair from among members. It is ideal that members include (at least):
 - 1. The Early Learning Hub Director
 - 2. One parent
 - 3. One representative from a Coordinated Enrollment Partner agency
 - 4. One representative from K-12 partners
- B. If parent representatives are not available from within the council, proposed grant narratives will be reviewed by parents from partner groups before submission to the Early Learning Division (ELD).
- C. The duties of the Legislative/Hub Grant Committee shall include:
- 1. Drafting responses to required questions in the Hub Grant request for the 2021-2023 biennium.
- 2. Proof reading and providing feedback to scope of work and other responses drafted by EL Hub/Clackamas County staff.
- 3. Discuss legislative updates for 2021 session to determine if they require presentation to the Council for discussion or action.
