- ! CMS has flagged 400+ hospices for legitimacy concerns and suspended payments.
- ! Failing to act puts your license, funding, and patient mission at risk.

MEDICARE AUDITS ARE HERE: ARE YOU READY?

- ❗ Over 50% of hospices admit they are not ready for a federal audit.
 - ❗ The OIG reports 40% of hospices are non-compliant with Medicare standards.
 - ❗ CMS is expanding enforcement with unannounced visits and audit sweeps across the country.
 - ❗ Hospices lack a current Security Risk Assessment (SRA) or audit-ready documentation.
 - ❗ Failed audits can mean denied claims, repayment demands, and reputational damage.
 - ❗ Is your hospice documentation defensible? Are your policies aligned? Are your staff prepared?
- If not—your license, funding, and patients are at risk.

CMS is Watching & Tracking Every Move...

- 7,000+ unannounced hospice inspections conducted by CMS in a single year.

WALL OF SHAME:

Hospice Beaches are Public and Permanent

When your hospice experiences a breach—technical, administrative, or procedural—it's reported, investigated, and made public. Once listed on the Wall of Shame, your organization is flagged, actively monitored, and subject to audit at any time—without notice.

Who Tracks You:

- HHS Office for Civil Rights (OCR) → HIPAA Breach Reporting Portal ("Wall of Shame").
- CMS Program Integrity Audits.
- Medicare Unified Program Integrity Contractors (UPICs).
- DOJ Medicare Strike Force.
- State Surveyors & Accrediting Bodies.

Examples of Hospice-Specific Breaches:

- Missing Security Risk Assessment (SRA).
- Untrained staff accessing PHI.
- Weak access controls or outdated software.
- Ransomware incidents.
- Inability to produce audit trail or documentation.
- Improper billing + HIPAA violations = funding freeze.



WHAT COMPLIANCE LOOKS LIKE

To stay off the Wall of Shame, you must:

- ✓ Have a current, documented SRA.
- ✓ Enforce role-based access controls.
- ✓ Prove ongoing HIPAA training.
- ✓ Implement NIST-aligned technical safeguards.
- ✓ Maintain audit-ready logs and breach response documentation.
