The primary purpose of the Red Cross Lifeguarding program is to provide lifeguard candidates with the knowledge and skills to prevent, recognize and respond to emergencies and to provide care for injuries and sudden illness until emergency medical services (EMS) personnel arrive and take over. This course does not include any review of swimming skills.

Lifeguard Training Course Prerequisites – Swim Test

To be eligible for the Lifeguarding course, the participant must be 15 years of age on or before the final scheduled day of the course they are participating in. The participant must successfully complete the following:

Prerequisite 1: Complete a swim-tread-swim sequence without stopping to rest:

- Jump into the water and totally submerge, resurface then swim 150 yards using the front crawl, breaststroke or a combination of both. (While swimming, you must swim continuously, keeping your face in the water and demonstrating good breath control. Swimming on the back or side is not permitted. Swim goggles are allowed.)
- After swimming 150 yards, maintain position at the surface of the water without support for 2 minutes by treading water. (Using only the legs, with hands under armpits and with head remaining above the surface of the water.)
- After maintaining position at the surface of the water for 2 minutes, swim 50 more yards using the front crawl, breaststroke or a combination of both.

Prerequisite 2: Complete a timed event within 1 minute, 40 seconds:

- Starting in the water, swim 20 yards. (The face may be in or out of the water. Swim goggles are not allowed).
- Surface dive (feet-first or head-first) to a depth of 7 – 10 feet to retrieve a 10-pound object.
- Return to the surface and swim 20 yards on your back to return to the starting point, holding the object at the surface with both hands and keeping the face at or near the surface. (Swimming the distance under water is not permitted.)
- Exit the water without using a ladder or steps.

Registration Procedures and Policies

- ~ Lifeguard Swim Test **MUST BE TAKEN PRIOR** to participating in any Lifeguard Training. **NO EXCEPTIONS** per American Red Cross.
- ~ Participants who fail the swim test may retake another swim test at no charge.
- ~ Participants who successfully pass the swim test will be eligible to attend their preferred course date on the night of their swim test in the order that their online registration form was received.
- ~ **The Lifeguard Training online Course and manuals MUST be completed/viewed within the week PRIOR TO THE START of the course.**
Website address for manual will be sent once online registration and swim test is completed.
Course itinerary will be sent via email the week of the course.
- ~ CPR/FPR/AED is included in the lifeguard and recert courses.
- ~ We will schedule courses based upon interest. Lifeguard Training/Recertification registrations will be taken in the order of Swim Test registration date.
- ~ Once a course date is established based upon requests, payment for the course will be due in full and non-refundable.
- ~ First year participants will receive CPR mask and hard copy of the manual with training fees. Manual available on line for pre-course study.

- ~ Lifeguard and CPR/FPR/AED Recertification participants may purchase replacement manuals or training masks at cost plus tax and shipping.
