





ADAM WICK



Adam Wick

CEO, Healthy Hemp Outlet

Bio:

Adam Wick spent 20 years in computer IT distribution and upon finding hemp products for his own personal use in 2016 when the industry was just getting started, he had a hard time locating high quality reputable CBD products for his own use. After speaking with several local (Florida) CBD manufacturers he realized there was a need for distribution in the industry and he started a local distributor helping pet stores onboard CBD (DNA Distributor). From that experience he saw that consumers were getting interested In CBD for their own use and in June 2017 he launched an e-commerce website offering only CBD products from reputable vendors (www.hhoutlet.com).

After seeing an initial success that continued to grow month over month, he opened his first retail store in October 2018 in West St. Petersburg, Florida - Healthy Hemp Outlet. Then, after several months of strategic marketing and some gorilla marketing techniques, the local store grew fast and he opened a second store six months later in April 2018 in Downtown St. Petersburg, FL.

Today he owns and operates both a CBD online business, and a CBD retail business, and a specific piece of both businesses currently offer Delta 8 THC products. "I enjoy managing all of these Cannabis Businesses and I enjoy the intricacies and challenges associated with Hemp SEO, CBD Digital Marketing and CBD Local Marketing" says Wick, who spends every day in the retail store interacting with clients, educating them on hemp and hearing their success stories. He just wishes someone would have told him more before he started his CBD business.

His favorite part of the industry is teaching shoppers that are looking at CBD for their first time and have lots of questions (or misconceptions).

By using quick short stories that are easy to relate to, his clients easily understand Cannabis Hemp CBD and how it works. It's a trick he learned in the computer industry, break down the technical conversation for People that don't speak technical language, this way they can understand what it is you are trying to sell. You'll hear him talk about Lettuce offering 2 types - iceberg or romaine, just like Cannabis offers 2 types - Hemp or Marijuana.

In 2019 his business did \$203,000 and he owes no money, has no partners, and is looking forward to growing 3X by 2022. He survived 2020 during the pandemic that brought quaranties and forced closures. His online business helped carry some of the revenue requirements during the dip in 2020 - retail dropped more than 500% (vs. 2021). He would like to grow his online and retail business via a large VC investment, or by joining a new Executive Cannabis Company's team to bring scale operations to a franchise CBD store (in Florida first he hopes), then across the nation. Adam is interested in Venture Capital Partners looking to invest in a Cannabis Business and in need of Enterprise Level Executives to grow a funded operation.

DONATO J. BORRILLO, MD



Presentation Title:

The Benefits of Hemp Derived Flavonoids and Cannaflavins

Dr. Donato J. Borrillo, MD, Brian E. Dickerson, and Jesse Riggins, Chief Research & Development Officer, Star Hemp

Abstract:

Review of the Flavonoids and Cannaflavins in Hemp varieties and review of the results of a clinical study confirming greater pain relief from the hemp derived flavonoids than aspirin and ibuprofen as indicated by Barrett in her 1985 studies. Our clinical study demonstrated greater than 92% received pain relief from using 100 mcg/ml of HempFlavin.

Dr. Barrillo Bio:

Donato J. Borrillo MD is an established medicinal marijuana provider in the State of Ohio and member of the Ohio Medicinal Marijuana Physicians Association. He is a certified Medical Review Officer for post-accident drug screens and impairment determination, and a certified National Registry Department of Transportation (DOT) examiner.

Borrillo is a 1990 graduate of the State University of NY at Buffalo School of Medicine. He interned at Cook County Hospital, Chicago, IL, and completed residency at Wright State University, Dayton, OH. He has a Master of Science degree in Immunology from Roswell Park Cancer Institute, Buffalo, NY, and a second Master of Science degree in Aerospace Medicine, from Wright State University, Dayton, OH.

After his medical residency, Borrillo served as a flight surgeon with the United States Air Force from 1996 through 2001 and was assigned to the Special Operations Command in Europe and Africa. He was Honorably Discharged as a Major, with 9 years of total service and 30 combat sorties. He continues serving the military as a recruit examiner (DPC-2) at the Lansing, MI, Military Entrance Processing Station (MEPS).

He is Board Certified by the American Board of Preventive Medicine.

Borrillo is a 1994 graduate of Case Western Reserve University School of Law in Cleveland, OH, and a 1986 graduate of Canisius College in Buffalo, NY. He is licensed to practice law in Ohio and Michigan, and medicine in Ohio, Florida, New York, Michigan, Nevada, South Carolina, Washington, Nebraska, and Illinois. He has an active clinical practice with several collaborating nurse practitioners.

Dr. Borrillo has deployed on humanitarian medical missions to El Salvador, Hurricane Katrina in 2005 with FEMA/DMAT, volunteers at the Ingham County Hope Clinic, and the Mother Teresa House for the care of the terminally ill. He teaches medical students at The University of Toledo Medical Center community free clinic, and practices in the field of wound care and hyperbarics at Sparrow Hospital Lansing MI, St. Luke's Hospital Maumee, OH, and The Toledo Hospital.

Borrillo's legal practice focuses on class action/MDL/mass torts, personal injury & wrongful death, occupational injury, and health care law. He is Of Counsel with Zoll & Kranz LLC and is well versed in FDA, OSHA, DOT, and FMLA statutes and regulations.

Publications include two recent peer reviewed abstracts in the field of cannabinoids, with over 30 publications over the past two decades, and is called upon frequently to peer review submitted articles.

Donato enjoys spending time with his wife Liesa and six children, he is a commercial pilot, SCUBA diver, and ice hockey goaltender.

BRIAN DICKERSON



Mr. Dickerson's Bio:

Mr. Dickerson is a lawyer by trade and licensed in 6 states. His nationwide law practice involves representing clients in the healthcare, pharmaceutical, and dietary supplement industries and ensuring compliance with guideline sand laws enforced by the Food and Drug Administration (FDA), Drug Enforcement Agency (DEA) and the Department of Justice (DOJ). Through the over twenty-five years of practicing law, Dickerson has observed many of the obstacles and failures companies within the pharmaceutical and dietary supplement encounter and is able to advise clients how to avoid these mistakes. He has been representing hemp farmers and dietary supplement manufacturers since 2014, when the first Farm Bill allowed for limited participation in the cultivation, extraction and manufacturing of hemp. He successfully navigated farmers, extractors, laboratories and manufacturers through the murky and always moving legal landscape in the past five years. Many of his clients in the healthcare and pharmacy industries know of his experience and work in the hemp industry and utilize Dickerson for their own development of hemp and cannabinoid products for their own healthcare practice and pharmacies.

Through his legal representation and owning his own ranch, for which it is growing hemp to then be extracted by SME, Dickerson has been asked to participate or be a member of many organizations. The Florida Agricultural Commissioner, who is in charge of overseeing the hemp program in the state of Florida, asked Dickerson to accept, which he did, the appointment to the Hemp Advisory Committee for the Florida Department of Agriculture and Consumer Services (FDAC). Dickerson serves on this committee to advise the Commissioner and FDAC as to the trends and legal and regulatory needs of the hemp industry in Florida. Dickerson also currently is a board member of The Florida Hemp Council and is regularly consulted on by members as to hemp and product development advice. After acting as counsel in the hemp industry and with Florida legalizing the cultivation, extraction and manufacturing of hemp in 2019, Dickerson sought out others to develop the SMH vertical integration model. His clients have also been excited about the ability to have a product line which can track the quality of the soil, hemp plant, and the eventual oil to use in their products.

JESSE RIGGINS



Mr. Riggins' Bio

In March of 2014, Jesse was diagnosed with an inoperable Glioblastoma brain tumor and was given a timeline of six months to live. After going through a medical trial, of chemo pills and radiation for four months, Jesse, a nurse at Vanderbilt University Medical Center, opted to stop completely. Within two weeks, Jesse began dosing himself with Rick Simpson Oil (RSO). Jesse started researching cannabis and determining which cannabis strains would be the best for treating his conditions. When he concluded which strain would work best, he located the specific strain and extracted the oils he needed and began dosing himself. In February of 2015, he walked back into his Doctor's office for his brain scan and the scan revealed no tumor and that he was in total remission. Jesse is still healthy with no cancer after 7 years.

After beating cancer, Jesse's sole drive has been to change people's lives with cannabis. He researched night and day about everything to do with cannabis: genetics, various growing techniques, different extraction protocols, and all modes of transport into the body possible. Jesse began consulting for cannabis and hemp companies, while producing new products. While developing his own products, Jesse developed the nuances of extracting Cannflavins and Flavonoids from cannabis and hemp plants as well as the best method for delivery to benefit the human body. Jesse's extraction methods allow him to extract over twenty Flavonoids from a variety of heirloom hemp plants at a concentration level high enough to use in dietary supplements and to take advantage of the amazing anti-inflammatory, antioxidant and anti-microbial properties of the Cannflavins. This journey has allowed Jesse to co-create the product which is now known as HempFlavin and used in clinical studies and for the benefit of humans, and the equine and canine worlds.

DR. HARRY BEHZADI



Presentation Title:

Effect of High Concentration of Cannabinoids in Analysis of Pesticides in Cannabis and its Products.

Challenges as Market Expands into More Edibles and Beverages

Dr. Harry Behzadi, President and CEO, AccuScience Labs

Abstract:

One of the very important pillars of Cannabis testing is analysis for pesticides. This testing is foundational in order to ensure product safety. The listed number of pesticides varies from state to state and some pesticides are commonly found in all states. Cannabis is a chemically complex compound(s) and trying to measure and detect pesticides against this body of diverse chemical compounds, on a part per billion level, has created new challenges. There are numerous documented studies and data sets that show heavy suppression of pesticides during the analysis due to the high concentration of cannabinoids. As laboratories continue to specialize in the analysis of cannabis flowers and their products for efficacy and safety, method development commenced with what was commercially available (less than 0.3 % Delta 9 THC material). This methodology proved quite challenging when we were finally able to identify and test samples with concentrations of Cannabinoids over 70 to 80% (these concentrations were not available at the onset due to legal limitations). In this presentation we showcase the results of a study surrounding high concentrations of cannabinoids on each of the pesticide recovery. Stay tuned to view a fact-finding adventure with the exiting results of this study..

Bio:

Dr. Harry Behzadi is currently President and CEO of AccuScience Laboratories and Vice President of Emerging Technologies for RJ Lee Group, most recently he was Business Development for SGS-EHS North America. Prior to that he was the Vice President of Operations, for TestAmerica Inc Eastern and western regions. He also worked VP of operations, and Corporate Technical Director for Accutest Laboratories, Inc. Since 1994, Dr. Behzadi had spearheaded growth and expansion of Accutest Corporation in the Southeast and beyond to the West Coast. He started Southeast division in 1995 and developed the lab from a handful of employees to one of the largest environmental laboratories in the South with staff 90+ strong. He began his career over 30 years in pharmaceutical industry and since then he has been responsible for laboratory management, analytical method development, professional training and QA/QC in both the environmental and pharmaceutical industries. He has navigated multiple laboratories through certification and NELAP accreditation process, Dept. of Defense and Various Fortune 500 companies. His expertise encompasses all aspects of the environmental testing business including technical and operations management, new method development, acquisitions, operations integration, sales and business development.


Abstract:

Bio:

Adam Wick spent 20 years in computer IT distribution and upon finding hemp products for his own personal use in 2016 when the industry was just getting started, he had a hard time locating high quality reputable CBD products for his own use. After speaking with several local (Florida) CBD manufacturers he realized there was a need for distribution in the industry and he started a local distributor helping pet stores onboard CBD (DNA Distributor). From that experience he saw that consumers were getting interested in CBD for their own use and in June 2017 he launched an e-commerce website offering only CBD products from reputable vendors (www.hhoutlet.com).

After seeing an initial success that continued to grow month over month, he opened his first retail store in October 2018 in West St. Petersburg, Florida - Healthy Hemp Outlet. Then, after several months of strategic marketing and some gorilla marketing techniques, the local store grew fast and he opened a second store six months later in April 2018 in Downtown St. Petersburg, FL.

Today he owns and operates both a CBD online business, and a CBD retail business, and a specific piece of both businesses currently offer Delta 8 THC products. "I enjoy managing all of these Cannabis Businesses and I enjoy the intricacies and challenges associated with Hemp SEO, CBD Digital Marketing and CBD Local Marketing" says Wick, who spends every day in the retail store interacting with clients, educating them on hemp and hearing their success stories. He just wishes someone would have told him more before he started his CBD business.

His favorite part of the industry is teaching shoppers that are looking at CBD for their first time and have lots of questions (or misconceptions).

By using quick short stories that are easy to relate to, his clients easily understand Cannabis Hemp CBD and how it works. It's a trick he learned in the computer industry, break down the technical conversation for People that don't speak technical language, this way they can understand what it is you are trying to sell. You'll hear him talk about Lettuce offering 2 types - iceberg or romaine, just like Cannabis offers 2 types - Hemp or Marijuana.

In 2019 his business did \$203,000 and he owes no money, has no partners, and is looking forward to growing 3X by 2022. He survived 2020 during the pandemic that brought quaranties and forced closures. His online business helped carry some of the revenue requirements during the dip in 2020 - retail dropped more than 500% (vs. 2021). He would like to grow his online and retail business via a large VC investment, or by joining a new Executive Cannabis Company's team to bring scale operations to a franchise CBD store (in Florida first he hopes), then across the nation. Adam is interested in Venture Capital Partners looking to invest in a Cannabis Business and in need of Enterprise Level Executives to grow a funded operation.

Abstract:

This presentation will provide experiences from farming and processing industrial hemp. The presentation will explore lessons learned from decades of farming experience and the similarities between hemp and the other grain crops grown on their 2,500-acre farm near Great Bend, Kansas. As with many of these traditional crops, South Bend Industrial Hemp started growing hemp as a dual-crop—that is, harvesting both fiber and grain from the same plant. We will explore the challenge of how to figure out just how to grow hemp alongside other crops as well as in the processing side.

Bio:

Melissa Nelson is the owner and field research scientist at Performance Crop Research, an independent crop research facility in Great Bend, Kansas. Melissa works with a variety of companies around the world collecting data on crops grown in the Midwest with a focus on soil health, residues, and efficacy of new chemistries and varieties.

Melissa is also co-owner of South Bend Industrial Hemp. South Bend focuses on helping grow the hemp industry in Kansas. South Bend also grows dual purpose varieties and is working towards developing the grain and fiber industry. Florida Industrial Hemp Pilot Bio-Remediation Project
Dr. Kate Calvin, Chemistry Instructor and Nylla Wilder, Student, South Florida State College

Abstract:

Fresh water lakes and waterways in Florida have been declining as the result of nutrient pollution Large amounts of nitrogen and phosphorus from fertilizer, animal feed, phosphate mine events and human waste have been identified as major contributors to this decline. These nutrients continue to exceed Florida Department of Environmental Protection's Total Maximum Daily Load threshold Industrial hemp Cannabis sativa has been shown to remove pollutants such as heavy metals and radioactive chemicals from polluted soil. This project is intended to explore and test the effectiveness of industrial hemp as a viable means of removing nitrogen and phosphorus from polluted water Cannabis sativa is a land plant and does not typically do well when its roots are in deep water that is not mechanically oxygenated. The goal of this project is to grow plants that will survive when placed in impaired water long enough to pull out some of the excess nutrients. The hypothesis is that the excess nitrogen and phosphorus in the impaired host water will provide the nutrients needed for the plants to survive We have developed a method of growing plants that condition the plants to seek water directly and the plants have demonstrated the ability to survive on the mats for 3 months We have obtained preliminary data on the nutrient levels in the water bodies, the plants, and nutrient uptake per plant in a 1 day period. Successful proof of concept warranted the start of a new phase of growth and analysis experiments.

Calvin Bio:

Dr. Kate Calvin earned her PhD in Molecular Biophysics from Florida State University in 2007. She then worked as Post-Doctoral Fellow and Scientific Research Specialist in the FSU College of Medicine until 2015. Having moved to central Florida to be closer to her parents, she is now a Chemistry Instructor at South Florida State University and is very pleased to be doing research again. With a work history involving analytical biochemistry and none in plant growth and inorganic water analysis, she has ventured into new research areas and is happy to share the group's progress to date.

Nylla Wilder is a freshman at South Florida State College majoring in biomedical science and enjoying her first research experience. She will join the Honors Program next year and looks forward to continuing in research.
