### **B. Sebewaing Harbor Commission**

The term for the Commission members will be three years with initially 2 one-year terms, 2 two-year terms, and 3 three-year terms to stagger the term expiration. The Commission will meet a minimum of four times per year. The lease on the marina is with the Commission and not with the Village.

The Huron County Road Commission will not lease the property to the senior citizens as an organization. The building may be leased out by the Village. The Village would be responsible for all utilities and maintenance. There are funds from the County property tax collected for the seniors and the Human Development Commission.
