VII. Community Recognition

The Bay Shore Camp and Family Ministries representative, Jeff Parson, stated this will be the 112th summer. Activities include school field trips, summer and family camps, gospel music weekend, and hosting outside organizations like Sebewaing Rotary weekly lunch. The trails, Family Fun Days (twice a year), scheduled community swimming, and living nativity are open to the public. In 2020 Bay Shore on the Road began. In 2021, received Faith Quest, the former Noah's Ark property near Gagetown, was received. A \$30,000 grant enabled the creation of Education Quest. A certificate of appreciation from the Village of Sebewaing was presented.

VIII. Committee Reports

A. Department of Public Works (DPW) Committee

Trustee Kuhl updates included Right of Way (ROW) trees have been cut by L&W with sidewalk replacement and stump grinding to be completed in the Spring. Battery replaced in salt spreader. Concrete from the basketball poles has been replaced. Painted the floor in the South Park men's room. Picnic tables are being repaired. The 2004 International dump truck was taken to Osentoski Equipment for a possible blown head gasket in the engine. Hydraulic cylinder being repaired on Batwing Mower. All village property has been removed from the Pine Street building. A donation of \$400.00

was made to the Sebewaing Chamber of Commerce for the Easter egg hunt.

- 6. Sharpsteen Street chip & seal from N Center to Albert Street
- 7. Albert Street chip & seal from Union to Pine Street
- 8. Pine Street chip & seal from N Beck to Albert Street
- 9. Union Street chip & seal from N Center to N Miller Street
- 10. E Main Street/Mill Street chip & seal from Beck Street to E Bay Street
- 11. E Sebewaing Street chip & seal from Beck to East Street

1. PLM Lake & Land Management Corporation Lagoon Algae Treatment Contract

Trustee Sting provided updates including fiber restored on Grover Street, cut down 10 trees for the Village and one tree in the electric lines, Christmas decorations were removed, fixed Primary at Michigan Sugar Company Piling Grounds. An estimate for

4160-line extension to customers on M25 currently on DTE will require easements to extend the line behind properties. Rebuilt electric service on Bay Street residence. Stack Testing Completed. United States Department of Agriculture (USDA) Rural Development (RD) Special Evaluation Assistance for Rural Communities and Households (SEARCH) Grant approved for the \$26,000 reimbursement. Water Main break on East Street. New water meter installed at Michigan Sugar Company. Rate studies will be done for the internet/fiber and updated for electric.

6. 350 Pine Street Garage Door Modification

7. Department of Energy Grant Application for Advanced Metering Infrastructure Matching Funds Commitment

L&W, along with 15 other municipalities, will be applying for a grant from the Department of Energy to finance 50% of Advanced Metering Infrastructure. The infrastructure will allow L&W to understand load profile, access meter data for 15 minute averages, provide customer information for individual peak electric usages, engineers for data, structure billing for peak usage times, etc. There may be future legislation or regulation requiring advanced metering infrastructure.

Resolution by Gunsell seconded by Sting to approve Resolution #23-2022-2023 for L&W to commit a 50% matching funds not to exceed \$570,000.00 for grant opportunities including those from the Department of Energy for Advanced Metering Infrastructure.
