Needed items are going to be posted on facebook each month and donations can be dropped off at the Trinity Methodist Church. Next December those items collected will be packaged and delivered to the families.

Trustee Kuhl provided departmental monthly activity including 12 loads of brush picked up, storm and drop sewers were cleaned off for rain and thawing snow, plowing and salting continues, oil changed in three pumps at main lift station, confined space training, oil, grease and filter completed on 2003, 2014 International trucks and JCB loader, cutting edge replaced on JCB snow bucket, blades replaced on 2003 truck, levy project is moving forward and zoning administrator will be looking at ordinance violations.

D. Light and Water Department. Trustee Sting reported for Fiber - 2 new installs are waiting, Electric - PCA for December was \$0.01456, Grove and Third Street pole rebuild, substation transformer was ordered, Pine street – starting batteries installed on both Jenbacher units, new batteries for station panels on order, December windstorm ran both units as a preventative measure, Water – routine maintenance at well houses, water main break on East Sebewaing Street had to do a valve replacement and replace a portion of the main, Safety - truck inspections were completed, and researching information on a Flir Infrared camera to purchase for locating bad connectors.
