## V. Approval of Minutes - Council and Committees

**VIII. Public Comments.** A resident questioned the demolition of 42 and 50 N. Center Street properties, specifically the remaining interior wall which is the shared wall with 36 N. Center Street. The wall is in poor condition and is now the responsibility of the owner of 36 N. Center Street. The demolition grant only financed the removal of the buildings. A Downtown Development Authority (DDA) Façade Grant was approved for 36 N. Center Street.

#### X. Committee and Commission Reports

**A. Department of Public Works (DPW**). Trustee Kundinger read the DPW minutes in the absence of the DPW Committee members. Highlights include Huron County Work Crew scraped and painted curbs throughout town. Picked up logs at the marina discharged by Michigan Department of Transportation (MDOT) cleaning the log jam upstream at the M-25 bridge. Railing along the river at 50 N Center Street has been installed. The Playscape is finished. Army corps installed a silt curtain along the south river bank and filled super sand bags to place along the river when needed. An engineer study will be completed on 42 & 50 N. Center Street to see if the concrete wall is sufficient to withhold the forces of nature before tile is installed and black dirt and grass is seeded. Citations requested for blighted properties due to noncompliance from previous violation letters.

#### 1. Vactor Truck Replacement

<u>Motion</u> by Kundinger seconded by Shenberger to approve the purchase of a Vactor Truck from MacQueen Equipment at a cost of \$526,620, as presented.

## 2. Bridge Weight Limit Testing

**B. Office Administration Department**. Trustee Schenberger updated the council stating the cost summary for the Playscape was reviewed. Huntington Bank provided a 30-day quote for the Vactor truck financing. USDA Rural Development has no grants available; however, they will allow the VoS to use up to half of the Repair, Replacement and Improvement (RRI) reserve from the lagoon loan as a down payment. Notifications were completed for the Zoning Board of Appeals Public Hearing and discussed the procedures for the meeting.

## 2. Village Owned Vehicle Take Home Policy

**C. Police Department.** Trustee Sting updates included a review on Part-time Officer Davis training. A review of the schedules for the Michigan Sugar Festival and the SRO Summer Schedule. Blight citations and tall grass letters were discussed.

**D. Light and Water Department.** Trustee Sting reported a discussion was held with Police Chief Repkie concerning the proposed remodeling of the Police Department building, which is owned by L&W. Bayside Best Bean had a meter replaced and reprograming for solar energy. Rebuilt the pole line from 33 E. Main Street to 117 E. Main Street and removed an excess transformer. Discussed the May 15, 2025 storm and prevention of a power outage by starting the J624 engine prior to the storm. Recommended an easement of 10 feet on either side of the poles for Sebewaing River Campground, which was discussed at the Zoning Board of Appeals meeting for the campground expansion. Pine Street Water Tower was washed out and repairs made.
