CHAPTER 1: THE SUBJECTIVE WORLD OF THE CHINESE PEOPLE

“Welcome to China, the land where everything is perfect,” she said.

I was the only one to respond to this with audible and spontaneous laughter. The other western and Japanese teachers were silently looking askance at one another. The speaker, the gratis Chinese language teacher that had been assigned to teach the foreign teachers at Nantong Vocational College, brought me abruptly to order with a frown.

“Can she possibly be serious,” I thought, “or is she psychotic?” It was September of 2005, the start of the new school year. It was only the second of the more than ten years that I was to spend in China. I was enjoying the novelty of a culture that was still mysterious and, in some ways, strangely different from my native land, the USA. But it was already obvious to me that China had as many problems as my native land. Many of China’s problems were just different.

Please take note right here at the top that I am no flag-waving propagandist for America. I’m a maverick, a free-thinking researcher/author who has been oppressed as much as anyone in and by my own country. I was on both extreme ends of the political spectrum before coming up with my own,

comprehensive, new social science. The whole world is, in my opinion, the police state that Orwell predicted; and the highly touted western democracy -- general elections wherein thousands or millions of people choose from a few candidates about whom they have no personal knowledge and know only what they've been told by commercially-purchased, mass media -- is the surest recipe for totalitarianism. Except in its ability to produce science and technology (which gets used more for negative than for positive purposes), I don't regard my country as a model for anything.

I have been, for thirteen years, a member of a United Nations family. I've lived on three continents and traveled to 30 countries. I am an international person who readily calls himself a communist to people who are astute enough to share my definition of the communist ideal: uniting humanity into one virtual and loving family. Obviously, developing this communist family requires us to select the best possible laws and customs irrespective of where and from whom they originate and to weed out the rest. It also requires us to be ruthlessly honest about ourselves. Seeing others as they are is easy. Seeing ourselves as we are, as others see us, may be the world's most difficult task.

As I update this book, in October of 2022, eight years after first writing it and, at the age of 73, reflect upon my own life; I find that my own life is a prime example of this axiom. I have put together (discovered in part but mostly assembled) a comprehensive, new social science. The last and most difficult part of the puzzle of

who we are, the last major piece for me to put into place, was the understanding of the archaeology and prehistory of my own native land (North America and, especially, the Midwest of North America). *The most negative, disagreeable and ugly things about ourselves, our own people and our native land are always the most difficult things for us to see.*

The concrete plan of the Peace Love and Progress Party, a fledgling party I have founded, for how to civilize the world and modernize the US government and other republics is condensed into two documents. The first is the four-page essay, "The Dream of Peace on Earth is now a Political Choice." The second is the nine-page "We the People Treaty/Amendment" (formerly the "Huttner Orwell Treaty Amendment"). Copies of both are free to read on the Blogs Page of PeaceLoveAndProgressParty.org. They are also contained within the books, "Selected Works of David Huttner," Volumes I and II, which are also FREE to download on the Downloads Page of the same website. A copy of each document is also appended to this little book. When the detailed Treaty/Amendment was first written, in November of 2015, a copy of it was mailed to the White House, to every congressman and senator in Washington D.C., to all of the foreign ambassadors in Washington D.C., to all fifty US state governors and to several legislative groups. A few of these individuals responded in a perfunctory manner. My New Jersey congressman, Corey Booker, refused to introduce it as a bill, as asked; and none of them have proactively supported it. None of them are exceptions to Orwell's

and my general characterization of politicians as the governmental arm of "Big Brother." Big Brother is a composite of all the homophobic, masked, latent homosexual people who are the angry people described by paragraph five of the Treaty/Amendment and who reflexively oppose basic truth and change because they associate both with the removal of their masks, removal of their Third Masks, the mask that hides homosexuality.

I am writing this message to the Chinese people because I'm hoping that many of you are exceptions. Many of you are no longer dizzy from China's great, developmental success. Unlike most of your peasant ancestors of Mao Zedong's day, you know that material success is necessary but insufficient for happiness. You subjectively desire and need more than just riches. Unlike our Nantong Zhiyue Daxue, Chinese teacher; many of you are also honest enough to admit (at least to yourselves) that China is not perfect and that your "miraculous" industrialization was not entirely of your own doing. Many of you are also astute enough to realize that national socialism, the "Us against the World" set of attitudes and policies that replace Marxism when it fails, can work for only a limited time. More specifically, the acquisition of western technology, via theft or donation, will not last indefinitely. Those national socialist policies and tactics have worked exceedingly well for you because the rest of the world perceives you as (or hopes that you will become) the counter-veiling force to their Enemy #1, the Great Resource Thief, American Imperialism. And of

course, as Machiavelli was the first to proclaim, "The enemy of your enemy is your friend." Trickery also works for only a limited time; and in the long run, operates to the disadvantage of the trickster. As our one great American leader (Lincoln) said, "You can fool all of the people some of the time, and some of the people all the time, but you can't fool all the people all the time."

If enough of you can be realistic, honest enough with yourselves about yourselves, you will support the political agenda of the Peace Love and Progress Party in time to avoid the crash landing that the U. S. of A. is now undergoing. (The U. S. is a sinking ship on a generational time scale but a crashing plane on a historical one.)

Americans were confirmed in their naive, western belief that violence is a tool that can solve problems (as opposed to being what it actually is: a tragedy that aggravates problems) when they came out on top in two world wars. They bought it hook line and sinker, the magic words of their own latent homosexual scoundrels, the magic words with which the Big Brothers always trick the traumatized and religious masses into voting for them: God is on our side. This magic phrase comes in numerous national variations. Ours is "In God We Trust," which tells the children, "Because we believe in your God, the one true God, we enjoy His providence. Therefore, all you need to do is trust in us as we trust in Him." Had the American people not been childish wishful-thinkers, the Great

American Celebration of the 1950s would never have happened. Americans would have realized that their success in warfare was made possible by good luck, by the good luck of having the two great oceans to protect them at a time when there were no ICBMs. Of course, Americans' increasing faith in and reliance upon "God," latent homosexual scoundrels and violence has caused the rest of the world to hate us and is quickly bringing our empire down.

If the Chinese people are wiser than Americans, they will realize that lies and trickery are the female form of violence and that using lies and trickery to exploit the lovelessness of the male-dominated West will not work to their benefit in the long run. Truth, by definition, is all the knowledge and information that advances human evolution. Lies can benefit their perpetrators in the short run but work to everyone's disadvantage in the long run.

The sane way to compete, the only way that will ultimately get us to that happy communist family that we all desire is to compete by improving ourselves, by eliminating our own weaknesses and becoming a worthy model for others.

Since the westerners have defaulted in leadership, since their societies are growing daily more Orwellian, you may have to lead humanity to becoming a communist family if ever we are to have one. In order to become the model that can successfully assume the mantle of world leadership, you must do as my Mao Zedong quote suggests. Make your objective and

subjective worlds one. You have a long way to go to achieve that.

With this goal in mind, let's try to be honest in talking about the negative Chinese characteristics, the warts.

The East, especially China, is female dominated. I have insisted upon this in every version of my major book, "Decoding the Deluge and Finding the Path for Civilization," that has been produced since first coming to China. (This book is now in its 25th Edition, which, if Big Brother isn't violating our rights, is available at <http://www.PeaceLoveAndProgressParty.org>. My as-yet-unpublished screenplay, "Genesis II," offers a detailed scenario of how the Eastern (female-dominated, marine) and Western (male-dominated, hunting) divisions of our first, out-of-Africa family formed and separated at Ur.

The female leaders of the Eastern branch of the family probably refused to adopt the innovation of phonetic writing because pictographs (the first Hanzi characters) had been strategically used to defeat Homo erectus in the opening battle(s) of the Species War. Eastern languages continued to develop as military codes, as shields that could keep the violent, better-armed, hunting people at bay. But this shield only held up until the nineteenth century, and you paid a terrible price for it. You paid with your creativity and imagination. A difficult code language requires its students to be always listening, imitating and remembering. Everything we do becomes habit, and these are the habits we need to learn from others. But

they are just the opposite of the habits we need to learn on our own, to discover and invent, to use imagination and creativity. Instead of listening, creative people carry on their own inner dialog, ask their own questions and pursue their own curiosity. Instead of imitating, we experiment with different ways of doing things. Instead of remembering, we intentionally forget everything unrelated to our goal and archive what is related; so that we can clear our minds to zero and become aware of whatever might be boiling up from our subconscious minds. Moreover, your imaginations (powers to visualize) are consumed just trying to learn and remember what all those crazy Hanzi characters are supposed to represent!

The incredibly-difficult Chinese language continues to empower China's women because children must learn it from the mother. It's great that Chinese women are able to be the leaders in love and marriage, where women tend to be more focused and knowledgeable. Love and marriage work much better in the East, especially in China. But the Stage II system of marriage and child-rearing that I advocate (See Article IV of the Treaty/Amendment.) will make them work even better – without all the drawbacks associated with female domination. What are the other drawbacks, other than the archaic language that prevents people, especially demeaned, unconfident and useless men, from inventing and discovering new knowledge?

Drawback II: women, focused as they are on not making any mistakes (especially in the choosing of

their man), are more conservative than men, more afraid of change. True perfection, were it possible, would consist of both infallibility (not doing anything wrong, the type of “perfection” personified by Eastern gods, the type that women value) and omnipotence (being able to do everything right, the type of “perfection” personified by western gods, the type that men value). This largely explains why Chinese people fear controversy, even the intellectual controversy, dialectics, that is necessary to discover truth. Chinese people, especially Chinese women, fear that the controversy will cause mistakes and create social divisions, which in turn are apt to create disharmony and instability. But the proper way to create social unity is not by dumbing down the social dialog but by reducing the K and R class struggle. (See Article I of the Treaty/Amendment for an understanding of the K and R class struggle.)

Female fear of change also exacerbates the latent homosexual fear of change (association of it with their masks) and the domination of latent homosexual scoundrels in government and the corruption of the process of democratic centralism. Democratic centralism can't select for the brightest and best people if people in the party or in government positions are able to reach down and meddle with the selection and promotion of the people at lower levels. This appears to happen regularly in China. Moreover, were the Party and the Government organizations at all levels not female-dominated-neo-phobic and latent homosexual cliques, at this late, post-revolution time, when the

Party has long controlled the secret police, the uniformed police, the army, the media and the school system; no one would have to know someone and suck up to someone to become a member. Party membership should be automatic for everyone who achieves a grade of B or better in his high school civics and history classes.

Qing Ming has also been obviously shaped by female neo-phobia. When I suggested in both my Nantong Middle School and Kunming University classes that “Grave-Sweeping Day” be converted into “Grandparent Interview and Video-Recording Day,” everyone was horrified! The truth is that almost no one knows anything about their ancestors further back than their great grandparents. Yet Chinese people pretend that their ancestors were all perfect people because if they were perfect, then the culture is perfect and no one needs to change. By asking the old folks the important questions about their lives and times and video-recording their responses, we could really get to know them (their strengths and weaknesses, successes and failures) and realistically honor them, remember them and learn from them for many generations.

Drawback III: women are sedentary. By not traveling and discouraging men from traveling, people fail to learn from other cultures and develop wishful and ignorant prejudices. Thus, communist attitudes are supplanted by backward, nationalist attitudes and leadership roles are forsaken for reactionary ones.

Drawback IV: women, who play the major role in creating children, are overly fond of them. There are at least ten times too many of us now! At the top of the food chain, without a natural predator and still failing to control ourselves rationally; we are a cancer upon the earth. No one needs to reproduce his or her own genes. We are all too much alike for that; and the genes have nothing to do with our important characteristics, our character, personality or general intelligence. Genes only determine the type of proteins our bodies produce and, accordingly, the shape of our eyes, the color of our skin, etc. What everyone does need is love. If we limit (preferably minimize) the K and R strategies, then we can provide much better for the children that we do produce and guarantee everyone love with the perfect partner.

Drawback V: lies, trickery and treachery are the female form of violence. It is the means by which women abuse others. Dominant, western fathers brainwash their children to believe that physical violence is natural and OK. Dominant, Chinese mothers brainwash their children to believe that lies, trickery and treachery are OK. China impresses westerners with its non-violent, civilized appearance. But beneath the façade is savagery in a different form, a society rife with fraud, larceny and betrayals.

Well, this is one man's take on China and her particular problems. I offer it with only constructive intent. My wish is not to hurt anyone's feelings but to help us to improve ourselves and our world. May it at the very

least provide you with food for thought. Those of you who are tempted to reject it out of hand should be advised that this criticism comes from a westerner who has spent ten of his intellectually-prime years in China, lived on three continents and traveled to 30 countries. Things are only meaningful in comparison to other things. We don't begin to know our own country and culture until we travel to and experience other countries and cultures. The next chapter describes what I believe we all must do to succeed in our task as Mao Zedong defined it to turn our savage world into a civilized paradise.

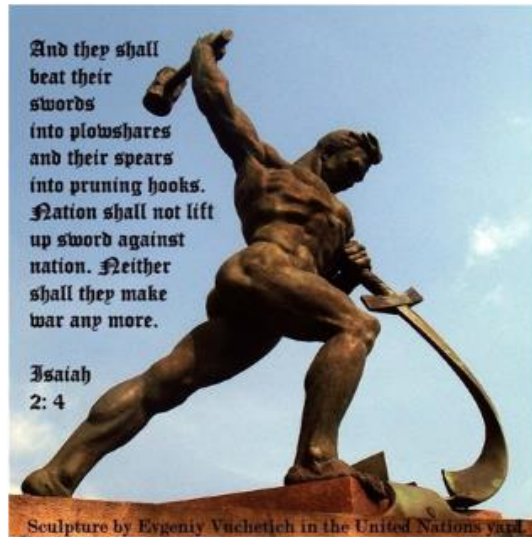
CHAPTER 2: THE OBJECTIVE PARADISE THAT BEST ACCORDS WITH OUR SUBJECTIVE ONES

Our first step must be to educate ourselves and become honest about ourselves and our ancestors. This means removing all our masks as described in great detail in *Decoding the Deluge* and eradicating all our prejudices and superstitions. The First Mask masks our greatest loves, our love for our opposite-sex parent and our siblings in general. The First Mask was born of our very flawed transition to exogamy (marriage outside the family, which began with the primal revolution at the dawn of *Homo erectus*' civilization) and was fortified by our flawed transition to monogamy [marriage to a single partner, which also gave birth to homophobia and the Third Mask, at the dawn of the Neolithic (discovery and spread of horticulture during the late Stone Age)]. The First Mask facilitates exogamy and prepares us for our unhappy marriages. The Second Mask masks our animal, great ape being and resulted from the expunction of our parent species (*Homo erectus*) from our oral histories as a result of guilt for having exterminated them. The Second Mask alienates us from the rest of nature, makes us the monsters of the natural world and helped to fashion our false, allopathic theory of disease. The Second Mask also created the universal prejudice against dark skin. The Third Mask masks the love of same-sex siblings and bisexual and homosexual orientations. The Third Mask

entirely prevents homosexual people from being able to enjoy adult, sexual love and makes them the vengeful monsters of society. Only as we eliminate the masks and the prejudices will we become honest and realistic enough to enact the "We the People Treaty/Amendment," a basic blueprint for civilizing our world and gradually but steadily turning it into the paradise of which men have always dreamed. We now possess the social science and the technology (minus one creatable software application) to do this.

The best and most effective tool for educating the world's peoples and overcoming all of our prejudices is one that we need to create: a greatly expanded United Nations News Agency. The first of the two parts of the Peace Love and Progress Party's Global Peace Plan is contained within the next document, which puts forth a plan for expanding the United Nations News Agency and turning it into a Global Peace Net.

CHAPTER 2A: "THE DREAM OF PEACE ON EARTH IS NOW A POLITICAL CHOICE"



Thirty years ago today, Tim Berners Lee proposed the Internet. Today is an ideal occasion for another proposal that could similarly impact our world. I herein propose a two-stage, United Nations Organization resolution that will put an end to war and elevate humanity to a new level of cooperation, progress and civility:

Stage I of the Global Peace Plan (in two stages).

Whereas we are doomed to repeat tragedies only to the extent that we remain unconscious of the laws of nature and society,

Whereas it is the highest and most solemn duty of this organization to eradicate the scourge of warfare and create peace on Earth, and

Whereas we are not a prayer group but a governmental body with the responsibility to deploy all our influence and powers to not just express our will but to actualize it;

We, the member states of the UNO resolve to fulfill our most solemn duty by carrying out the following two-stage process, as follows:

Article I: The Global Peace Net (GPN)

Section 1: The United Nations News Agency shall be expanded into a Global Peace Net. It shall broadcast via Internet, television and radio 24/7/365. Every member state shall be required to avail all of their citizens of these broadcasts 24/7/365.

Section 2: (A) Broadcasts shall be exclusively in the English language so as to accelerate the promotion of the world's most syntactically-simple trade and port language as the world language and common means of communication. (B) Member states shall be assessed annual dues increases, to finance the GPN, proportional to their abilities to pay. (C) Under-developed member states whose citizens lack access to electricity and/or radio, television and Internet communication shall receive subsidies to provide for such access. (D) Compliance failure shall be deemed the equivalent of

not paying dues and subject non-compliers to the same restrictions and sanctions.

Section 3: Structure and Standard Operation Procedure.

(A) Every member state shall appoint its own reporter.

(B) An annual program director shall be elected by the full body of reporters on an equitable and rotating basis and be subject to removal, at any time, by a two-thirds vote of the full body of reporters. The Director shall supervise the permanent staff and select events, issues, videos and other-news-organization-borrowed-reports and anchor their presentation during the first third of every news program. (C) The second third of every program shall consist of a panel discussion of five other nation-state reporters, chosen by the full body on an equitable and rotating basis, a discussion in which they respond to the Director's news coverage. (D) The last third of every program shall be an open discussion in which the panel reporters have full discretion to air their own and their peoples' point of view regarding whatever they regard as most newsworthy.

Section 4: The mission of the GPN shall be to (A) educate and inform the public, (B) eradicate prejudice, and (C) prevent member states from isolating and brainwashing their citizens and misusing them for the commission of war crimes.

Article 2 (The "We the People Treaty/Amendment")

Whereas the unconscious but essential cause of every war (and conflict generally), since the ascension of our parent species to the top of Earth's food chain, has been

the elimination of surplus population and the struggle between K and R strategies and classes; Whereas lasting peace, civility and progress require the minimization of the K and R class struggle (the maximization of equal opportunity and population control, respectively) and the eradication of the two scourges that cap the class struggle (religious superstition and homophobia/latent homosexuality); we further resolve that,

Section 1: Five years from the inauguration of the GPN, the “We the People” Treaty/Amendment shall be put to a vote by the General Assembly.

Section 2: Signatories to the Treaty/Amendment that undertake its provisions, domestically, will cease to be an actual or potential threat to world peace. They will embark upon an accelerated path of integration and development. They will constitute, at first only de facto but eventually also a de jure, Civilized United Nations Organization, CUNO, as described in the Treaty/Amendment. They will use their power and influence as necessary to induce the remaining member states to become signatories to the Treaty/Amendment and CUNO members. Until a state accepts all of the provisions of the Treaty/Amendment and begins good-faith efforts to implement them, it shall be (A) regarded by CUNO members as savage, irrespective of its level of technical prowess and material prosperity, (B) ineligible for CUNO benefits except by special arrangement and (C) subjected to whatever political and trade sanctions as the remaining (Civilized United

Nations Organization) member states deem fitting and proper.

Proposed We the People Treaty Agreement and
28th Amendment

*PREAMBLE AND TWENTY-FIVE-YEAR GLOBAL
TRANSITION PERIOD*

Whereas human civilization in its current state of
disorganization is unsustainable and, owing to its many
acute and chronic problems, arguably unworthy of the
appellation "civilization";

Whereas it is incumbent upon the richest and most powerful nation(s), our nation(s), to play the leading role(s) in the community of nations;

Whereas savagery occurs at the intersections of fear, anger and ignorance;

fear being universal and ongoing among the supreme beings on this planet owing to our failure to set limits upon our genetic competition with one another, our failure to minimize the extreme strategies for genetic competition, the K (quality) and R (quantity) strategies by maximizing, respectively, equal opportunity and population control;

anger characterizing all of the people with same sex siblings who cannot love, owing to homophobia in men, which was the accidental result of irrational and savagely-high birthrates, birthrates in excess of the birthrates correspondent to the greatest decrease in the death rates, birthrates that force men to become killing machines, and homophobia in general, which resulted from the adoption of monogamy by non-standardized families with multiple, same-sex offspring; anger characterizing loveless people who accordingly are always fighting and resent everyone whom they suspect of enjoying sex and life generally; people who are motivated mostly by fear, value only what contributes to their individual survival (money, power and their own genetic offspring), grow up wearing the Third Mask, become consummate actors, liars, manipulators, scoundrels of every sort and the monsters of society, people that rise automatically to

the top of every walk of savage life, breed more people like themselves and thus impact society ever more negatively; people who are afraid of all real social change because they associate all real or uncontrollable change with the all-important change that they cannot make (removing their masks, being themselves and loving the same-sex people that they can really love); people who gravitate to politics and government like metal filings to a magnet and (in combination with their economically-focused counterparts) forcibly prevent the improvement of civilization (real, positive change) by focusing all the efforts of government only upon the symptoms of our problems and causing governments everywhere to become ever-greater parasites upon the public body and terror-inducing masters of the people who initially created them and to whom they ought to remain subservient;

and **ignorance** characterizing everyone wearing the First Mask (remnant of our incomplete transitions to exogamy, following the primal deed, and monogamy, following the Neolithic), a mask that denies our greatest loves (for the sexuality of our siblings in general and the face of our opposite sex parent) and prepares us for unhappy marriages and lives of frustration; and characterizing everyone wearing the Second Mask (remnant of the Species War, our expunction of the memory of our parent species, and our link with the animal kingdom), a mask that denies our animal/great-ape being and makes us the monsters of nature; and ignorance especially characterizing the fundamentalist believers who are still traumatized by

the most horrific events of our prehistory (the Species War, that lasted 35 to 40 thousand years and ended 33 thousand years ago, and the Great Flood of 14,634 BP), fundamentalist believers who are unconscious of our strong mixed emotions toward the four, universal groups of ancestors and relatives and the one individual (the same-sex parent) that became mythologically inflated and amalgamated into the “gods” and “demons” of pagan times (“God” and “Devil” of modern times); fundamentalist believers whom the Third Mask scoundrels easily mislead with only four magic words (“In God We Trust” or “Gott Sei Mit Uns,” etc.);

Whereas it is necessary for humanity to most rapidly attain the highest possible levels of cooperation and civility and rates of learning and evolution in order to prevent another collapse of the Greenland Ice Sheet and in order to maximize our chances of preserving Earth as an oasis of life by learning how to shield our planet from the gamma rays that result from supernova explosions and routinely destroy life throughout the universe;

We jointly resolve to modernize our respective governments as herein indicated, during a Twenty-five-year Global Transition Period. The Transition Period will be one in which there is a global moratorium on procreation (on new births, a zero human birth rate). The Transition Period and Global Birth Moratorium will (1) reduce the human population to a manageable level, (2) further educate the peoples, (3) create equal

opportunity both within and between nations, (4) complete the spread of the western trade and port language (English) as our common means of communication and (5) eradicate all forms of prejudice, especially the most harmful prejudice, homophobia, which will cease to exist -- even among our current, largely homosexual and bisexual population, when no one can procreate, when there is no upward pressure upon the death rate and when no one is forced to choose between having love and having children.

We make these resolutions with the understanding that there are currently ten-to-twenty-times too many of us; that human apes are a cancer upon the Earth; that irrespective of what our instincts tell us, no one needs to reproduce his own genes; and that what everyone does need is love.

ARTICLE I

(Minimization of the K and R class struggle)

Section 1 Government, at every level, shall regard the implementation of equal opportunity among the people and population control of the people as its chief responsibility and the precondition for civilized society. Equal opportunity and population control are the antidotes for the K and the R strategies, respectively, and shall be implemented simultaneously, in equal measure and to the greatest possible extent.

Section 2A The maximization of equal opportunity shall include but not be limited to the following: (i) the

public recognition that, given good nutrition and prenatal care, all peoples are equal in their potentials and individuals need equal love and respect (i. e. equal opportunity) in order to feel themselves to be and function as members of any family, societal or otherwise. All prejudice, hate-mongering and propaganda to the contrary shall be forbidden. (ii) strict limitations upon gifts and bequests to individuals [subject to Section 4(B), herein], (iii) equal opportunity for education [subject to Section 4(C), herein], (iv) elimination of nepotism from all enterprises except family owned enterprises [subject to Section 4(D), herein], (v) an equal right to share in Earth's resource and mineral wealth [subject to Section 4(E), herein], (vi) the creation of a hierarchy of global, national, state and local Equal Opportunity Committees to interpret, administer and help enforce the equal opportunity law. To ensure the most vigilant and vigorous enforcement of their mission, committee members at every level shall be chosen from present and former members of communist, R parties.

Section 2B The maximization of population control shall include but not be limited to the following: (i) the public recognition that genetic inheritance determines only what proteins our bodies make and has nothing to do with personality, character or general intelligence and that, far from being the right of individual couples or individual women, human reproduction is an honor, privilege and duty conferred upon families by the societal family. All propaganda to the contrary shall be forbidden; (ii) a twenty-five-year, global moratorium

on new births during a Transition Period to reduce the population to a manageable level, eradicate homophobia and all other forms of prejudice, complete the spread and adoption of the world language (English), educate and integrate the world's peoples, eliminate predatory occupations, goods and services and false marketing practices that have evolved to eliminate or make work for surplus population, use the Stage II software of Article IV to the fullest extent possible for pre-Stage II people to provide everyone love with the ideal partner(s) and create equal opportunity and (iii) a hierarchy of global, national, state and local Population Control Committees, to interpret, administer and enforce the population control law. To ensure the most vigilant and vigorous enforcement of their mission, committee members at every level shall be chosen from present and former members of Republican, arch conservative, K parties.

Section 3 A hierarchy of global, national, state and local Family Planning Committees, consisting of members that are representative samples of their respective population groups, that work in close cooperation with their respective Equal Opportunity and Population Control Committees shall experimentally determine the ideal number of new births needed for their polities, based upon mortality rates and with the goal of maximizing the rate of decrease in mortality. Following the birth moratorium, they shall confer their apportioned procreation rights upon the couples and marriage groups they select from applicants and make living arrangements for pre-school-age children in

accordance with the Stage II (Article IV) goal of simplifying and standardizing family life and sexual orientations. Family Planning Committees shall select from procreation applicants on a rational basis (e. g. shall select the applicants most needed and loving). The FPCs shall also control the resources described in Article IV, Section 1, oversee the installation and use of Baby-Face Generating software in hospitals and the installation and use of Face Matching software in libraries and post offices and the collection of individual records in all locales for the male and female databases. Both databases are to be global; and, by the end of the Transition Period, all selections (matches) are to be made on a distance-preferred basis. This is to accelerate the growth of equal opportunity and even development of the Earth outside of the cloud corridors, cloud corridors being latitudinal bands of low-air-pressure, forested, nature-preserves.

Section 4 (A) The Equal Opportunity, Population Control and Family Planning servants shall be elected on the basis of eopc (tax-contribution-weighted) centralism, as described in David Huttner's book, "Just Say No ..." through the end of the Twenty-five-year Transition Period. Thereafter, every polity shall have the option to switch to the simpler democratic centralism as described in Article V, Section 5B. (B) Limits upon individual gifts and bequests shall be sufficiently low so as to require all individuals to prepare for gainful careers and acquire gainful employment and not guarantee an individual's dominance or success in any company, profession or

employment. (C) Within five years of the enactment of this amendment, all full-time, educational institutions shall admit at least one half of their students solely on the basis of merit (blind to their financial ability). Within ten years of the enactment of this amendment, all full-time, educational institutions shall admit all of their students solely on the basis of their merit. (D) Family-owned enterprises shall be defined as those employing only personnel related to one another genetically or through marriage and shall have no more than twenty employees. (E) The excess of estate monies (above and beyond the legal limit for the designated heirs) shall revert to the issuer of the monies, in the case of bullion, to the national government. The excess of estate securities shall revert to the issuer. The excess of estate real estate and personal property shall escheat to the local government in which the property (or for personal property, the deceased's legal residence) is located and shall be managed and auctioned by these localities as best meets societal and fiscal needs. Properties valued in excess of one billion dollars shall escheat to the state in which it is located. States and localities shall transfer only non-transferable leases for terms of years and life estates to the real property that they acquire, and they shall manage the property so as to reduce the sprawl of single-family dwellings and increase forestation, farm land, wet lands and wild life preserves. Global mineral rights other than to nonferrous building materials and water shall escheat to the United Nations Organization, starting within one month of the adoption of this treaty

by the General Assembly of the United Nations. All currently-corporate-owned rights to the same minerals shall also escheat to the United Nations Organization over a ten-year schedule, ten percent per annum, starting when the General Assembly ratifies this agreement.

ARTICLE II

(Eradication of homophobia and latent homosexuality)

It is hereby recognized and accepted that, provided mother has a lover and ceases to remain available to us in fantasy or otherwise, our sexual fantasies and desires become transferred onto (a) sibling(s) or the individual(s) most like (a) sibling(s). Accordingly, the unregulated and diverse families of savage, K and R society produce heterosexual, bisexual and homosexual individuals, all of whom are equally entitled to happy lives with the partner(s) of their gender preference. Every marital partnership, monogamous or otherwise, that mirrors the number and gender of an individual's childhood-family siblings shall be fully and equally recognized for all purposes, legal and civil. All such marriages shall be recorded with the names and signatures of each partner and shall be otherwise subject to the contract and family law of the state in which they reside and their marriage is recorded.

The Transition Period (birth moratorium of twenty-five years, described in Article I, Section 2Bii) will do the

most to eliminate homophobia, *latent* homosexuality, lovelessness and the associated anger and character and personality disorders because they result, in men, from savagely-high birth rates and generally from monogamy forcing homosexual people to choose between love and progeny.

ARTICLE III

(Eradication of superstition and religious ignorance)

The teaching of the literal belief in religious myths and rituals, in “Gods,” “Devils,” “spirits” or any things immaterial and imperishable shall be forbidden. “In God We Trust” and its equivalents in other languages shall not be applied to coins and currency; and public servants who make public reference to religion, other than in jest, in popular figures of speech or in a context of scientific investigation and understanding, shall be deemed incompetent and subject to removal from office. (Amendment I of the present US Constitution is modified accordingly.)

ARTICLE IV

(Development and implementation of the Stage II system of marriage and child rearing)

In order to simplify future social life, best guarantee everyone marital bliss (love with one perfect partner, a mutual lord and bondsman), eliminate divorce and the breakup of families, eliminate marital infidelity,

minimize emotional frustration and crimes of violence, empower women within the family to a globally unprecedented extent, eliminate the Oedipus Complex, minimize the Electra Complex, save everyone the frustration and countless, wasted hours searching for love and make creative geniuses of our men and gifted family leaders of our women; the following system of marriage and child-rearing shall be developed and everywhere implemented.

Section 1 (the technical and organizational means) (A) It is assumed that governments (the United States and China, at the very least) are already in possession of "Finding Mr./Ms. Right (face-matching) Software." David Huttner has elsewhere described the algorithm for this software. Governments are to cease and desist from using this software for espionage purposes and use it only for the positive purposes outlined herein. (B) The US Government shall contract to develop "Baby Face Generating Software," which, using a sample of a baby's genome and analyzing the genes, alleles and ethnic markers that determine facial characteristics, generates frontal and side profile images of what a baby's face will look like at maturity. This software shall be used to generate these images for every newborn baby. (C) The images described in B are to be defined by the facial detection point software that is a component part of the software described in A. Each triad of images shall constitute a record that is categorically stored in a single, international database, one for females and another for males.

Section 2 (implementation and procedure) (A) For a reasonable fee, Family Planning Committees are to use the Finding Mr./Ms. Right (Face Matching) Software to assist members of the old, Stage I society in finding partners and in similarly assisting everyone who becomes a widow or widower. (B) For selected procreation couples and groups that are not monogamous and heterosexual and that give birth to girls, the Family Planning Committees are to find, from among the couples that are monogamous and heterosexual, the couple (especially the male of the couple) that looks the most like the girl and her biological father. These substitute-parents are to rear the baby girl ("Jane") and tell her that her biological parents "are close friends of ours, love their daughter very much but are working elsewhere and will be unable to see you until you are older." At three years and five months of age, every Jane is to be allowed to see her substitute or biological parents enjoying intercourse. As soon as Jane expresses her desire to replace Mom in the sex act with Dad, she is informed that all sexual activity with Dad is forbidden to her but that she can have the man who will look the most like herself and Dad. To do so, she must start school immediately. (C) At 3.5 years of age, highly-motivated Jane is enrolled in a preschool where, in addition to the usual socialization games and training in the world language (English), she undergoes an intensive course in "Health and Safety, Marriage and Family Life." Within 6 months Jane is living at the school and only going home on the weekends. Then she graduates. (D) The

Family Selection Committee uses the Finding Mr/Ms Right (Face Matching) Software to select from the database the newborn, baby boy (“Dick”) that will look the most attractive to Jane and sends her family Dick’s contact information. In the selection process, preference is to be given to Dicks from other countries and cultures so as to most quickly integrate the world’s peoples. (E) Jane travels to newborn Dick’s home and immediately starts using her training (and initial help from the biological mother or a nanny, if necessary) to perform as his wife and mother. She nurses Dick from artificial breasts that hold formula milk or (preferably) the biological mother’s expressed milk. She cleans up after Dick and learns to recognize his signals for when he needs to eliminate. She sleeps with him and devotes all of her time, energy and attention to him. All 4-year-old girls want to mother, which is why they play with dolls. With her training and the provision of all the needed resources, Jane shall become the best possible wife and mother for this man whom she knows will always love her as no one else possibly could. (F) As soon as Dick is toilet trained, they start school together in a boarding school where they have their own apartment with everything except a kitchen. The school shall have only a few teachers (as most teaching will be online with only the finest teachers) but many lab assistants, physical education instructors, nurses and counselors. They maintain contact with parents through online, instant messaging applications.

ARTICLE V

(Additional reforms to integrate governments, eradicate imperialism and improve the quality and character of government servants and their accountability to the people for all acts and omissions)

Section 1 The tax on individual incomes, which was everywhere born of military buildups and the fear of war, which became a staple of government finance and a means of government becoming unaccountable to the people and an oppressor of the people, shall be abolished at all levels of government over a ten-year period. Existing individual income tax law shall not be amended or augmented and individual income tax rates shall be reduced 10% annually until they are at zero. (Amendment XVI of the present US Constitution is repealed.)

Section 2(A) Whereas lifetime (“old-age”) government retirement plans were created to advance paternalism and the public participation and acquiescence in warfare; whereas increases in public education lead naturally to increased life expectancies and turn these plans into pyramid schemes that create ever-increasing government obligations; whereas government can only meet these obligations with either ever-increasing population growth, GDP and resource acquisition or a fraudulent and predatory medical industry or (as is actually the case) both; whereas the enabler of imperialism has become the engine that drives it; whereas the sole reasonable and sane motive for life’s

struggle is not the fear of death in and of itself but love; and whereas those who are no longer able to love through their affective or productive behavior should want to and be allowed to abandon the struggle; these plans (and institutions such as the Chinese Investment Corporation, which serve similar nationalistic ends but reap profits by covert and insidious means) shall be discontinued incrementally over a ten year schedule. FICA and SECA taxes shall not to be increased during this period and the portion of these taxes earmarked for the Federal Old-Age and Survivors Insurance Trust Fund, the Federal Supplementary Medical Insurance Trust Fund and the Federal Hospital Insurance Trust Fund are to be similarly and incrementally rerouted into the IRA or 401K retirement plans of each individual's choice. Any balances remaining in the Old-Age and Medical Insurance funds at the end of the ten-year, phase-out period shall be distributed on a population-share basis to state job training programs. Any balance remaining in the Hospital Insurance Fund shall be assigned to the Chief Medical Officer designated per Article V1, Section 2B, below, and devoted to public, medical education. (B) Whereas private, life-time annuities and pension plans were created to facilitate the exploitation of labor (pension plans) and conduce to criminal conspiracies, fraud and other torts; such existing plans shall be subject to strict scrutiny and no new ones shall be created.

Section 3 It is hereby recognized that governments that become a true friend and servant to the people by providing the vital services that civility requires, the

services that facilitate communication and cooperation and the molding of humanity into one virtual and loving family, thereby eliminate the causes of and potentials for strife, the need for every form of protection business and the perverse government roles of parent and master of the people. Accordingly: (A) the military shall cease to recruit new members, receive no budgetary increases and reduce its budget in proportion to its annual rate of personnel attrition until it is one twentieth of its present size. The military will also commence to amalgamate and integrate its forces with the similarly lean and compact forces of the other signatories to the treaty agreement. When the General Assembly ratifies this agreement, the planetary military shall be put under the command of the Secretary General of the United Nations and the original signatories (encompassing all the permanent members of the Security Council) shall unanimously move to give the United Nations Organization supreme and binding legislative power. Nation states may continue to employ national guards and coast guards in conformity with international law. All covert operations, other than for the purpose of verifying compliance with treaty agreements, are hereby forbidden. (B) All welfare entitlements shall be abolished incrementally over a period of ten years, and welfare laws shall be neither amended nor augmented. (C) All police departments, at every level of government are to receive no budgetary increases and hire no new personnel until they are shrunk to one tenth of their present manpower owing to their natural rates of

attrition; and their budgets shall be downscaled proportionately and synchronously. (D) Article I, Section 8 of the present Constitution shall be amended to include the preamble, "Government at all levels shall have all of the powers and only the powers necessary to serve the real needs of the people, needs that cannot otherwise be satisfied. These are powers to regulate and protect and to receive a fair remuneration for the services and shall include those powers enumerated below only while and to the extent that these government services are needed by the people. Services that are not self-financing (e. g. legislators, educators, military and police) shall be financed by sales and property taxes and the civil reclamations, auctions and land-leasing described in Article I, Section 4(E), herein. The foremost power and duty of government at all levels is to promote communication and cooperation between the people and thereby render itself superfluous and dissolved."

Section 4 Pay grades in excess of ten times the lowest pay grade shall be deemed violations of the spirit of Article I, 2A. The pay grades for all levels of government, except their lowest pay grades, shall be reduced accordingly. Since government service is honorary and suitable only for the noblest people, "overtime" pay shall cease to be available for all government employees.

Section 5A To enable the wealthiest individuals and corporations to continue to use the media and their wealth to influence public opinion and the political

process – without controlling the political process, without financing expensive, general election campaigns of individuals who are personally known and beholden only to these wealthiest campaign contributors; either eopc centralism (described in Art. I, Sec. 4A) or, after the Transition Period, *democratic centralism* shall be the process by which all governmental elections are conducted. These are also the election processes which best guarantee all citizens the right to express themselves and to participate in politics at a level commensurate with their relative interest, education and abilities.

Section 5B Democratic centralism shall operate as follows:

(i) All registered voters participate in selecting their representatives at the lowest, most local, level (e. g. the precinct level).

(ii) Precinct representatives convene at the ward level and promote one of their members to the next level, etc, until the President, the Vice President and ministers are chosen from among the representatives of the highest, national council (the “House of Representatives” in the USA). (Article I, Section 6 [2] of the present US Constitution is hereby modified accordingly.) The Vice President shall preside over the national council in the president’s absence and -- if he retires, is successfully impeached or dies in office – replace him until the council can convene and elect a new president. Councils at the state levels, consisting of representatives promoted from the counties, shall

replace the current state legislatures. All councils shall be unicameral; senates and all parallel state and local governments are abolished. (Article I, Sections 3[1] through 3[6] and 7[1] of the present US Constitution are hereby repealed.) Representatives at every level have legislative and executive responsibilities and shall rely upon agencies to interpret and execute the laws only to the extent that they require assistance. These executive responsibilities together with the greater communication and cooperation fostered by Article I, herein, should cause government administrative agencies to slowly wither away. (Sections 1-3 of Article II of the present Constitution are hereby repealed.)

(iii) Representatives at every level report to the councils that promoted them and are subject to recall at any time by a two-thirds vote of those councils. No representative or council shall interfere with the election and promotion process within lower councils.

(iv) All council decisions, except those regarding impeachment or expulsion, shall be decided by majority vote and shall become law within the jurisdiction of the council unless overridden or superseded by the decision of a higher council. All decisions of higher councils are binding upon lower councils. (Article I, Sections 7[2] and [3] of the present Constitution are repealed.)

Section 5C This section, Article V, Section 5 of the 28th Amendment, repeals from the present Constitution, Article I, Section 1.

Section 6 As has been understood since the publication of George Orwell's 1984, individuals who suffer from homophobia and latent homosexuality grow up wearing the Third Mask, are angry and are inclined to prevaricate about anything and everything. Thus, their participation in politics, where they do the most damage, shall be discouraged accordingly: all persons registering as candidates for elected offices shall register what they believe their sexual orientation to be (i. e. homosexual, bisexual or heterosexual). Candidates registering as heterosexual or publicly representing themselves as heterosexual and those legally married to persons of the opposite sex shall also register the names, addresses and genders of their siblings, half-siblings and cousins whom they saw frequently and on a regular basis prior to age thirteen and any other persons with whom they lived for more than one month prior to the age of thirteen. False reporting of this information shall be sufficient grounds for removal from office.

ARTICLE VI

(Food, Medicine and Energy)

Section (Food) 1(A) Refined sugar, artificial sweeteners and azodicarbonamide are hereby forbidden as food additives. (B) Wasted food and human waste is to be collected and returned to the farm land as has been done perennially in China. (Human waste is plant food and NOT fish food as westerners mistakenly believe.) This may occasionally require the boiling of drinking

water, due to e-coli bacteria; but the cost of boiling is far less than the health costs of losing the vitamins and minerals from our top soil and our food. (C) Doctor Gary Null shall replace the current Food and Drug Administration director. He shall serve for life and choose his replacement. (D) Although the changes implemented by this Amendment's Article 1, Sections 2A, 2B and 3 will immediately reduce the demand for and increase the supply of food; the following measure may be necessary to alleviate hunger in the short run and supplement diets. Gary is to appoint a committee of respected agronomists and marine biologists to study the feasibility and advisability of establishing artificial floating reefs, in US coastal waters, for the inexpensive cultivation of fish. Gary is also to educate the public as to the best practices for integrated, animal and plant, hydroponic cultivation.

Section (Medicine) 2(A) The government is to remove itself from the medical business, except for its obligations to veterans and the maintenance of VA hospitals. Medicare, "Obamacare" or similar programs by any name are to receive no further funding and are to be defunded and decommissioned incrementally over a six-month period commencing with the enactment of this 28th Amendment. (B) Doctor Ilsedora Laker shall be asked to replace the current Chief Medical Officer. If she declines the offer, she shall be asked to recommend one of her protégés. The new, Chief Medical Officer shall serve for life and choose his or her own replacement. (C) The Chief Medical Officer shall direct the VA hospitals, which will utilize Dr.

Hamer's New German Medicine protocols and instruction unless and until ones of better and proven effectiveness can be found. VA hospitals shall admit and treat non-veterans on an availability basis (veterans retaining priority service).

Section (Energy) 3(A) All nuclear power plants are to be decommissioned and no new ones built or commissioned unless and until the technology is developed to reprocess and render harmless all nuclear waste products. (B) Governments that are signatories to this agreement are to jointly undertake the research and development of layered nanocarbon tube wires of 4 km in length. (Nanocarbon conducts both electricity and heat hundreds of times better than copper and can potentially be used to draw up thousands of times the equivalent of our current energy needs in geothermal heat that can generate electricity cleanly, renewably and above the ground.) Geothermal energy and other forms of renewable energy are to replace all use of fossil fuels within a ten year schedule during which all providers of such energy and manufacturers of products consuming it are to downscale or revamp their production accordingly.

Section 4 We hereby acknowledge that the creation of cheap food (as contemplated in Section 1D, above) and or cheap energy (as provided for in Section 3B, above) would, in the absence of the equal opportunity and population control reforms of this Amendment's Article I, lead to another explosion of the human population and destroy what remains of Earth's biological

diversity. *Therefore, the provisions of this Article's Sections 1D and 3B shall only be undertaken in conjunction with those of Article I.*

ARTICLE VII

(Converting the World to English)

Whereas humanity requires a common language in order to facilitate communication and cooperation and unite into the one virtual and loving family that we virtually were (prior to our earliest division at Lake Victoria and, minus our African half, remained through the outbreak of the Species War at Ur), the one virtual and loving family that we ought to be;

Whereas the trade and port language of the western world that originated in Troy/England is the most modern language with the simplest, easiest-to-learn and word-order-dependent syntax;

Whereas this trade and port language (English) is already well underway to becoming the world language;

The native-English-speaking countries that are signatories to this agreement resolve to establish an annual, three month long, summer-time “English Teacher Invasion of the World” program as follows.

Section 1 All college students who are native English speakers and wish to participate shall obtain a TOESL or similar, online certificate.

Section 2 Commercial airlines shall be requested to donate free transportation to and from the countries to which the teacher/invaders travel.

Section 3 Host countries shall be required to provide room and board (quartering) for the teacher/invaders, who shall be apportioned among the host countries on a language need and quartering ability basis.

Section 4 The basic guideline for all teaching plans shall be that provided by David Huttner's book, "Converting the World to English."

Section 5 The teacher/invaders' only remuneration shall be (A) the satisfaction of having performed a politically-vital task, (B) the life-long gratitude and friendship of some of their students, (C) an enhanced understanding of cultural differences, (D) an objective understanding and assessment of their native cultures and (E) a light-weight but inexpensive travel bike constructed with plastic brush tubes and bicycle torque couplings, a bike that easily disassembles and transports in a hemp bag, a bike that will be given to them when they arrive in their host community and can be taken home with them and that will be manufactured and donated by the Shanghai-Phoenix Bicycle Company and/or any other suitably large and successful companies that wish to participate.

ARTICLE VIII

CUNO

Upon ratification of this agreement by the General Assembly, the UNO will change in character (becoming a Civilized United Nations Organization) and global progress and integration will start to accelerate at an unprecedented pace. As the supreme legislative, judicial, military and police power; CUNO's various branches shall be responsible for monitoring the member state's compliance with this agreement and restructuring itself (forming the new bodies called for in this agreement and eliminating old bodies or gradually diverting budgetary resources from old to new bodies as conditions warrant).

Section 1 New CUNO bodies shall include: (A) the Equal Opportunity, Population Control and Family Planning Committees subject to Article I; (B) the supreme military command of our downsized and integrated militaries [a Hexagon?]; (i) which shall locate and manage or expropriate manufacturers of all military-grade weaponry and all major military contractors globally and as appropriate; (ii) identify and inform the Secretary General of potential sources of conflict throughout the world, (iii) resolve conflicts as peacefully as possible, (iv) continually upgrade weaponry, utilizing the most advanced technologies, (v) undertake planetary preparedness training for natural disasters and the (remote) possibility of extra-terrestrial invasion; (C) an NRA [Natural Resources Administration (the malevolent NRA, known to US citizens, shall cease to exist as CUNO manages or expropriates all weapons manufacturing companies)] (i) which shall inventory Earth's subterranean

resources, excluding non-ferrous building materials (ii) devise improved mechanisms for reclaiming and recycling these resources, (iii) estimate the amount of each non-renewable resource that can be annually and sustainably utilized and auction extraction rights of the same to the highest bidders and (iv) distribute the royalties to the under-developed countries for the development of their infra-structure and (D) a MCRC (Multinational Corporation Regulatory Commission) (i) which shall have the exclusive right to tax and regulate multinational corporations, (ii) which shall monitor the proportions of various companies' prices within the industries where multinationals exist to discover cartels and monopolies, (iii) designate cartels and monopolies and subject them to price regulation, (a) to equate their returns on investment to the yields of triple-A bonds and (b) grant price-regulated monopolies and cartels the right to buy-up start-ups deemed indispensable to their (the monopoly's or the cartel's) survival, (c) providing the so-designated start-ups at least two years to recover their costs and (d) arbitrating the buy-out price if the parties fail to agree on one, (iv) all decisions of the MCRC being appealable to the ICJ [International Court of Justice (at the Hague)]; (E) a patent law division of the ICJ, (i) which prepares and submits to the General Assembly legislation standardizing patent law throughout the world, (ii) consolidates national patent offices; (iii) monitors and requires the reporting to itself of the transfer of patent rights [recommending to the General Assembly the creation of criminal penalties for

compliance failure] and (iv) prepares and submits to the General Assembly legislation creating time limits within which the buyers of patents must either put their technologies into commercial production or lose their rights to them.

Section 2 CUNO will cease to finance itself with contributions from the member states and finance itself instead with taxes collected by the MCRC.
