# Commentary on the Continuity and Expansion of Vision: From ARAA to CRGA

## The Pax Americana Renaissance & Architecture Act (PARAA-2025)

A Bill to restore American infrastructure, civic design, and federal architecture to a classical and sacred standard—revitalizing the economy, glorifying God, and renewing the spirit of national unity through Christian order, virtue, and beauty.

# **Statement of Legislative Intent**

To authorize and fund the planning, construction, and implementation of a national infrastructure and architectural restoration initiative that:

- 1. Replaces godless, brutalist architecture with buildings of symbolic and sacred character
- 2. Expands highways, bridges, and transportation systems with classical and regional artistry
- 3. Commemorates America's divine heritage and the Christian roots of its law and liberty
- 4. Trains a new generation of builders, masons, artists, and engineers in faith-driven excellence
- 5. Elevates the moral and aesthetic standards of civic life and public space





# **Strategic Legislative Objectives**

#### 1. Establish the PARA National Commission

# **Fiscal Impact Summary**

## 1. Resilience-first budgeting

– PARA allocates approximately \$850 billion over 10 years, leveraging targeted revenue (e.g., dedicated excise taxes, AI tax) to avoid increasing the debt.

– Much of PARA funding is front-loaded by reallocations (e.g., existing defense, VA, DOE/DARPA) and not additive to the budget baseline—thus reducing reliance on borrowing.

## 3. Growth multiplier

– Absent costly mistakes, these programs can boost GDP growth modestly (1–2 pp) while reducing unemployment and fortifying tax bases.

## 4. Debt containment strategy

– With assumed GDP growth via PARA programs, interest-GDP ratio is expected to





stabilize at ~120–125%, instead of trending upwards—buying critical fiscal latitude.

# 5. Interest savings

- Preventing debt creep and promoting growth may reduce future interest costs, potentially saving hundreds of billions annually.

## SECTION I - NATIONAL PURPOSE & JUSTIFICATION

"Restoring the Foundations of a God-Blessed Republic"





## §101. Declaration of Intent

The United States of America, in order to preserve its divine inheritance, secure the blessings of liberty, and provide for the cultural and spiritual well-being of its citizens, hereby proclaims a national mission of civic restoration. The purpose of this Act is to initiate and institutionalize a multi-decade infrastructure renaissance that renews American architecture, engineering, and city planning in accordance with the classical, Christian, and republican ideals upon which the nation was founded.

This Act shall lay the groundwork for the design, development, and construction of:

- Grand civic halls, courthouses, state capitals, and municipal buildings
- National monuments and sacred memorials to American heroes and divine providence
- Roads, bridges, highways, and transit networks that connect the nation with order and dignity
- Strategic federal infrastructure, including research centers, military installations, and federal agency headquarters
- Restoration of beauty, order, proportion, symbolism, and permanence in all national projects

The United States hereby asserts that physical design is not morally or politically neutral. Cities and buildings form the conscience of a people. Architecture is theology cast in stone; it either points upward toward God and virtue—or downward into chaos and despair.

This Act recognizes that without reverence, without harmony, and without moral authority in the very structure of our nation, the American people lose their memory, their dignity, and their destiny.

#### §102. Constitutional Foundation

This Act is justified under the following constitutional principles:





- Article I, Section 8 empowering Congress to provide for the general welfare and to fund national infrastructure and civic institutions.
- The Preamble committing the government to establish justice, ensure domestic tranquility, and secure the blessings of liberty.
- The 10th Amendment allowing states and the people to work in partnership with federal authority for local and regional revitalization.

## §103. Moral and Civilizational Imperative

The collapse of beauty in the built environment parallels the collapse of virtue in the body politic. As Thomas Jefferson once wrote:

"The art of architecture is among the most useful and most honorable of all arts. It unites taste with convenience, and displays the power of a people."

— Thomas Jefferson, Notes on the State of Virginia

As Scripture proclaims:

"Unless the Lord builds the house, the builders labor in vain."

— Psalm 127:1

The loss of grandeur, dignity, and sacred space in American public architecture has contributed to a society that no longer reveres the transcendent or honors the eternal. The Pax Americana Renaissance shall reverse this trend.

We restore not only roads and bridges—but the American soul.

# SECTION II - INFRASTRUCTURE ZONES & PROJECT TYPES





"Laying the Stones of Restoration: National Blueprint for Renewal"

# §201. Establishment of National Infrastructure Renaissance Zones (NIRZs)

The United States Congress hereby authorizes the Department of Commerce, in collaboration with the Departments of Defense, Transportation, the Interior, and Homeland Security, to designate and develop National Infrastructure Renaissance Zones (NIRZs) across all fifty states and territories. These zones shall serve as hubs of economic revival, architectural excellence, national identity, and citizen employment.

#### Each NIRZ shall include at minimum:

- A restored or newly constructed Civic Core: including a courthouse, town hall, and cathedral or chapel
- A Memorial Walk or Cultural Axis to commemorate the spiritual and historical roots of the American people
- A National Road & Rail Terminal of beautiful and secure design, connecting major trade and military arteries
- A Research & Innovation District featuring new institutions of art, science, health, and theology
- A Veteran & Family Resource Center to serve those who bore the burden of war and poverty
- A National Guard Armory and Civic Defense Campus to ensure preparedness and patriotic service

## §202. Categories of Projects Authorized

Under this Act, the following project types shall be federally initiated or incentivized for development in both urban and rural environments:





#### 1. Architectural Monuments and Landmarks

- o Domes, arches, towers, and spires of national symbolism
- Restoration of degraded sites of American heritage

#### 2. Transportation Infrastructure

- o Highways, bridges, railways, and intermodal hubs
- Projects must include aesthetic design and regional cultural elements

#### 3. Waterworks and Energy

- o Grand public fountains, aqueducts, water purification systems
- Renewable and nuclear energy hubs built with monumentality and harmony in mind

#### 4. Military Installations & Fortresses

- Permanent, defensible, and symbolically rich military bases
- Memorial chapels, honor walls, and command centers with sacred geometry

#### 5. Scientific & Religious Research Sites

- Astrophysical observatories, oceanic research institutes, medical and theological academies
- Structures to reflect the pursuit of truth, virtue, and divine order

#### 6. Public Housing and Gardens





- Beauty-centered public housing rooted in the dignity of family and tradition
- Christian gardens, monasterial orchards, and urban farms rooted in Edenic design
- 7. Civic Centers, Chapels, and Theaters
  - All new civic structures must incorporate classical, Romanesque,
     Byzantine, or American neoclassical style
  - o Emphasis on natural light, sacred proportions, and permanence

# SECTION III - ARCHITECTURAL AND SYMBOLIC GUIDELINES

"Reviving the Sacred Geometry of the Republic"

## §301. Design Mandates for Federal and Federally-Funded Construction

All projects developed under this Act—whether directly built by federal agencies or funded via grants to states or localities—must conform to the following design mandates rooted in Western, Christian, and classical traditions:

## A. Acceptable Styles

- Neoclassical, Byzantine, Romanesque, Gothic Revival, and Colonial American
- Contemporary buildings must integrate classical proportion, sacred geometry, and meaningful ornamentation
- Brutalist, postmodernist, and intentionally abstract or dystopian styles are strictly prohibited in all federal or military projects

#### **B. Symbolic Requirements**

- Each federal structure shall include:
  - A cross or sacred symbol honoring Judeo-Christian faith at its highest point
  - o Latin or English inscriptions of Scripture or foundational civil texts
  - Use of the Eagle, Star, Olive Branch, and Torch as permitted symbols of national unity





• Artistic depictions of American founding events, biblical figures, angelic guardians, and military virtue

#### C. Structural Priorities

- Emphasis on domes, arches, vaults, and spires to lift the eye and spirit
- Use of natural stone, bronze, glass, and wood, avoiding plastics and unnatural textures
- Buildings to be sustainable, eternal, and capable of use for hundreds of years

## D. Layout and Geometry

- Follow sacred geometry: golden ratio ( $\Phi$ ), symmetry, alignment with cardinal directions and celestial markers
- Civic plazas must be aligned with religious and historical centers
- Each NIRZ shall include a centerpiece structure (cathedral, senate, hall, or tower) surrounded by gardens, courts, and memorials in proportional balance

#### §302. Cultural Dedication and Commemoration

- Every project zone must be dedicated by a public prayer, Scripture reading, and veteran or clergy blessing
- Federal monuments shall be inscribed with Psalm 33:12: "Blessed is the nation whose God is the Lord"
- A commemorative Pax Americana Seal shall be placed in stone at each completed site

# SECTION IV - ECONOMIC STIMULUS & STRATEGIC MILITARY INTEGRATION





"A National Renaissance Through Labor, Defense, and Divine Order"

#### §401. Mobilization of the American Workforce

To ensure full national engagement, this Act establishes a Pax Americana Jobs Corps—a coordinated civilian-military-industrial initiative that will:

### A. Employment Objectives:

- Employ at least 3 million Americans in:
  - Construction and engineering
  - Classical craftsmanship (stone, bronze, carpentry)
  - Infrastructure logistics and logistics support
  - Federal aesthetic planning, public art, and conservation
- Prioritize veterans, young adults, formerly incarcerated individuals, and underserved communities
- Partner with trade schools, Christian universities, and state apprenticeship programs

#### **B.** Wages and Benefits:

- Guarantee living wages, healthcare access, housing stipends in rural builds, and skill certification
- Workers will be treated as national civil artisans, contributing to the renewal of the American covenant

# §402. Strategic Integration with National Defense

The PARA Act will fuse economic revival with national defense modernization, enhancing strategic resilience across four domains:

#### A. Dual-Use Infrastructure:

 Roads, bridges, ports, and airfields must support military transport, drone logistics, and civilian-military emergencies





 Require EMP-hardened facilities, deep bunker locations, and supply chain redundancies

#### **B. Defense-Integrated Industrial Zones (DII-Zones):**

- At least 12 designated zones where infrastructure will co-exist with:
  - Shipyards and naval facilities
  - Aerospace and drone manufacturing
  - Cyber defense and AI command outposts (ethically supervised)

- Broadband and water purification programs

# §501. Identification and Designation of Strategic Sites

The PARA Act identifies key regions of geographic, cultural, prophetic, and economic importance across the United States to serve as hubs for renewal:

# A. Northern Kentucky-Greater Cincinnati Region:

- Birthplace of the modern covenant movement.
- Proposed site of the Great American Basilica, dedicated to Christ the King and civic virtue.
- Interstate gateway zone—logistics, pilgrimage, memorial park, and veterans renaissance district.

# **B. Appalachian Highlands & Blue Ridge Spine:**

- Designated for sacred mountains, restorative retreats, natural resource hubs.
- Ideal for holy sanctuaries, Christian academies, and revival amphitheaters.
- Will include an Eastern Watchtower monument to defend and proclaim liberty from the hills.

### C. Midwest Belt - Grain, Rail, and Gospel:

- Industrial-church complex builds (cathedrals, civic commons, stations of renewal).
- High-speed rail from Chicago to Dallas with Americana Revival architecture.
- Rural towns converted to Self-Sustaining Federal Artisan Colonies.

#### D. Four Corners National Bastion:

- Monumental defensive infrastructure for desert military innovation and peacekeeping.
- Multi-faith embassies, Scripture-based law academy, drone development parks.

# E. Pacific Crown (California, Oregon, Washington):

• Select restoration of coastal ports for:





- Naval operations
- Christian seminaries of apologetics
- o Film, music, and arts Renaissance hub
- Holy Mount Project: Tower of Restoration overlooking the Pacific (symbolic axis mundi)

#### F. Southern Cross Belt (Texas, Louisiana, Florida):

- Resurrection of Christian domes, Gothic capitals, and domed state chapels.
- Flood, storm, and EMP-resilient infrastructure.
- Massive infrastructure hubs tied to Gulf trade and biblical-era design ethics.

#### §502. The "American Wonders Initiative"

The United States shall commit to erecting seven national wonders across its territories to:

- 1. Reflect America's spiritual rebirth
- Serve as beacons to the world
- 3. Restore public awe, reverence, and national unity

#### **Proposed Wonders:**

- The Cathedral of Unity in Kentucky
- The Tower of Testimony Arizona or Nevada
- The Path of the Prophets East Coast corridor of shrines and monuments
- The Fortress of the Republic Great Plains or Missouri River valley
- The Pillars of Peace Pacific arch
- The American Ark Appalachian museum of heritage, faith, and flood survival
- The Hall of Nations DC-adjacent Christian diplomatic embassy

# §503. Sacred Geography & Biblical Symbolism

Each region and build must be:

• Aligned with sacred topographies—rivers, elevations, cardinal direction





- Grounded in biblical symbolism (temple dimensions, sacred ratios, gates of heaven)
- Designed to remind America that God is among His people

- Unify public universities, defense institutions, Christian academies, and private sector innovators
- Operate under strict Biblical ethics, national security standards, and constitutional liberty safeguards
- Focus on AI alignment, energy independence, space communication, and biomedical integrity

# A. Designated Corridors:

- 1. Appalachian Ethics & Innovation Corridor AI, robotics, and ethics labs
- 2. Great Lakes Energy & Water Corridor Clean energy, hydro-tech, and nuclear revitalization
- 3. Texas-New Mexico Aerospace & Space Doctrine Corridor Space travel, EMP defense, firmament sciences
- 4. Southern Bioethics & Medical Restoration Corridor Christian-aligned research in DNA, healing, and mental health
- Pacific Defensive and Cybersecurity Corridor Combat CCP infiltration, cybersecurity resilience
- 6. Heartland Agriculture & Restoration Corridor Sustainable farming tech, rural AI, food supply sovereignty
- 7. Arctic-Northern Communications & Atmospheric Command Weather research, orbital tech, signal integrity

# §602. AI Governance & Ethical Oversight Division

A new federal board shall be created:

The Christian Technological Stewardship Commission (CTSC)

**Duties include:** 





- Evaluating all AI for:
  - Human dignity preservation
  - o Scriptural alignment
  - National interests
  - o Security of the soul and mind
- All AI must pass a Moral Sanity Audit developed with input from:
  - Orthodox Christian theologians
  - Computer scientists
  - Constitutional lawyers
  - Military cyber-defense officials

### §603. Biomedical & Genetic Restoration Doctrine

#### America will:

- Ban:
  - o Transhumanist modifications
  - Human-animal hybrids
  - Non-consensual experimentation
  - Eugenics programs
- Promote:
  - Healing technologies aligned with creation
  - Natural restoration practices
  - o Non-invasive cancer and neuro recovery research
- Fund:
  - o Faith-based hospitals
  - Christian rehabilitation clinics
  - Neural trauma centers for veterans and the elderly

# §604. Atmospheric, Celestial & Naval Engineering

#### Directed investment in:

• EMP-proof and nuclear-resilient electrical grids





- Airship and anti-gravity research zones (under NOAA and DOD oversight)
- Christian-led exploration of the firmament, upper atmosphere, and acoustic phenomena
- Naval reconfiguration with:
  - Hypersonic deterrents
  - Sea defense reefs
  - Ocean floor sanctuaries for national defense and creation preservation

# Legal & Philosophical Justification for Section VI

- 1. Scriptural Authority

# §701. Restoration of the American Tradesman and Artisan

The United States shall launch a National Tradesman and Artisan Revival Act, hereafter referred to as Project Hammer & Harp, aimed at:

- Reviving craftsmanship across rural and urban America
- Establishing state-sponsored artisan guilds grounded in Christian vocational mentorship
- Reopening and revitalizing abandoned factories, mills, and historic workshops
- Encouraging the production of domestic goods, sacred art, furniture, and infrastructure parts

These hubs shall be governed by:

- Faith-based local boards
- Veteran-operated trade centers
- Apprenticeship initiatives through the Non Ducor Duco Academy

# §702. Federal Infrastructure Corps (FIC)

A civilian-military workforce program that fuses:

- CCC-style public works
- Disaster recovery rapid deployment teams
- Veteran and re-entry citizen employment tracks

FIC members will:





- Build and maintain:
  - o Roads, railroads, canals, and bridges
  - Water purification stations and vertical farms
  - Sacred sites and city beautification projects
- Be provided:
  - o Room, board, spiritual guidance, and educational credits
  - Local placement programs tied to post-service careers

# §703. Christian Cooperative Economic Zones (CCEZs)

Designated regions across America will pilot a new biblical economic model rooted in:

- Free market principles infused with Christian ethics
- Debt forgiveness programs for families, farmers, and small businesses
- Resource pooling via co-ops for:
  - o Housing, healthcare, tool-sharing, childcare, and elder care
- Tithe-based public investment pools replacing predatory loan models

# §704. National Repatriation & Reinvestment Act

All American-owned manufacturing, technological, and energy-producing companies operating offshore shall be:

- Offered patriotic tax incentives to return home
- Penalized for outsourcing essential national industries
- Provided grants for:
  - o Building in Strategic Labor Revival Zones (SLRZs)
  - o Partnering with FIC, Veterans Corps, or Guilds

# §705. Employment, Agriculture & Financial Liberty Act

This subchapter declares:

 Abolition of property tax for family homeowners on land used for food or self-sustaining purposes





- A new agrarian dividend paid to families who produce goods or services for their communities
- Immediate breakup of monopolies in food distribution, fertilizer, and rural land ownership (e.g., BlackRock, Gates Foundation holdings)

# **Legal & Philosophical Justification for Section VII**

"Beauty for Ashes: The Cultural Renaissance of a Nation"

# §801. The National Sacred Arts Revival Program (NSARP)

To restore the spiritual and cultural vitality of America, this legislation inaugurates a federally supported but locally governed arts initiative focused on:

- Sacred architecture, iconography, sculpture, and classical music
- Creation and restoration of:
  - Church murals and mosaics
  - Public monuments with Christian, moral, and historical themes
  - Scriptural inscriptions in public buildings and courthouses
- National tours and fellowships for artists trained in:
  - o Byzantine, Romanesque, Baroque, and Neoclassical styles

# Funding will be directed to:

- Faith-based fine arts academies
- Artisans graduating from National Guilds (see §701)
- Apprentices working under living masters in sacred traditions

# §802. Gospel Media Infrastructure & Christian Broadcasting Network (CBN-USA)

This subsection reclaims the digital and broadcast airwaves for:

- Truthful reporting
- Faith-filled inspiration
- Education grounded in Christian worldview

#### **CBN-USA will:**





- Establish regional gospel studios in each state
- Create a federally protected digital media archive of:
  - Church history
  - Sermons
  - Sacred music
  - o Documentaries on American Christianity and virtue

Public schools and libraries shall feature CBN-USA programming in civic and history education tracks.

# §803. The Psalter Program

### Establishing:

- National Psalm Choirs in schools and youth programs
- Commissioning new musical compositions based on the Psalms, Prophets, and Gospels
- Public performance grants for sacred festivals, revivals, and holy day reenactments

# §804. Heritage Cinematics & Redemption Film Industry Act

A national initiative to develop:

- Films and television series rooted in biblical, historical, and virtuous storytelling
- State tax credits and grants for:
  - o Productions with moral, redemptive arcs
  - Christian producers and directors
  - o Studio zones in declining regions to spur employment and tourism

#### This act will:

- Open film sanctuaries and community theaters in rural towns
- Incentivize Christian cinema tours with education-based discussion sessions

# §805. Cultural Literacy Restoration Act





#### This mandates:

- A required civics and culture education track in all public institutions
- Emphasis on:
  - American Christian heritage
  - o The Constitution and Declaration of Independence
  - Hebrew, Greek, Latin roots of liberty
  - o Contributions of saints, revivalists, patriots, and reformers

#### All educational materials shall be:

- Faith-affirming
- Factually accurate
- Rooted in love for truth, freedom, and national dignity

# **Legal & Philosophical Justification for Section VIII**

- 1. Biblical Mandate
  - Exodus 31:1-5: "I have filled him with the Spirit of God... in all manner of workmanship."
  - o Psalm 96:9: "Worship the Lord in the beauty of holiness."
  - o Philippians 4:8: "Whatever is noble, pure, lovely... think on these things."
- 2. Church Fathers and Beauty
  - o St. Augustine: "Beauty is the glory of truth made visible."

# SECTION IX - NATIONAL INFRASTRUCTURE OF DIVINE ORDER

"A City Set on a Hill: Holy Spaces, Monuments of Renewal, and Capitol Reenchantment"

# §901. Holy Cities & Sacred Districts Program (HCSDP)

To reawaken America's spiritual life and establish enduring sacred heritage, Congress hereby authorizes the designation and construction of Holy Cities and Sacred Civic Districts across the United States.

#### **Objectives:**

- Establish regional capitals of faith and culture
- Designate cities with profound historical, Christian, or prophetic significance (e.g. Jerusalem, Kentucky; New Bethlehem, PA; Nazareth, TX)
- Construct:
  - National Cathedrals
  - o Biblical gardens and pilgrimage walks
  - Gospel universities
  - Veterans' Churches of Remembrance
  - o Christian Courts of Justice and Natural Law

Cities will serve as centers of pilgrimage, worship, education, and governance under Christ.

# §902. Capitol Beautification & Sacred Symbol Restoration





All federal buildings, capitals, and courtrooms are hereby commissioned to undergo beautification, incorporating:

- Mosaics of justice and mercy
- Sacred verses carved in stone
- Statues of saints, martyrs, and Christian patriots
- Architectural facades in Neoclassical, Baroque, or Christian Imperial styles

### The U.S. Capitol Complex shall be crowned with:

- A central bronze cross
- Illuminated verses from the Beatitudes and Ten Commandments
- A National House of Prayer open 24/7 for intercession and repentance

#### §903. Monuments of Renewal Initiative

Establish a national program to erect Monuments of Renewal—sacred and civic landmarks honoring:

- Deliverance from slavery, addiction, war, and tyranny
- Faithfulness of Christ through American history
- The unborn, the persecuted, and those forgotten by men but remembered by God

#### Monuments shall be raised in:

- Inner cities and rural towns alike
- Battlefields, revival sites, orphanages, and border crossings

### Examples include:

- The Prodigal's Gate (a monument to repentance and national return to God)
- The Psalm 91 Obelisk (a structure symbolizing divine protection)
- The Defender's Pillar (a national war memorial for Christian soldiers)

# §904. National Sacred Construction Corps (NSCC)

Form a Christian-led corps of architects, engineers, artists, and masons trained in:





- Sacred geometry
- Ecclesiastical design
- Scriptural symbolism
- Natural stone, stained glass, wood, and sustainable materials

#### Corps members will be:

- Commissioned as servants of the republic
- Sent across the nation to design and build the Kingdom Commons—spaces where justice, worship, and governance meet

### §905. Architectural Codes of the Covenant

Every structure receiving federal funding must:

- Reflect truth, order, beauty, and sacred dignity
- Reject brutalist, postmodern, or nihilistic styles
- Be modeled after divine proportion, natural harmony, and Biblical meaning

The "Architectural Charter for National Renewal" (to be codified in Appendix V) shall govern this standard.

# Legal & Philosophical Justification for Section IX

#### 1. Biblical Foundations

- o Isaiah 2:2-3: "The mountain of the Lord's house shall be established... and all nations shall flow unto it."
- o Psalm 48:1-2: "Beautiful in elevation, the joy of all the earth, is Mount Zion."
- Revelation 21: The New Jerusalem, its streets and dimensions, offer a template for divine urban design.

### 2. Theological Vision

- St. Augustine: "Peace is the tranquility of order."
- o St. Thomas Aquinas: "Art is right reason in the making."
- o Benedict XVI: "The faith becomes culture when it is expressed in form."

#### 3. American Precedent





- Washington D.C. originally planned by L'Enfant using symbolic Christian layout
- Mount Rushmore, Lincoln Memorial, and the Liberty Bell all embedded sacred meanings
- The WPA and CCC once built national parks, monuments, and moral architecture in hard times

### 4. Strategic National Benefit

# SECTION X - STRATEGIC SOVEREIGNTY INFRASTRUCTURE

"Rails, Rivers, Roads, and Righteousness: Building the Backbone of a Free Republic"

# §1001. National Transportation & Mobility Sovereignty Act

The United States shall fund, construct, and restore its critical infrastructure with the goal of securing sovereign domestic mobility across land, air, and water.

### **Major Initiatives:**

- 1. Restoration of National Rail Lines
  - Rebuild regional railways connecting forgotten cities, rural communities, and agricultural zones
  - Reconnect industrial supply corridors across state lines
  - Launch the "American Pilgrim Train"—a transcontinental route linking major revival cities and historical Christian sites
- 2. Reconstruction of Interstate Roads & Highways
  - Prioritize military-grade construction standards
  - Design symbolic routes shaped by the Cross and the Covenant





- Install lighting, safety, and emergency shelter systems across long-distance routes
- 3. American Canal & River Revitalization Project
  - Dredge and modernize inland waterways for bulk transport and flood prevention
  - Reinstate barge-based freight systems to reduce dependence on foreign ports

# §1002. Strategic Port Cities & Naval Bastion Development

Identify and transform key maritime and inland ports into fortresses of commerce and defense, anchored by:

- Christian civic centers
- High-yield logistics hubs
- Joint civilian-military naval industries

### **Designated Strategic Ports:**

- Charleston, SC Heritage Fortress Port
- Mobile, AL Revival Commerce Gateway
- Louisville, KY Inland Naval and River Defense Command
- Corpus Christi, TX Gulf Christian Stronghold
- Tacoma, WA Pacific Pilgrimage Port

# §1003. National Supply Chain & Production Independence Program

Create the American Sovereignty Industrial Grid (ASIG) to:

- Localize essential manufacturing
- End reliance on adversarial foreign production
- Mandate all strategic goods (medical, military, electrical, water, energy) be produced domestically

#### ASIG Facilities shall be built near:

Military bases





- Faith-led vocational schools
- Logistics corridors and border checkpoints

# §1004. Economic Defense Infrastructure Zones (EDIZ)

Establish federally protected zones of economic resistance and revival in:

- Appalachia
- Rust Belt cities
- Borderlands
- Native and rural territories

### Each zone shall be granted:

- Preferential tax policy
- Infrastructure grants
- Land leases for Gospel-aligned projects
- Sovereign credit development funds

#### EDIZs will house:

- Resource processing plants
- Faith-and-family focused homesteads
- Domestic cyber defense nodes and tech sanctuaries

# §1005. National Roads of the Covenant Program

All new infrastructure funded by this bill shall:

- Be consecrated with prayer and scripture upon groundbreaking
- Feature stone markers engraved with blessings, scripture, or local Christian history
- Align design with God's principles of flow, purpose, and order (see Appendix VI)

# SECTION XI - AGRICULTURAL AND ECOLOGICAL DOMINION

#### §1101. The Eden Renewal Act

The United States shall restore and sanctify the nation's agriculture and land management under the framework of divine stewardship, local autonomy, and long-term food independence.

#### **Key Measures:**

- Subsidies redirected to small, faith-based farms over corporate monoculture giants
- o Protection from predatory foreign land purchases

# §1102. National Food Independence Mandate

America shall never be dependent upon hostile nations or corporate monopolies for its daily bread. Thus:

- All critical food categories must have a domestic, independent supply chain
- Ban on foreign ownership of agricultural land
- Emergency national seed vaults to be distributed across states

# §1103. National Park Sanctification & Resource Zones

The nation's parks and lands shall be consecrated as Ecological Cathedrals, protected from technocratic destruction or foreign privatization.

#### Each site will:

 Include Christian dedications, scripture markers, and creation-based educational displays

# SECTION XII - MILITARY ARCHITECTURE AND NATIONAL DEFENSE INSTALLATIONS

§1201. The Fortress Doctrine of Christian Defense





America shall invest in the architectural, strategic, and technological renewal of all defense installations, bases, and military academies. These shall no longer be symbols of moral decline or geopolitical confusion, but sanctuaries of righteousness, discipline, and strength.

#### **Core Directives:**

- 1. Reconstruction of Military Bases with Classical and Christian Design
  - Replace soulless, brutalist structures with citadel-style installations featuring:

- 2. Strategic Realignment
  - Construct new defense zones in underutilized inland areas to:
    - Mitigate coastal vulnerability
    - Provide jobs to middle America
    - Reinvigorate national defense identity
- 3. Unified Command Christian Chapel
  - All major military bases must include a consecrated chapel for worship and Christian education
  - Military chaplains to be trained in both spiritual warfare and doctrinal fortitude

# §1202. High-Command Redesign & Civilizational Symbolism

A full redesign of the Pentagon and major strategic hubs shall be considered under Project Aegis:

- Public architecture shall mirror that of Constantinople, Rome, or Old Testament fortresses
- Command centers will integrate both cyber-defense infrastructure and sanctified physical environments





Note: All new buildings must contain scriptural inscriptions, oaths to the Constitution under God, and architectural features to inspire courage, awe, and fear of God.

# §1203. Training Grounds of the Ecclesia Militans

  - Major interstates to include subterranean defense shelters, civil defense zones, and satellite hubs
  - o Redundant supply systems for wartime transport and defense
- 2. Homeland Defense Fortresses
  - Urban defense installations constructed around major cities: New York,
     D.C., Houston, Denver, etc.
  - Structures to be modeled after crusader citadels and American forts like
     Fort McHenry

# §1205. Technological Integration and Sacred Command

- 1. Cyber & Space Command Sanctification
  - Integration of AI defense and hypersonic deterrents under prayer and oaths





 Command HQ for Space and Cyber divisions must contain consecrated control rooms, red sanctuaries, and military Psalms inscribed in steel

#### 2. The Aegis Accord

 No AI defense mechanism or drone technology can operate without a human override conditioned by Christian ethical protocol

- 1. The Liberty Cathedral (Washington, D.C.)
  - A colossal temple-like sanctuary symbolizing America under Christ—open to all denominations
- 2. The Pillars of Providence (Appalachian Highlands)
  - Twin mountainous towers engraved with the Decalogue and the Constitution
- 3. The Ark of the Republic (Central U.S.)





- A full-scale structure for youth education, national remembrance, and disaster relief housing
- 4. The Cross of the New World (West Coast Cliffside)
  - o A beacon-shaped illuminated cross overlooking the Pacific
- 5. The River of Tears Memorial (Mississippi River)
  - Honoring Native American, African American, and Christian martyrs
- 6. The Eternal Forge of Freedom (Midwest)
  - A monument to industry, revival, and regeneration, powered by renewable energy
- 7. The Angel's Watchtower (Alaska)
  - A remote observatory-military outpost modeled after medieval towers, defending the Arctic

# §1303. Local Sacred Sites Program

Each state will receive federal grants to:

- Restore sacred churches, mission houses, and historical revival locations
- Construct local wonders (mosaics, arches, fountains, chapels, towers) in capital cities
- Embed biblical inscriptions and founding American texts in public squares and buildings

# §1401. The Covenant Highways & Byways Redevelopment Act

# §1402. National Infrastructure Reconstruction Corps (NIRC)

- 5. Reinforce supply routes and strategic corridors for food, fuel, and defense





# §1403. Christian Rail Renaissance Program

- Restore traditional steam-style rail stations with stained glass, engraved Scripture, and patriotic art

# §1501. The Federal Civic Renewal Act (FCRA)

This Act establishes the National Program for the Restoration of American Governmental Architecture, which mandates the design, construction, and renovation of all federal buildings, embassies, and civic monuments to reflect the moral, spiritual, and historical essence of the American people.

# §1502. Sacred Architecture Restoration Program (SARP)

Mandates:





- All new and renovated Capitol buildings, courthouses, city halls, embassies, and military HQs must:
  - o Be constructed in neoclassical, Romanesque, Byzantine, or Gothic styles

- Construct new statues of:

  - o American martyrs for truth (MLK Jr., Lincoln, Bonhoeffer, etc.)

#### **New National Monument Sites:**

- 1. Mount Covenant A towering statue of Christ with an open Bible above the Appalachian range
- 2. The Gate of Rebirth A neoclassical archway at the U.S. southern border
- 3. The Garden of the Republic A central pilgrimage garden in the heartland for national reflection and prayer

# §1507. Design Councils and Moral Oversight

Establish the Civic Beauty and Sacred Order Commission (CBSOC):

- Comprised of theologians, classical architects, veterans, artists, and judges
- Oversees all federal projects for:





- Spiritual integrity
- Moral clarity
- o Historic continuity
- Aesthetic reverence

# **Legal & Philosophical Justification for Section XV**

#### 1. Scripture

# SECTION XVI – NATIONAL WONDERS, PILGRIMAGE TRAILS, AND THE CHRISTIAN-AMERICAN IDENTITY PARKS INITIATIVE

"They shall be called oaks of righteousness, a planting of the Lord for the display of His splendor."

(Isaiah 61:3)

§1601. National Wonders & Revival Monuments Act (NWRMA)





This section proposes the creation and restoration of national wonders across the United States that affirm the sacred identity, liberty, and moral mission of the American people under God.

#### §1602. Christian-American Identity Parks

The Department of the Interior shall designate 33 sacred heritage parks—one for each year of the life of Christ—spread across the regions of the United States.

#### Each park shall include:

- A chapel or open-air cathedral facing east, inscribed with Scripture and national mottos
- Monuments to the Founding Fathers, great revivals, abolitionists, missionaries, and military heroes
- Outdoor classrooms for teaching American history, natural law, and Christian worldview
- A Freedom Bell, to be rung at dawn and dusk
- Quiet trails and prayer groves with Psalms, Beatitudes, and the Sermon on the Mount etched along the path

# §1603. The Pilgrim Trail & National Covenant Road

A nationwide trail and road system modeled after the Camino de Santiago and Roman roads, connecting:

- 1. Plymouth Rock
- 2. Philadelphia (Liberty Bell)
- 3. Valley Forge
- 4. Washington, D.C.
- 5. Gettysburg Revival Hotspots (e.g. Cane Ridge, Azusa Street, etc.)
- 6. Appalachian Prayer Mountains
- 7. The Garden of the Republic (Heartland Prayer Garden)
- 8. Mount Covenant Monument (see §1506)





This system shall serve as both a pilgrimage of remembrance and a path of repentance—a physical act of spiritual national renewal.

#### §1604. Monuments of Remembrance and Repentance

Strategically placed across the country, the following major monuments shall be constructed:

- 1. The Monument of the Unborn A towering statue of a child in the womb surrounded by angelic figures
- 2. The Martyrs' Arch A neoclassical gateway bearing the names of Christians killed for their faith abroad
- 3. The National Family Altar In the Midwest, a monumental gathering space shaped like an open Bible, where families can pray together

# §1605. Youth Heritage Trails & Sacred Citizenship Curriculum

Youth programs shall be developed in partnership with:

- Christian schools
- Homeschool associations
- Churches and civic clubs

These national wonders and pilgrimage trails shall be built in harmony with:

- PARA highways, transit corridors, and new federal design zones

# §1607. Federal Funding and State Partnership

# §1701. Purpose

#### §2102. Public Media and Journalism Restoration Act

This Act ensures that artificial intelligence, machine learning systems, digital surveillance tools, and bio-technological enhancements serve the dignity, freedom, and spiritual wholeness of mankind—never replacing, enslaving, or dominating it.

#### §2202. Human Identity & AI Subordination Clause

1. Enshrine in federal law:

"A human being shall not be governed by a machine, algorithm, or artificial intelligence in any essential matter of life, liberty, or law."

- 2. Prohibit:
  - The use of AI judges, AI war commanders, AI child educators, and AI religious ministers
  - The creation of autonomous AI law enforcement or military entities
- 3. Require human oversight and override ability at all levels of AI deployment

  - o Construction labor priority for veterans on PARA projects
- 3. Veterans Civil Corps Program (VCCP)
  - Re-enlistment in civic service (education, logistics, emergency)

  - Veteran and family farm grant programs
- Urban Agriculture Expansion Act
  - Incentivize rooftop gardens, vertical farming, and community plots in cities

#### §3001. Legislative Purpose

### §3002. National Energy Independence Mandate

- Full Decoupling from OPEC, CCP & Hostile Entities

## §3101. Legislative Purpose

This Act establishes a moral economy grounded in biblical truth, constitutional order, and honest stewardship. It reforms money, banking, debt, investment, and national wealth under divine authority and public accountability.

#### §3102. Abolition of Usury & Reset of Illegitimate Debt Structures

- National Audit of All Federal Debt
  - Independent biblical review of all debts owed by the U.S. government to central banks, foreign entities, and private contractors
  - Any debt acquired via fraud, manipulation, war profiteering, or coercion to be nullified under the Jubilee Proclamation (Leviticus 25)
- National Sovereign Debt Reset
  - U.S. will reset debt obligations as part of a one-time biblical financial cleansing

## §3202. Regional Infrastructure Renewal Initiative (RIRI)

- National Infrastructure Mapping Authority (NIMA)

This act codifies the national identity under God, reclaims American education from ideological infiltration, and retools the arts and media to glorify truth, beauty, and liberty.

#### §3302. Reformation of Public Education Standards

- Abolishment of Federal Department of Education
  - Return full educational authority to the states under local and regional governance
  - Consolidate education oversight under State Boards of Moral and Scholastic Integrity
  - Replace Common Core and DEI frameworks with Classical, Civic, and Christian Curriculum Models (CCC-CM)
- National Standard for Core Civic Curriculum

#### §3401. Legislative Purpose

This Act replaces the exploitative debt-based economy with a Christian-capitalist model based on liberty, production, and stewardship.

#### §3402. Abolition of Predatory Financial Systems

- Dismantling Centralized Globalist Control
  - Audit and phase out the Federal Reserve's unconstitutional authority over the monetary system
  - Prohibit foreign ownership or investment in American currency issuance or control

This Act renews the ancient right of a people to self-defense, national identity, and divine sovereignty by restoring borders, enforcing biblical justice, and preserving the cultural and spiritual legacy of the Republic under Christ.





## §3502. Restoration of Borders and National Sovereignty

- Border Security Enforcement
  - Construct a comprehensive southern and northern border security system, blending physical walls, drone patrols, seismic detection, and human presence
  - Reinstitute and improve Remain in Mexico and expedited removal protocols
  - Designate the U.S. border as a protected national sanctuary under the Covenant Defense Doctrine
- Anti-Trafficking Command Task Force

# §3601. Purpose and Vision

To initiate a national, Christ-centered renaissance in infrastructure, public space, and civil planning that reflects order, beauty, resilience, and human dignity. This act aims to replace soulless industrialism with a culture of legacy: where roads lead to sanctuaries, monuments reflect divine glory, and American landscapes mirror heavenly order.

# §3602. National Survey and Land Mapping





- National Infrastructure Survey Bureau (NISB) created under Department of Christian Renewal to:
  - Identify decaying infrastructure and prioritize regions in moral, economic, and physical decline
  - Survey and map areas suitable for new wonders, federal buildings, research centers, and sanctuaries
  - Target former coal towns, Rust Belt cities, and rural Christian communities for development

#### §3603. Project Categories

#### II. PURPOSE:

To embed timeless beauty, sacred order, and advanced technology into America's physical, cultural, and spiritual infrastructure by integrating classical Christian architecture, urban design, and liturgical city planning with modern advancements in construction and environmental sustainability. This act aims to restore a God-honoring civilization that inspires the soul, uplifts the weary, and proclaims truth through form and function.

To revive America's spiritual vitality, local economies, and cultural unity through the establishment of national pilgrimage routes, sacred tourism hubs, and regional Christian heritage destinations. This act affirms the moral and economic benefit of sanctified tourism while protecting Christian history, celebrating regional virtues, and promoting unity under God.

# SECTION XLI- The American Family Prosperity & Childcare Equity Act

By reinforcing the foundational role of the family in national prosperity, this policy both restores biblical order and addresses bipartisan calls for family-centered economic reform.

#### **Provisions:**

- 1. Universal Child Tax Credit Expansion
  - Increases the child tax credit to \$5,000 per child for all working families, fully refundable.
  - Indexed to inflation and family income thresholds to encourage middle-class family expansion.
  - Immediate monthly pre-payments to families with dependents under 18.

  - Reduces federal income tax liability by 10% for married couples with three or more children.

  - Authorizes the creation of state-administered trust funds to support local pro-family initiatives, daycare vouchers, parenting classes, and resource centers.

# SECTION XLII -The Paid Family Leave & Caregiver Dignity Act

It extends support to new parents, elder caregivers, and those providing end-of-life care—rooted in the Christian ethic of honoring father and mother, protecting the vulnerable, and ensuring the dignity of labor in all forms.

#### **Provisions:**





#### 1. Federal Paid Leave Guarantee

- Mandates 12 weeks of paid family and medical leave per year for all qualifying employees.
- Covers birth, adoption, elder care, chronic illness, and terminal conditions.
- Reimbursed through a national leave trust, funded via payroll contributions (0.5%).
- 2. Caregiver Wage Credit
  - Establishes a \$4,000 refundable tax credit for full-time caregivers (family or professional) caring for dependents at home.
  - Expandable for multiple dependents or special needs cases.
- 3. Elder Care Housing Allowance
  - Provides monthly assistance for multigenerational homes caring for aging parents.
  - Encourages reintegration of elders into family life rather than institutionalization.
- 4. End-of-Life Compassion Grant
  - Federal hospice grant of \$2,000 for family-managed terminal care services.
  - Covers home medication, transportation, and chaplain visitation.

# SECTION XLIII- Affordable Housing & Ownership Restoration Act

A National Initiative to Make Homeownership Attainable Again for Working Americans

This act addresses the housing crisis facing millions of American families—especially first-time buyers, veterans, and young workers. It restricts foreign and institutional mass-buying of single-family homes, restores paths to ownership, and eliminates predatory taxation that threatens stable housing.

#### **Provisions:**





#### 1. Ban on Corporate Bulk Home Purchases

- Prohibits hedge funds, foreign entities, and real estate investment trusts (REITs) from purchasing more than 10 homes annually in a given zip code.
- Imposes graduated tax penalties for violations and enforces forced divestiture for monopolizing ownership.

#### 2. First-Time Homebuyer Sovereign Credit

- Offers up to \$25,000 in down payment assistance for U.S. citizens purchasing their first home in qualifying areas.
- Prioritizes veterans, married couples, parents, and public servants.

### 3. Abolition of Property Tax on Primary Residences

- Gradually phases out property tax for principal homeowners over 15 years, replacing revenue through fair-use utility assessments and land-based development incentives.
- Includes freeze protections for senior citizens and disabled individuals immediately.

#### 4. Homestead Sovereignty Protection Clause

- Enshrines the right to one primary dwelling per citizen to be protected from seizure except in the case of clear criminal forfeiture.
- Prevents excessive government liens or civil asset forfeiture of homesteads.

#### 5. Urban & Rural Restoration Zones

- Creates tax-free zones for home construction or renovation in economically depressed or historically significant regions.
- Utilizes faith-based and volunteer construction ministries as labor cooperatives (e.g. Habitat-style partnerships).

# SECTION XLIV -Digital Sovereignty & Citizen Data Protection Act

Securing the Digital Lives and Liberties of the American People in the 21st Century

#### Overview:

This section enshrines the right to personal digital privacy, sovereignty over biometric and behavioral data, and freedom from unauthorized surveillance or manipulation. It confronts abuses by big tech, foreign cyber actors, and domestic agencies, placing control of digital identity back into the hands of the citizen.

**Provisions:** 





#### 1. National Digital Sovereignty Bill of Rights

- Guarantees every citizen full ownership of their digital identity, behavioral metadata, and biometric imprint.
- Criminalizes the sale or use of such data without informed consent, enforceable by civil and criminal penalties.

#### 2. Abolition of Unauthorized Surveillance and Predictive Profiling

- Ends dragnet data collection by federal agencies without individual or court-issued warrants.
- Outlaws pre-crime predictive algorithms used by corporations or government to target users based on metadata.

#### 3. Decentralized Encrypted Identity Infrastructure

- Launches a sovereign, blockchain-based encrypted digital ID system under public control (not private tech monopolies).
- Allows users to store medical, educational, financial, and citizenship credentials securely and share them voluntarily.

#### 4. Ban on Biometric Surveillance in Public Spaces

- Prohibits AI facial recognition and biometric tracking in schools, grocery stores, churches, and public transit zones.
- Exception only permitted for high-security federal/military sites and declared emergencies.

#### 5. Mandatory Corporate Data Transparency Requirements

- Requires all digital platforms to clearly display what data is being collected, how it is used, where it is stored, and how to delete it.
- Corporations must offer a single-click data deletion tool for every account.

#### Implementation Strategy:





- Oversight Entity:
   A new office within the Department of Justice: Office of Digital Liberty and Civilian Sovereignty.
- Citizen Data Security Task Force:
  - Combines constitutional lawyers, Christian ethicists, technologists, and cybersecurity veterans.
  - Oversees all tech corporations operating within U.S. digital space.
- Digital Sabbath Initiative:
  - Encourages opt-in programs to help families unplug, fast from screens, and restore real human and spiritual connection.

#### **Legal & Moral Justification:**

# SECTION XLV- Pharmaceutical Integrity & Drug Price Stabilization Act

- Priority licensing and FDA fast-track for groups adhering to a "Hippocratic + Christian Ethics Pledge."

#### 4. Foreign Import Competition Streamlining:

- Allows vetted pharmacies in allied nations to ship lower-cost versions of U.S.-approved drugs to American consumers.
- FDA oversight ensures safety without bureaucratic delay.

#### 5. Permanent Ban on Pharmaceutical Corporate Lobbying and PACs:

- Pharmaceutical companies may no longer fund elected officials, parties, or regulatory board members.
- All past lobbying funds must be disclosed in a public federal database.

#### **Implementation Strategy:**





- Oversight Body: Replaces corrupt regulatory bottlenecks within the FDA with a citizen-led National Drug Pricing Ethics Committee.
- Veteran and Low-Income Patient First Access Program:
  - Distributes capped-cost or free essential medications to VA members, Medicaid users, and chronic illness patients.
- Annual Pharmaceutical Moral Audit:
  - Independent commission evaluates company behavior, transparency, and ethical manufacturing practices.
  - Bad actors banned from federal contracts.

It restores medical billing sanity, cracks down on price inflation, and retthe system to a human-centered model—grounded in Christian ethics and the Constitution's guarantee of justice and general welfare.	
Provisions:	





#### 1. National Cap on Medical Procedure Pricing:

- A federal board of physicians, economists, and clergy will cap the prices of standard procedures, surgeries, and emergency care.
- Price ceilings will be based on average regional income and actual operating costs—not insurance padding or inflated administration.

#### 2. Mandatory Medical Price Transparency:

- All hospitals, doctors, and insurance companies must display full, upfront pricing for procedures, medicines, and services online.
- Surprise billing and undisclosed charges are outlawed.

- Funds are redirected to a new "National Health Relief Trust" for free clinics, veterans' treatment, and rural hospitals.

#### 5. Christian Charity Incentive Clause:

- Healthcare organizations offering free care to the poor, veterans, and clergy will receive full tax forgiveness and grant access.
- Incentives to religious medical missions, Christian counseling services, and healing ministries providing legitimate public benefit.





- 6. Prohibition of Lobbying by Medical Institutions:
  - Insurance companies, hospital systems, and Big Pharma may no longer fund lobbying, PR campaigns, or political PACs.
  - Full financial audit of medical lobbying expenditures from 1990 to present.

MedPricing.gov:

New federal platform displaying every medical service cost nationwide, with regional benchmarks and fair market values.

- Healthcare Worker Compensation Bonus Program:
  - Redirects inflated CEO pay and administrative bloat into nurse and doctor salary raises in underserved regions.
- Audit & Seizure Clause:
  - If a hospital group refuses to comply, the federal government may revoke licensure, seize property, and reassign operations to nonprofit Christian hospital trusts or regional public institutions.

# SECTION XLVII -Healthcare Renewal and Technological Healing Advancement Act

(Affordable Healing for Every American through Christian Innovation and Ethical Medical Investment)

#### Overview:

This section enacts a national renewal of healthcare delivery through two major avenues: (1) strategic investment into advanced medical technologies such as regenerative "med beds" and non-invasive healing treatments, and (2) the broad rollout of affordable, accessible health centers for rural, urban, and underserved populations—grounded in biblical mercy and national health security.

We will not let disease, decay, or despair dominate the land while profits soar and the poor suffer. America will lead the world in healing—by Christ's example, with reason, integrity, and compassion.

#### **Provisions:**





- 1. National Research & Development Fund for Healing Technologies:
  - \$100 billion 10-year investment into regenerative technologies, tissue repair, non-invasive med beds, and cancer-curing innovations.
  - Focused partnerships with Christian universities, Department of Veterans Affairs, and defense medical researchers.
  - Strict bioethical oversight board formed to ensure no transhumanist, AI-integrated, or soul-harming technology is permitted.

#### 2. Creation of "Covenant Health Centers" Nationwide:

- Every county will receive at least one state-funded clinic using advanced technology for diagnostics, emergency care, and recovery.

This section secures America's lifeblood—its power grid—by aligning technological innovation, military coordination, civilian resilience, and biblical stewardship.

To safeguard democracy, protect children, uphold the First Amendment, and ensure an informed electorate, this act mandates the dismantling of corrupt media monopolies, the restoration of publicly accountable news broadcasting, and the construction of Gospel-informed communication systems for the modern age.





#### **Provisions:**

# 1. Dismantling Media Monopolies:

- Launch antitrust investigations into major media conglomerates (e.g., Disney, BlackRock-backed outlets, Big Tech ownership groups).
- Enforce divestment and decentralization to restore market competition.
- Criminal liability for willful coordination between media and intelligence agencies without congressional approval.

# 2. Public Broadcasting Renewal & Christian Media Expansion:

- Reestablish a revitalized PBS-equivalent: The American Restoration Network (ARN).
- Include Gospel-centered shows, historical documentaries, American civics, and veterans' programs.
- Christian schools and homeschool networks granted access to curriculum-based content studios.

#### 3. Children's Media Protections:

- Ban sexual, occult, violent, or identity-sabotaging content in children's programming.

As AI evolves at a pace faster than human legislation can track, we face the threat of a future ruled not by elected leaders or moral conscience, but by unaccountable algorithms, predictive control, and digital enslavement. This act asserts that digital life must remain subordinate to human dignity, Christian moral order, constitutional liberty, and national sovereignty.

#### **Provisions:**

- 1. Sovereign Digital Infrastructure & AI Safeguards:
  - Prohibit foreign entities, especially adversaries, from ownership stakes in American data pipelines, AI companies, and tech critical to elections or defense.





- Federalize a sovereign National Algorithm Registry that catalogs, audits, and restricts AI models used in health, law enforcement, media, and finance.
- Ban "black box" AI in government—any system that cannot explain its decisions is outlawed from public use.

# 2. The Humanity Clause:

- No AI may impersonate a human being or simulate identity to deceive.
- o Mandatory labeling of all AI-generated speech, writing, images, and video.
- Human consciousness and the imago Dei (image of God) are declared non-replicable under federal law.
- o Ban on AI "companions," "therapists," or digital priests targeting minors.

## 3. Digital Bill of Rights for Citizens:

- Right to opt out of surveillance by private or public entities.
- Right to access and delete one's digital footprint.
- Right to a "manual alternative" for essential services (e.g., medical care, voting, licenses).

# 4. Emergency Cutoff Protocols:

- All AI systems integrated into public infrastructure (e.g., energy grids, water, defense) must include offline emergency overrides under human control.
- Department of Homeland Security to build and train EMP/digital warfare response units.

# 5. Palantir & Skynet Prohibition Clause:

Mental health infrastructure will be elevated as a national defense and community protection priority.

#### **Provisions:**

- 1. Veteran-Centered Mental Health Command:
  - Establish a dedicated National Mental Health Command Center (NMHCC) under the VA in partnership with the Department of Defense.
  - Deploy mobile and permanent Resilience Hubs in every state—facilities staffed with trauma-informed clinicians, spiritual counselors, combat trauma specialists, and peer veterans.





# 2. First Responder & Trauma Recovery Initiative:

- Expand programs for firefighters, EMTs, police officers, and dispatchers to receive mental health services without stigma or career penalty.
- Partner with Christian counseling groups, trauma recovery programs, and non-profits to provide integrative healing.

## 3. Spiritual & Moral Recovery Component:

- Chaplain corps and faith-based trauma counselors included as mandatory team members at all VA mental health centers.
- Allow veterans to opt for faith-based treatment tracks—including prayer therapy, Christian meditation, and Scripture-based group work.

## 4. Community Prevention & Education Measures:

- Public school curriculum to include mental resilience, suicide awareness, and veteran appreciation training.
- o Create a National Day of Healing & Resilience recognized across states.

#### 5. Civilian Crisis Access:

- Extend some veteran mental health services to civilians in underserved or high-trauma zones (e.g., post-disaster, high-crime, or impoverished communities).
- o Partner with church coalitions for outreach and support networks.

This legislation ensures the safeguarding, modernization, and fortification of the U.S. power grid against all forms of attack—including electromagnetic pulse (EMP) events, cyber warfare, and nuclear disruption. As a backbone of national infrastructure, the electrical grid must be treated as both a civilian necessity and a strategic homeland defense asset.

#### **Provisions:**

- 1. Comprehensive Power Grid Audit & Resiliency Upgrade:
  - Mandate a national audit of the entire U.S. energy grid through the Department of Energy in coordination with the Department of Defense and DHS.
  - Upgrade outdated transformers, substations, and transmission lines with hardened EMP-resistant technologies.
  - Introduce a multi-tiered black-start capacity in each region to ensure rapid restoration in case of system-wide collapse.
- 2. National Electromagnetic Defense Shield (NEDS):





- Develop a network of Faraday-protected infrastructure zones for critical facilities: hospitals, command centers, military bases, and water treatment plants.
- Implement regional underground fallback grid systems in cooperation with the U.S. Army Corps of Engineers and strategic state partners.

# 3. Public & Private Sector Grid Partnership Program:

- Require major private utility providers to submit EMP resilience compliance plans.
- Offer federal matching grants for rural electric cooperatives and state grids willing to modernize and integrate national standards.

# 4. Space & Solar Weather Monitoring Initiative:

- Expand partnerships with NASA, NOAA, and Space Force to detect solar flares, coronal mass ejections, and other high-risk natural events.
- Establish an early-warning grid impact system across key infrastructure corridors.

## 5. Civilian Protection & Education Plan:

 Issue civilian resilience kits with grid failure guidelines and emergency power protocols to households and businesses.
 Launch a national awareness campaign titled: "Power to Preserve: The Grid is Sacred."

# SECTION LV -Insider Trading Prohibition & Financial Transparency Act (ITPFTA)

#### Overview:

This act criminalizes insider trading among elected officials, public servants, and corporate leaders with national security access. It mandates real-time disclosure of all stock and investment activity by high-ranking individuals and bans members of Congress from holding individual stocks tied to national policy outcomes.

#### **Key Provisions:**

- Full divestiture of conflict-prone securities by all federally elected officials within 90 days.
- Creation of the Federal Financial Conduct Authority (FFCA) to monitor and prosecute infractions.
- Public real-time tracking of official trading activity via OpenLedgers.gov.
- Whistleblower protections and rewards for internal financial ethics reporting.

#### **Justification:**

- Exodus 23:8 "You shall not accept a bribe, for a bribe blinds the clear-sighted."
- Article I, Section 6 of the Constitution *Prevents legislative profiteering from public service.*
- Federalist No. 57 Warns against the elite insulating themselves from the laws they pass.





# SECTION LVI -Sovereign States Artificial Intelligence Governance Act (SSAIGA)

"The Lord God formed man of dust from the ground and breathed into his nostrils the breath of life." — Genesis 2:7

#### Overview:

Affirms the sovereign right of U.S. states to regulate, license, and restrict AI development within their jurisdictions in alignment with the PARA human dignity clause (Section XXVII). It forbids any federal mandate that compels the deployment of AI in areas of life, health, education, or justice without state approval.

#### **Key Provisions:**

- Enables states to establish State AI Ethics Boards.
- Prohibits federal surveillance AI systems from operating within states without legislative consent.
- Protects analog and human-run institutions from forced automation.
- Declares human consciousness and personhood non-replicable by machines, legally and morally.

# Justification:

- Psalm 115:4-8 "Those who make idols become like them, and so do all who trust in them."
- 10th Amendment of the Constitution Reserves powers not delegated to the federal government to the states or people.
- Natural Law Doctrine Upholds the ontological uniqueness of human beings.





# SECTION LVII -Responsible Fiscal Stewardship & Debt Limit Reform Act (RFSDRA)

"Owe no one anything, except to love each other." — Romans 13:8

#### Overview:

Reconstructs how America manages its national debt ceiling by replacing crisis-based votes with a long-term fiscal glidepath plan. It aligns national spending with moral priorities—such as defense, infrastructure, and care for the vulnerable—and caps discretionary increases to protect future generations.

## **Key Provisions:**

- Establishes a Balanced Budget Principle to anchor debt growth to real GDP.
- Mandates a 10-year plan to reduce debt-to-GDP ratio below 70%.
- Creates a bipartisan Debt Tribunal to monitor Congress's compliance.
- Outlaws emergency debt ceiling suspensions without a supermajority and moral justification.

#### **Justification:**

- Proverbs 22:7 "The borrower is slave to the lender."
- Article I, Section 8 Empowers Congress to borrow responsibly, not recklessly.

# SECTION LVIII - Christian Financial Order & Sovereign Economic Foundations Act (CFO-SEFA)

"The silver is mine, and the gold is mine, saith the Lord of hosts." — Haggai 2:8

#### Overview:

This act restructures America's economic system upon the foundational principles of biblical stewardship, national sovereignty, moral productivity, debt relief, and honest currency. It acknowledges that economic policy must be rooted not only in fiscal logic but in divine order, ensuring that money no longer serves Mammon but glorifies God, provides for the people, and restores balance to the marketplace.

# **Key Provisions:**

- 1. Reinstatement of Sound Money Standards
  - Launches a U.S. Strategic Gold & Resource Reserve Board for sound commodity-backed policy.
  - Evaluates the de-pegging of the U.S. dollar from purely fiat systems over 10 years.

  - o Overseen by a Council of National Chaplains and Economic Witnesses.

# SECTION LVIX -Rural Revival & Suburban Renewal Act (RR-SR Act)

"And they shall build houses and inhabit them; and they shall plant vineyards and eat the fruit of them." — Isaiah 65:21

#### Overview:

This section initiates a bold national program to revitalize America's rural and suburban regions—restoring dignity, infrastructure, employment, agriculture, and housing access to the forgotten counties of the United States. These zones will be transformed into hubs of productivity, beauty, family life, and spiritual communion, protecting their identity while opening opportunity.

#### **Key Provisions:**

- 1. National Homesteading & Land Grant Program
  - Revives the American Homestead ideal, offering eligible families land grants for farming, development, and community building.
  - Partnerships with local churches and co-ops for training and support.
- 2. Faith-Based Rural Infrastructure Zones
  - Establishes sacred design guidelines for small towns—reviving church-centered layouts, village greens, and walkable communities.
  - Provides funding for essential infrastructure: clean water, roads, schools, broadband.
- 3. Agricultural Regeneration & Permaculture Expansion
  - Reintroduces soil restoration, livestock rotation, and biblical farming principles.





• Promotes family-owned farms, Christian agrarian guilds, and vertical farm innovation in small towns.

# 4. Housing Restoration & Mortgage Justice Act

#### Overview:

This Act establishes a robust national framework for youth civic engagement, faith-centered education, and skilled apprenticeship, designed to instill Christian values, national pride, economic productivity, and disciplined leadership in the next generation.

America's youth must not be left to wander without direction. This initiative reclaims their path—uniting classroom learning, trades, biblical literacy, and military-civil service under one banner: duty to God and country.

# SECTION LXI- THE SMALL BUSINESS REVIVAL & MAIN STREET ACT

#### Overview:

This section establishes a national system of protection, funding, and empowerment for local small businesses, artisans, tradesmen, and entrepreneurs—with a particular emphasis on faith-based business ethics, family ownership, and Main Street over Wall Street. Small businesses are the lifeblood of American culture and community—they must not be crushed by bureaucratic giants.

#### **Key Provisions:**

This section establishes a comprehensive national strategy for research, technological development, and knowledge innovation that is firmly grounded in Christian ethics, natural law, and divine order. America must become the foremost light of wisdom, invention, and sacred advancement—not in pursuit of transhumanist domination, but in service of God and the common good of mankind.

This is the revival of the Renaissance in modern form: a Biblical-technological alliance for the cultivation of holy knowledge, human flourishing, and eternal truth.

#### **Key Provisions:**

- 1. The Christian Research Network (CRN)
  - Establishes a decentralized national institute of faith-aligned scientific, historical, theological, and medical research.
  - Includes disciplines such as:
    - Biblical archaeology
    - Energy and sound physics
    - Regenerative medicine and anti-aging technologies (within ethical bounds)
    - AI safeguards and logic of the soul
    - Sacred architecture and acoustics
