READING THE ACTIVITY CALENDAR

There is a method to reading a CAS calendar, so let us help you... **The first activity listed** for the day is open to all CAS students and is directed by a staff member. This activity often encompasses one of our six enrichment areas. Those enrichment areas include: 1. Science & Nature, 2. Building, Transportation & Engineering, 3. Math & Literacy, 4. Drama, 5. Music, and 6. Social Emotional Learning. There is at least one activity in EACH of these enrichment areas EVERY month!

The second activity listed is also open to all CAS students. Staff members will be sure all the supplies needed for these activities are available and then the children will be able to work on them independently.

The third activity listed is available to those CAS students in 4th or 5th grade, and will be set up in a different area, directed by a staff member. These activities are a bit more challenging and are planned specifically for our older age group. While we recognize that many of our younger students are eager and capable of participating, we also understand that our older students are becoming more independent. The "Older Kid's" space and activity is a privilege exclusively for those in 4th & 5th grades. We hope our younger groups look forward to having this privilege soon!

The final activity listed is open to all CAS students, and is our structured physical activity. While everyone enjoys physical play during one of our free-play times, this activity is similar to PE Class.

IMPORTANT TUITION INFORMATION

Tuition payments are due on the first of the month, September through May. The next tuition due date is September 1st. Please be aware that there will be a **\$25 late fee** for any payment that is not received by 6 PM on the 8th of the month. The complete late payment policy is available on pages 18 & 19 of the Parent Handbook.

RELEASE AT PICK-UP

Please let us know whenever someone else is picking up your child. Unless they are listed on your forms, we cannot release your child. This policy is an important safety measure and can cause a great deal of inconvenience when we are not informed. Please help us avoid these situations by making sure that everyone who may pick up your child is listed on your forms and by informing us when someone different will be picking up your child. Please remind them to have their photo I.D. ready.

NO CELL PHONES



CAS respectfully asks that you finish your communications before entering the building. It is important for you to greet your children upon arrival and ask about their day. Additionally, CAS staff members often have information to share with parents.

MEDICATION POLICY



Due to storage requirements, we ask that all medication and vitamins be given at home. If this is not possible, or in the case of emergency medication such as Epi-Pens and Inhalers, the CAS staff may administer medication once a Medication Form is on file at CAS. Forms and information are available on-site or on the CAS website at careafterschool.com/health-condition-info.

A form must be completed and on file before any medication can be given.

WITHDRAWAL POLICY

Please remember to notify CAS by the 15th of the month to withdraw your child from the program for the following month. No refunds will be made for withdrawal from the program. If notice of withdrawal is not given by the 15th of the month, half of the next monthly payment is required. If you wish to withdraw, send an email to info@careafterschool.com.

CHANGES & UPDATES

PERSONAL INFORMATION UPDATES:

Please let us know whenever there is a change in information on your child's registration form (phone number, place of employment, etc.). Leave a note or email your Site Director or our office at info@careafterschool.com.

DAYS OF ATTENDANCE:

Please notify CAS by the 23rd of the month if you need to request a change to your days of attendance. Changes will be made if space in the program permits and will be effective the first week of the following month. Send an email to info@careafterschool.com to request a change in enrollment status.

COMMUNICATIONS: most program-related communications will come to you through the Brightwheel app. You can communicate directly with your Site Director through the Brightwheel app as well, for things like absences and changes to pickup routines. The administrative office will continue to communicate through email in addition to Brightwheel for things such as enrollment changes, withdrawals, and payment issues. Please be sure emails from info@careafterschool.com go to your inbox.

COLD WEATHER PLAY: Please read the temperature guidelines below, as Care After School has made changes to the previous specifications.

- **Specific Temperature Guidelines (all according to “real feel” temperatures which factor in the wind chill):**



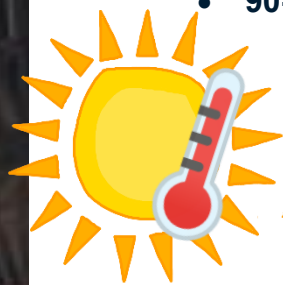
- **50-59 degrees:** Jacket and/or long sleeves recommended.
- **40-49 degrees:** Coat and long pants recommended.
- **32-39 degrees:** Coat and long pants required.
- **25-31 degrees:** Winter Coat and long pants required. Hats and mittens recommended.
- **15-24 degrees:** Winter Coat, long pants, hats and mittens required.
- **Below 15 degrees:** Outdoor play is prohibited.



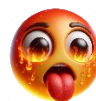
- **Snow Play: Children are permitted to play in snow if the following conditions are met:**
 - All temperature guidelines above are met
 - Exposed skin does not come in contact with snow
 - Children must have snowsuit & boots while outside, or a change of pants, shoes and socks once back indoors.

HOT WEATHER PLAY: Please read the temperature guidelines below, as Care After School has made changes to the previous specifications.

- **Specific Temperature Guidelines (all according to “real feel” temperatures which factor in the heat index):**



- **Above 95 degrees: Outdoor play is prohibited**
- **90-95 degrees:**
 - Outdoor play time is shortened to a maximum of 20 minutes, with at least 30-minute intervals between outdoor play sessions.
 - Water is taken outside and children have access to it at all times.
 - Children are permitted to go inside upon request.
 - Children with heat sensitivity including, but not limited to, those with asthma, allergies, epilepsy, etc. will not be permitted to play outdoors.



- **Air Quality:**

0-50: Outdoor play permitted
51-100: Outdoor play permitted
101-150: Follow same guidelines as when temperatures are 90-95 degrees.
151-Above: Outdoor play prohibited
