Minutes of the Brown Township Board Meeting, September 26th, 2024

The Pledge of Allegiance was said.

Shari O'Riley called the meeting to order.

Old Business:

The meeting minutes from September 12th, 2024, were approved and signed.

New Business:

Resolution 2024-7 Budget. Mr. Murphy made a motion to approve the resolution. Mr. Rogers seconded. Resolution 2024-7 was approved and signed.

Mr. Murphy asked that item #5 and item #6 be switched on the agenda.

Mr. Murphy mentioned the upcoming joint meeting. He also brought up our LIT amount. He asked Mrs. Delp about what she was going to propose at the joint meeting. She explained that Mr. Murphy could vote however he liked. Mr. Murphy brought up the resolution he wanted to pass.

Mrs. Delp stated that Mr. Murphy is not able to propose a resolution himself. She explained that she spoke with an attorney and that it is not how the board works. She stated he is welcome to get his own attorney or speak to the state legislatures.

Mr. Murphy read the resolution that he personally wrote.

Mrs. O'Riley reminded everyone about the joint meeting coming up. She also stated that the HOA's in Brown Township will be notified with information and upcoming meetings can also be found on our website. She wanted to ensure the citizens that their concerns from last meeting were being taking into consideration.

Citizens Comments

John Patton (10812 E. Co. Rd. 750 N) stated that he held a meeting with local HOA presidents to help start spreading information.

Debra (?) asked how hard she was going to get hit with taxes. Mrs. Delp told her to call the office and they could discuss it. She then asked when the annexation would be decided. Mrs. Delp said there was nothing going on with it right now. She then asked if the annexation goes through, the property taxes would go up and they would lose their fire station. She asked what the benefit is to Brown Township. Mrs. Delp stated that nothing is to that point yet and no data has been gathered yet. Mrs. Delp explained the process of how that works.

Patti West (10665 N. St. Rd. 267) stated that Next Door should be used for communication for her personally.

John Hibbard asked how the rest of the board would vote for Mr. Murphy's resolution. Mrs. O'Riley stated that she did not have any information regarding Mr. Murphy's resolution. Mrs. O'Riley said she will not be commenting on it. Mr. Hibbard asked how long it takes to gather the information

they (Mrs. O'Riley and Mr. Rogers) need to make a decision. Mr. Hibbard then continued to share his opinions.

Mr. Patton stated that Mrs. Delp is doing her job, and the board is doing their job.

Mr. Hibbard and Mr. Patton continued to go back and forth. Mr. Patton stated that the resolution is premature.

Mr. Murphy stated that there is no annexation. He then explained that the tax increase is to pay the fire fighters which will be discussed Monday. He then mentioned that there is a merger being pursued by Mrs. Delp and there is also a consolidation.

Debra (?) stated that the tax increase will affect them. Mrs. Delp and Debra discussed the upcoming joint meeting.
