Online Scheduler:

PJC uses a public platform, **PlayTime Scheduler**, to coordinate play among its members at our various venues. This app lets you see who is playing where and when, receive ‘**Alerts**’(updates), add notes, etc. There is a one-time, free registration to set up an account. Use the ‘Demo’ and/or ‘Help’ menus to learn more. Once registered, it is simple to see who is playing when, and where.
