NOTICE OF INTENT TO FILL COUNCIL MEMBER VACANCY BY APPOINTMENT

The City of Panorama Park has a vacancy for City Council as of July 13, 2023, due to the resignation of Christopher Gilbert and his subsequent appointment as Mayor. Pursuant to Section 372.13, (2), (a) of the Code of Iowa, notice is hereby given that the City Council of Panorama Park, Iowa, intends to fill this vacancy by appointment during their next regular city council meeting that will be held at city hall at 7:00 PM on Thursday, August 10, 2023. However, the electors of the City of Panorama Park have the right to file a petition requiring that the vacancy be filled by a special election. If electors wish to require a special election, a valid petition requesting a special election must be filed with the city clerk within fourteen days after publication of this notice or within fourteen days after the appointment is made. If no such petition is filed, the appointment shall be for the period until the next pending election as defined in Section 69.12 of the Code of Iowa. Eligible electors of the City of Panorama Park, Scott County, Iowa, wanting to be considered for appointment should submit a request in writing to the City Clerk's office by 4:00 PM on Monday, August 7, 2023.

Published upon order of the Panorama Park City Council. The Mayor and City Clerk are authorized and directed to post notice of this at least once, not less than four nor more than twenty days before the date of the meeting in the three public places per Code of Ordinances, Panorama Park, Iowa, Chapter 18, Section 18.05 [2].

3. MAYOR NOMINATION AND APPROVAL

Christopher Gilbert resigned as city council member and mayor pro tem. *Christopher Gilbert was* nominated as Mayor by S. Rice and seconded by S. Perry. Roll Call: T. Huber. Christopher Gilbert was approved as the next Mayor for the City of Panorama Park, Iowa and sworn in by City Attorney Jeff McDaniel. C. Gilbert's resignation leaves the city with one council vacancy. The position may be filled by appointment in compliance with Section 372.13, (2), (a) of the Code of Iowa.
