The City Council of Panorama Park, Iowa met in regular session on Wednesday, April 10, 2019 in the City Hall at 6:00 p.m.

#### Call to Order

Mayor Rice called the meeting to order at 6:15 p.m. A quorum was reached.

#### **Agenda Approval**

Mayor Rice asked if there were any questions on the agenda and hearing none, asked for a motion to approve. A motion was made by Mandi Lauritzson, seconded by Jacque Krause to approve the Agenda as presented. With no further discussion, Roll Call: Beth Elmore – aye. Agenda was approved.

#### **Public Comments to the Council**

No comments from the public.

#### Mayor's Report

- Mayor Rice said he had compiled a report showing the CD's by fund and maturity dates.
- Mayor Rice said since the weather has improved, he would again reach out to the Scott County Sheriff's office for setting up a speed check.

#### **Committee Reports**

Council Member Lauritzson, Public Works & Roads Committee, reported that she had not heard back from the Bettendorf City Engineer regarding the condition of North Street outside the city limits. Lauritzson said she would follow up with the City Engineer. No other committees reported.

#### **New Business**

- 1. Discussion and approval of Council meeting minutes from March 20, 2019. Mayor Rice asked if there were any questions or corrections to the minutes. Hearing no other comments, he called for a vote. A motion was made by Krause and seconded by Lauritzson to approve the March 20, 2019 meeting minutes as presented. With no further discussion, Elmore –aye, motion was approved.
- 2. Discussion and approval of expenses. Council members reviewed expenses. Mayor Rice asked if there were any questions, and hearing none, called for a vote to approve expenses. A motion was made by Krause and seconded by Elmore to approve expenses as presented. With no further discussion, Lauritzson aye and motion was approved.

- 3. Discussion and approval of monthly Financial Statements. Council members reviewed the financial statements. Mayor Rice asked if there were any questions, and hearing none, called for a vote to approve the Financial Statements as presented. A motion was made by Krause and seconded by Lauritzson to approve the Financial Statements as presented. With no further discussion, Elmore- aye and motion was approved.
- 4. First reading, discussion and approval of the revised City of Panorama Park Sewer Service Charges, Chapter 99, 99.02 Rate, Code of Iowa, Sec. 384.84. Mayor Rice said the City of Davenport had notified all cities on their system that they had revised their sewer ordinance and requested cities to adopt it. Mayor Rice is further reviewing sections that do not pertain to the City of Panorama Park such as industrial sections. The revision before the council tonight is to repeal and replace one section, Article 99.02, Rate Each customer shall pay sewer service charges in the amount of \$25.00 per month and replace with "The regular residential monthly sewer service charges of \$25.00 shall be suspended indefinitely, effective July 1, 2019. Property owners shall be responsible for any unpaid sewer service charges incurred prior to July 1, 2019." Mayor Rice said another announcement for the change in the ordinance, will be inserted in the next sewer bill. If there are no comments from the public at the next meeting for the second reading, the council may vote to suspend a third reading of the ordinance. Mayor Rice asked if there were any questions and hearing none, asked if there was a motion to approve. A motion was made by Krause and seconded by Lauritzson to approve the repeal and replacement of Article 99.02 as presented. With no further discussion, Elmore- aye and motion was approved.

With no other business before the Council, the meeting was adjourned at 7:17 p.m.

## MODIFICATION OR CHANGE OF EXISTING ORDINANCE ORDINANCE NO. 99.02

AN ORDINANCE AMMENDING THE CODE OF ORDINANCES OF THE CITY OF PANORAMA PARK, IOWA, BY AMENDING PROVISIONS PERTAINING TO SEWER SERVICE CHARGES

**BE IT ENACTED** by the City Council of the City of Panorama Park, Iowa:

**SECTION 1. SECTION MODIFIED.** Section 99.02 of the Code of Ordinances of the City of Panorama Park is repealed and the following adopted in lieu thereof:

**99.02 RATE.** The regular residential monthly sewer service charges of \$25.00 shall be suspended indefinitely, effective July 1, 2019. Property owners shall be responsible for any unpaid sewer service charges incurred prior to July 1, 2019.

**SECTION 2. SEVERABILITY CLAUSE.** If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

**SECTION 3. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
