The City Council of Panorama Park, Iowa met in regular session on Wednesday, June 6, 2018 in the City Hall at 6:30 p.m.

Council Members Present: Beth Elmore, Jacque Krause, Mandi Lauritzson, Shawn Rice, and David White **Council Members Absent:** None **Presiding:** Mayor Ronald Rice

Call to Order

Mayor Rice called the meeting to order at 6:30 p.m. The meeting was delayed from 6:00 p.m. due to a private event in the City Hall building. A quorum was achieved.

Consent Agenda

Council members reviewed the Financial Reports for the period ending May 31, 218. Mayor Rice asked if there were any questions, and hearing none, asked for a motion to approve the consent agenda which included the June 6, 2018 Agenda, May 15, 2018 Special Council Meeting Minutes, and Financial Reports for period ending May 31, 2018.

A motion was made by Council Member Rice, seconded by Lauritzson to approve the Consent Agenda as presented. With no further discussion, three ayes and zero nays, Consent Agenda was approved.

Presentations

There were no presentations.

Public Comments to the Council

Four residents were in the audience, but no one requested to comment to the Council.

Unfinished Business

 Resolution 2018-14 authorizing Mayor Rice to open a credit card account with Wells Fargo Bank. Mayor Rice met with a Wells Fargo Bank representative about a credit card account. Mayor Rice said Wells Fargo recommended authorized persons have separate credit cards rather than one card used by all. Mayor Rice said that spending limits could be set on the cards. Council members discussed the recommendation and other options and agreed that a credit card account should be opened with Wells Fargo Bank with Mayor Ron Rice as an authorized user.

A motion was made by Krause and seconded by Elmore to approve Resolution 2018-14 authorizing Mayor Ron Rice to open a credit card account for the City of Panorama Park with Wells Fargo Bank. With no further discussion, three ayes and zero nays, motion was approved.

2. Council members further discussed the approved City of Panorama Park credit card account with Wells Fargo Bank, and agreed to add Mayor Pro-Tem David White as an authorized credit card user.

A motion was made by Krause and seconded by Elmore to approve Mayor Pro-Tem David White as an authorized user for the approved credit card account for the City of Panorama Park with Wells Fargo Bank. With no further discussion, two ayes and zero nays, motion was approved. Mayor Pro-Tem White recused himself.

3. Council members discussed complaints by residents for several properties in Panorama Park that are in violation of City ordinances. Council Member Rice said she had been contacted by resident 5734 Valley Drive about the upcoming 'Big Trash' pick up day and if they could have a trailer set out with large items. Council Member Rice said she would contact the vendor and confirm if this would be acceptable.

Mayor Rice provided communications from Attorney Jeff McDaniel regarding delinquent sewer payments for 106 6th Street, and junk vehicles on property at 5734 Valley Drive.

4. Council members discussed adding speed bumps along Park Avenue, tabled at the last meeting. Mayor Rice said a compromise could be to place one permanent, table-type speed bump with required warning signs instead of three spread along Park Avenue. Council members discussed what type of speed bump would be better suited to Park Avenue.

A motion was made by Krause and seconded by Council Member Rice to approve installing one speed bump, with type to be determined, on Park Avenue near 7th Street. With no further discussion, zero ayes and three nays, motion was defeated.

- 5. Council members discussed purchase of new carpet for City Hall. Samples from local vendor Dave's Floor Trends were viewed. The carpet will be square tiles, which will be easier to replace if stained or soiled. Council members also viewed similar samples from online vendors and agreed that the samples were not comparable in quality to the local vendor's. A motion was made by Lauritzson and seconded by Krause to approve purchase of carpet with installation from Dave's Floor Trends. With no further discussion, three ayes and zero nays, motion was approved.
- 6. Council members discussed the installation of a 'brick' cement product for the lower front façade of City Hall. A small sample was available for Council members to view. Council members agreed the 'brick' would dress up the front of City Hall and make it less 'garage' like.

A motion was made by Krause and seconded by White to approve purchase of the 'brick' cement product for the lower façade for City Hall. With no further discussion, three ayes and zero nays, motion was approved.

7. Council members discussed the pros and cons of entering into a contract with a realtor to facilitate the sale of the city-owned vacant lot located SW of the intersection of Park Avenue and 2nd Street (parcel 841349201). Mayor Rice provided communication from the City Attorney, Brooks Law Firm, with their advice on proceeding with the sale through a realtor. City Council members discussed the recommendations and agreed to proceed with posting a 'for sale' sign on the lot and also placing a notice in the Quad City Times for 30 days to gauge interest in the property.

A motion was made by Krause and seconded by Lauritzson to approve posting a 'for sale' sign on the city-owned vacant lot located SW of the intersection of Park Avenue and 2nd Street (parcel 841349201), and place a notice in the Quad City Times for 30 days. With no further discussion, three ayes and zero nays, motion was approved.

New Business

1. Resolution 2018-18 authorizing Mayor Rice to close the First Central Bank savings account and reinvest the funds with Great Southern Bank.

A motion was made by Council Member Rice and seconded by Elmore to authorize Mayor Rice to close the First Central savings account with a balance of \$75,339.95, and reinvest the funds with Great Southern Bank. With no further discussion, three ayes and zero nays, motion was approved.

2. Mayor Rice provided the Council members a brief overview of how a purchase of Quickbooks Online accounting software would save time and money in the long run. Council members discussed the pros and cons of purchasing such software. Council members agreed to purchase software to allow for three users.

A motion was made by Council Member Rice and seconded by Krause to authorize Mayor Rice to purchase Quickbooks Online accounting software. With no further discussion, three ayes and zero nays, motion was approved.

- 3. Council Member Rice noted that checks and envelopes to be used with Quickbooks would need to be purchased. *A motion was made by Council Member Rice and seconded by Elmore to authorize Mayor Rice to purchase checks and envelopes to use with the Quickbooks Online accounting software. With no further discussion, three ayes and zero nays, motion was approved.*
- 4. Council members discussed purchasing a paper shredder for City Hall. A motion was made by Krause and seconded by Lauritzson to authorize purchase of a paper shredder. With no further discussion, three ayes and zero nays, motion was approved.

5. Council Member Rice requested that two additional folding tables for City Hall be purchased for event use with funds from the Culture and Recreation account.

A motion was made by Krause and seconded by Laurtizson to authorize purchase of two additional tables. With no further discussion, three ayes and zero nays, motion was approved.

6. Council Member Rice requested six stackable chairs for seating tables be purchased for the additional tables with funds from the Culture and Recreation account.

A motion was made by Krause and seconded by Elmore to authorize purchase of six stackable chairs for the additional tables. With no further discussion, three ayes and zero nays, motion was approved.

 Resolution 2018-19 Authorizing Mayor Rice to withdraw from the Wells Fargo Bank savings account \$75,000.00 to include with the amount of \$75,339.95 withdrawn from the First Central Savings account to reinvest in a CD at Great Southern Bank.

A motion was made by Council Member Rice and seconded by White to authorize Mayor Rice to purchase checks and envelopes to use with the Quickbooks Online accounting software. With no further discussion, three ayes and zero nays, motion was approved.

Committee Reports

Council Member Rice reported on the Culture CommitteeCouncil Member Rice said she will deliver the announcement to residents, including the upcoming 'BigTrash' pickup day on Monday, June 11. There were no reports from other committees.

Mayor's Report

Mayor Rice provided an update on the ongoing City Hall renovations and said the siding will be installed soon.

<u>Permit</u>

Mayor Rice asked for a motion to grant a permit to 717 Park Avenue for installation of an in-ground swimming pool. Mayor Rice said the owner has provided the plans for the in-ground pool.

A motion was made by Krause, seconded by White to approve the permit. With no further discussion, two ayes and zero nays, permit was approved. Lauritzson recused herself.

July Council Meeting

Council members agreed to change the July meeting due to the 4th holiday, which is the first Wednesday of the month, to Wednesday, July 11 at 6:00 p.m.

Adjournment

There being no further business, a motion was made by Krause, seconded by White to adjourn the meeting. With no discussion, three ayes and zero nays, motion was approved. The meeting was adjourned at 8:27 p.m.

City of Panorama Park PUBLIC HEARING MINUTES June 20, 2018

The City of Panorama Park held a **PUBLIC HEARING** at City Hall, 120 Short Street on Wednesday, June 20, 2018 at 6:00 p.m. to obtain public comment on proposals offered for the sale of the city-owned lot (Lot: 001 JEFFRIES SUBD / Parcel ID 841349201) located at the SW corner of Park Avenue and 2nd Street.

Council Members Present: David White, Jacque Krause, Mandi Lauritzson, and Shawn Rice Council Members Absent: Beth Elmore Presiding: Mayor Ronald Rice

Call to Order of Public Hearing

Mayor Rice called the Public Hearing to order at 6:35 p.m., after a brief delay due to a thunderstorm. Mayor Rice said he had received a phone call from a resident regarding the city-owned lot for sale, expressing their belief that the originally gifted lot was intended for a park in memory of the gifter. Mayor Rice said he had reviewed the deed and abstract, as well as pertinent council minutes and did not find any restrictions indicated for the property use. Council member David White, who was also council member during the time period when the lot was gifted, said there were no restrictions understood by that Council on the lot use. Mayor Rice said an offer has been made for purchase of the city-owned lot, and recognized Ms. Janessa Ormsby, 3449 Moencks Road, Bettendorf, IA, to present her intended use of the lot. Ms. Ormsby said she intended to build a single family home on the lot. Ms.Ormsby showed plans for a recently built 'shotgun' style house, approximately 30 feet by 79 feet. Council members asked if the house would be a 'spec' home. Ms. Ormsby said she preferred pre-sold homes and has possible clients who might be interested. Council members thanked Ms. Ormsby for her presentation and she exited the public hearing.

Public Comment

Mayor Rice opened the floor for public comment on the proposal for the sale of the city-owned lot (Lot: 001 JEFFRIES SUBD / Parcel ID 841349201) located at the SW corner of Park Avenue and 2nd Street or any additional proposals. No citizens were present in the audience and the comment period was closed.

Call for Closed Session



Motion was made by Council member Rice, seconded by Lauritzson to counter the written offer for purchase of the city-owned lot (Lot: 001 JEFFRIES SUBD / Parcel ID 841349201) located at the SW corner of Park Avenue and 2nd Street. Roll aye Krause, aye White, zero nays, motion approved.

A motion was made by Council member Rice, seconded by Lauritzson to adjourn the meeting. With no discussion, aye White, aye Krause, zero nays, motion was approved. The meeting was adjourned at 7:30 p.m.
