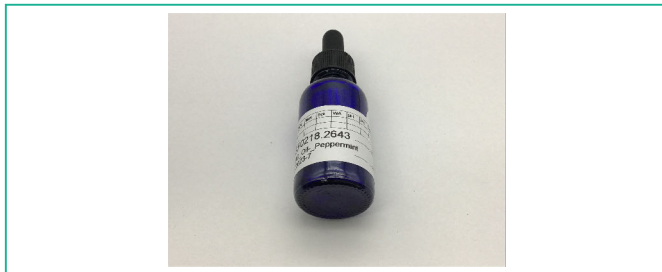

Total Potential THC = THCa \* 0.877 + Δ9-THC + Δ8-THC  
Total Potential CBD = CBDa \* 0.877 + CBD
