STATEMENT REGARDING ARTWORKS ATTRIBUTED TO GAZBIA SIRRY

To Art Market Professionals and To Whom It May Concern,

The Estate of the late Egyptian artist **Gazbia Hassan SIRRY (1925–2021)** has recently identified a number of artworks circulating in the art market attributed to the artist.

Having reviewed the images and information available in relation to these artworks, as reproduced in *Appendix 1* to this statement, the Estate has serious reservations regarding their attribution to Gazbia SIRRY. Accordingly, the Estate has not identified any documented provenance, exhibition history, archival record, or literature references supporting the attribution of these artworks to Gazbia SIRRY.

Therefore, collectors, galleries, auction houses, dealers, art advisors, and other art market professionals are advised to exercise caution when dealing with these artworks, whether in connection with their acquisition, sale, exhibition, publication, reproduction, or any other form of commercial or non-commercial use thereof.

The Estate of Gazbia SIRRY, represented by Mrs. Azza Saadi Naguib Ali, remains the primary reference for matters relating to the documentation, cataloguing, and authentication of the artist's works. The Estate further recommends that appropriate due diligence, consistent with recognized art market practices, be undertaken in relation to any artwork attributed to Gazbia SIRRY and that the Estate be consulted, where appropriate, prior to any transaction, exhibition, publication, or public representation relating to such artworks.

The Estate expressly reserves all rights to take any necessary legal action in relation to the artworks attributed and linked to the late artist, and any associated use, reproduction, publication, display, exhibition, making available, offering for

sale, sale, circulation, or any other use thereof, and to challenge any infringement of the rights associated with the artist's works and legacy, including any act that would constitute distortion, misrepresentation, imitation, forgery, or otherwise be prejudicial to the artist's reputation, status, or artistic history, in any form or manner, in order to preserve the integrity of Gazbia SIRRY's legacy and protect the artist's rights in a manner consistent with her wishes, her will, and recognized professional practices in the art market.

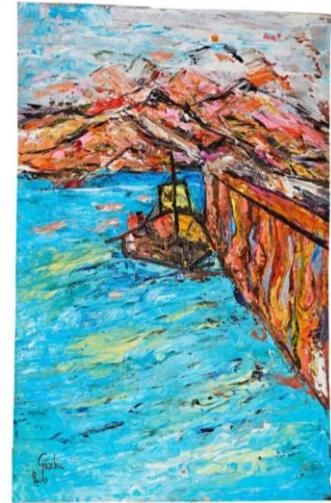
