TO
AMENDED DECLARATION
OF
HARBOR HOUSE WEST, A CONDOMINIUM

The undersigned officers of Harbor House West, Inc., a Florida not-for-profit corporation charged with the operation of Harbor House West, a Condominium, according to the Amended Declaration of Condominium thereof, as recorded in O.R. Book 1018, page 41, et seq., Public Records of Sarasota County, Florida, as amended, hereby certify that the following amendments to the Declaration were approved by not less than a majority of the entire membership at a membership meeting held September 12, 1998. The undersigned further certify that the amendments were proposed and adopted in accordance with the condominium documents and applicable law.

21. OBLIGATION OF MEMBERS. In addition to other obligations and duties heretofore set out in this Declaration, every unit owner shall:

e. Not alter, relocate, or eliminate - either totally or in part - either the interior or exterior walls of a unit without the written consent of the Board of Directors and any mortgagee(s) involved in the ownership of the unit. No change in the configuration or location of common waste water lines is permitted, except for ground floor units. At no cost to the Association, and with prior written approval from the Board of Directors, ground floor units may be permitted to change the configuration or location of common waste water lines but only if additional cleanouts are installed prior to relocating any lines.

(All other Declaration provisions shall remain unchanged.)
