The undersigned further certify that the amendment was proposed and adopted by the membership in accordance with the condominium documentation, and applicable law.

1. Proposed amendment to Article 21 entitled "Obligations of Members," Section (n), to read as follows:

n. ~~Except for the foyer, the kitchen, the breakfast, the screened porch, the storage room and the bathrooms (see attached Exhibits A, B, C, D, E and F) fully carpet all floors, including standard commercial underpadding. Apply sound control, acoustically tested, IIC=62 and STC=59 or better rated under all floor coverings with the exception of carpet. This regulation does not apply to the ground floor units.~~

(All other Declaration provisions remain unchanged.)

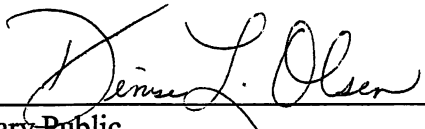
