ABOUT

Live Coal's mission is to transform lives and neighborhoods through art, community development, and education. We believe equitable access to art, artists, art materials, and art spaces is vital to the vibrancy and health of children, individuals, families, and communities.

Our two main programs are The RED and Detroit rePatched. The RED is an interactive children's art museum in Detroit's Piety Hill neighborhood that will open to the public starting in the summer of 2024. The RED organizes programming centered around children being artists! It features a permanent collection of children's art, an early childhood and literacy room, a Lego room, an art-making room, an exhibition space, and a gift shop. Detroit rePatched is an arts-infused green space and art hub in Detroit's Brightmoor neighborhood where we connect art + home, art + land, and art + people. We are building partnerships with local Brightmoor leaders and organizations to provide mutual support for one another while serving Brightmoor residents of all ages and stages of life.

ELIGIBILITY/REQUIREMENTS

- Participants must be between the ages of 3-7 for the 10:00am-12:00pm program and ages 8 -adult for 1:00pm-3:00pm program.
- Participant must have completed registration and legal forms prior to participation.
- Participant must bring their own water bottle and/or snacks if needed.
- While it is optional, we highly recommend participants attend all sessions to get a well-rounded arts programming experience. Please be sure to mark which days you will attend so we can open up sessions for others who are interested and/or on waiting list!

SCHEDULE/SESSIONS

- All programming takes place on Mondays from July 8-August 26, 2024 at our Detroit rePatched site. We will meet at 14143 Bentler Street and move throughout the site as needed to complete various activities.
- Programming for ages 3-7 is from 10:00am-12:00pm and programming for ages 8-adult is from 1:00pm-3:00pm. Some exceptions are made for those who need accommodations. Please ask a staff member.
