



Shiny Apple Cabins Giveaway Terms & Conditions

1. Eligibility

The giveaway is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Shiny Apple Cabins, its affiliates, subsidiaries, advertising and promotional agencies, as well as their immediate family members or individuals residing in the same household, are not eligible to participate or win.
