#### **Background and Purpose**

#### **MULE DAY, Columbia, TN**

Mule Day is an annual celebration held each spring to recognize the history and contributions of this unique hybrid equine. Mules are highly valued for their hard work, strength, stamina and intelligence, honoring that legacy is why the Mule Day Committee and the Maury County Bridle & Saddle Club have chosen to offer "blue collar" scholarships to the young people of Maury County. For 50 years Mule Day has supported many charities ranging from construction and site improvements at the Maury County Park to local schools and civic organizations. The pressing need for those with CTE & Vocational training in Maury County offers the Maury County Bridle & Saddle Club and Mule Day the opportunity to give back and improve the lives of all Maury County residents.

#### Eligibility

The applicant must be a current resident of Maury County Tennessee or an active member of the Maury County Bridle & Saddle Club with plans to pursue a post high school CTE or Technical School program. The applicant must be a high school senior or recent GED graduate without full time post-secondary experience. Applicant should have applied to a post-secondary program, and acceptance will be verified before scholarship is awarded. Preference will be given to students who:

- Are active members of the Maury County Bridle & Saddle Club.
- Are Mule Day volunteers.
- Exhibit financial need.
- Applicants with less than perfect academic records are encouraged to apply.
- Scholarships are ONLY available for CTE (career & technical education) and Vocational Training Programs. No funds may be used for post-secondary degreed programs.
- Scholarship funds may be used for approved tuition fees, books, supplies, program required tools and equipment.
- All applications must be complete and contain all required signatures.

Amount of Award of up to \$2,500.00 per scholarship, funds will be awarded based upon program cost and financial need. Those participating in multi-year programs may reapply, individual Mule Day Scholarship will be awarded annually.

Due Dates: Applications will be due on March 11, 2024. Awards will be announced by April 1, 2024. Use of Award This award may be used toward tuition, fees, instructional materials or supplies. All awards will be paid directly to the institution of enrollment by the Maury County Bridle & Saddle Club.

## The Mule Day Sponsorship Committee will select the recipients of these scholarships and reserves the right to amend this document on an annual basis.
