Adoption Agreement

This contract is a written agreement to transfer ownership of an adoptive pet, from Love Connection Dog Rescue to _____. Upon completion of the seven (7) day trial period, I Acknowledge receiving the above animal and I understand and agree to the following terms:

1. I understand that I am receiving the above dog upon completion of a standard home visit, safety check. The typical trial period lasts seven (7) days. If the dog is returned under terms of agreement within seven (7) days, I will be issued a refund of fifty (50) percent of the adoption fee. The remaining fifty (50) percent is nonrefundable. X_____
2. I understand that the dog will need to complete the vaccination series, spay or neuter as noted on this contract as a contingency. The adoption requires that is completed within the recuse and done by the rescues chosen veterinary office. Love Connection Dog Rescue reserves the right to reclaim the dog if the vaccinations, spay and neuter are not completed as required before the dog turns six (6) months of age. X_____
3. I understand that I am adopting this animal without any behavior, temperament or health guarantees. I assume all risks associated with bringing a new animal into my home. This animal may exhibit unexpected behavior, display an undesired temperament, or require expensive medical treatment for a new or pre-existing illness, or condition. I am adopting this animal as is, and I am completely responsible and obligated to pay any expenses related to this animal incurred from this date forward. Love Connection Dog Rescue will not provide medical care. We will not reimburse for any expenses, including medical. A licensed veterinarian may not have examined this animal and, it is recommended that this animal be kept separate from existing animals until thoroughly examined by a veterinarian. X _____
4. I agree to provide care from this day forward to my new pet. This includes adequate quality food and water to maintain healthy living, a clean shelter within a comfortable temperature range, and necessary medical treatment and veterinary care, including annual vaccinations. I will only transport this animal inside an enclosed vehicle. If I can no longer meet these expectations I will only surrender back to the rescue. X _____
5. I will not keep this animal outdoors for extended periods of time and I understand that this animal is an indoor companion. I will always provide inside housing and at no time will the animal be housed outdoors, chained or tied. X_____
6. I will NOT alter the dog's appearance in any way shape or form (e.g. cropping, docking) except for routine grooming. X_____
7. I will be the animal's primary caregiver and the animal will reside with me. If the animal does not prove suitable, I will return it to Love Connection Dog Rescue and no other organization or individual. I agree never to sell, trade or surrender the pet to any agency or person without giving prior notice to Love Connection Dog Rescue and I agree that Love Connection Dog Rescue will have first option of reclaiming the pet. X_____

8. If the above animal becomes lost, stolen or deceased, as a courtesy I will notify Love Connection Dog Rescue, immediately. If my dog becomes lost, I will assist in the search of pet and make every reasonable effort to locate my pet. X_____
9. I agree that the adoption fee is non-refundable and there is no reimbursement if I return the dog to Love Connection Dog Rescue for any reason. X
10. If there is any reason to rehome the pet or I can no longer care for the pet I will return the above pet to Love Connection Dog Rescue and not rehome or surrender to any other rescue, individual or organization. X_____
11. I release and agree to hold harmless Love Connection Dog Rescue and its members and volunteers from any claim, cause of action or liability for any and all injuries or damage which this animal may cause. X_____
12. No other agreements are in effect, and there is no one else authorized to make other agreements or guarantees with regard to this animal. X_____
