New Business:

Deed Restrictions:

As discussed at the February 1st Annual Meeting, the Deed Restrictions will be renewed as is. Kathy indicated that the attorney the Board decided to use requests a retainer in the amount of \$1,000.00 to start working on the renewal. L. Ferringo made a Motion to retain the attorney for \$1,000.00 to work on renewing the Deed Restrictions. A. Daly seconded. All in favor. Motion carried.

Garage Sale:

The Annual Cudjoe Gardens Garage sale will be held in March. Leigh Anne will place in the e-Minder, and request owners to let us know if there are any items they would like to highlight in the advertisement. Allison will coordinate with Leigh Anne.

Complaints:

- Chicken Coop: In January, the Board received a complaint about a house on 5th Avenue West with chickens and a coop, which violates the Cudjoe Gardens Deed Restrictions. Kathy sent a letter to the homeowner asking for compliance. The chickens have not been removed as of the February Board meeting. The Board discussed and agreed that this needs to be escalated. This is an egregious violation of the Deed Restrictions. A. Daly made a Motion to request our attorney send a letter to the homeowner to urge removal of the chickens as this is a clear violation of the Cudjoe Gardens Deed Restrictions. R. Blair seconded. The majority were in favor; one abstained. Motion carried.
- Overgrowth in a Canal: In January, there were complaints of overgrowth in two different canals causing a navigational hazard. The property locations at issue are: 21087 4th Avenue East and 21076 3rd Avenue East. Kathy sent letters to the homeowners. This is a code enforcement issue. The Board agreed that if nothing is done, then we need to submit a complaint to the County. Kathy will follow up on this issue.
- Overgrowth and trailers in front yard: There was discussion of overgrowth and two trailers in the front yard of the house at 28966 9th Avenue West. Kathy will send a letter to the homeowners to request moving the trailers from the front yard and cleaning up the overgrowth.
- **Issue with "barracks":** There was discussion of a large number of people living at the home at 20966 2nd Avenue West. The Board discussed and agreed to contact the Tax Assessor's office to submit a complaint as this residence is homesteaded.
- January's Board meeting: (status not discussed at the February Board meeting)
 - A camper showed up on 1st Ave West that might be housing people; we need to send a
 letter to the owner of the house. Unclear if people are living in it. Ken/Kathy to investigate
 and send a letter if necessary. We need to confirm if anyone is living there; if so, CGPOA
 may be able to file the complaint with code enforcement or try to talk to the owner.
 - Another property on 1st Ave West has all construction equipment on their property. This
 is the house that is being built by the owner, but he has a permit. Andrew will talk to the
 owner and see what can be done about the equipment. We need the complainant to file
 a formal complaint about the equipment to the CGPOA Board in writing.
