# Please Trim Your Vegetation!

All vegetation that overhangs a canal must be trimmed back so as not to impede boat traffic. Please note that there are not many vacant lots left--we are about filled up. That means that we have more boats in the neighborhood than we have ever had. Add the many boats that come in for mini-season and with short-term rentals and we have an increased potential for collisions and other accidents. You may think to yourself, "but wait, I am an expert boat handler". Maybe, but there are a great many who are not and need all of the room they can get. Per County Code, every lot owner is responsible for their property. Please take the time to go out and look your property over. If you have vegetation that overhangs a canal, or creates a "blind bend", clean it up and get in compliance with applicable regulation (10% of the canal's width).
