Notes from the President (Katherine Winters):

By the time you read this, we will have survived Mini Season and live to talk about it in the coming months. The board is still here working for you. We are investigating and taking action where warranted on several complaints that we received. I do not make it a habit to discuss those actions in the newsletter because we do not want to pit neighbor against neighbor.

On the legislative front, several things that may impact the Gardens happened. At the county commission meeting, \$329,936.00 in grant money from FDOT was acquired for the Florida Keys Overseas Heritage Trail with the connection at Cudjoe Gardens. We do not know exactly what this means. The commissions appointed two pro-housing members to the Affordable Housing Advisory Committee. The commission granted approval to advertise a Public Hearing to adopt a glitch Ordinance to remove the requirement in Monroe County Code 2-700 that appointments to the Affordable Housing Advisory Committee be accomplished by resolution. If this is approved, then there will be no public insight or input into who is appointed to the AHAC. Beware: Parking violation fees in Key West (and possibly more of Monroe County) will increase from \$20 to \$200. The change was made because it was cheaper for people to pay the fine than the fee charged by parking lots.

The CGPOA reviewed the by-laws for the association. (These are the by-laws and NOT the deed restrictions). Several questions have come up over the last few months concerning different interpretations of the by-laws. We found there are several areas where there is inconsistency and lack of clarity. Over the next few months, we will be revising the by-laws to be consistent. We hope to have that work completed no later than the next annual meeting. We will send out any changes before the meeting so you can review them before taking a vote. If you are interested in those discussions, please come to the next board meeting. One of the questions being discussed is who is allowed to attend the board meetings - anyone or only paid members. If you have an opinion on that question, please attend the meeting or contact one of the board members. There are certainly pros and cons on this issue.

Love Your Dog but Not Their Poop:

This is a repeat of an article that appeared in the April Newsletter. We still have a problem. In Cudjoe Gardens, we love our dogs. We even have birthday parties for them.
