Pet owners unite (Cindy Dresow): Our Cudjoe Gardens RESPONSIBLE Pet Owners need to influence those who are not responsible. "Pick Up After Your Pet" signs are posted, yet some allow their pets to leave their deposits anywhere, without picking it up. This gives all pet owners a 'bad name'. We have a leash law; pets are not allowed to run loose. **When ALL pet owners responsibly pick up after their pets, Cudjoe Gardens will be an even greater area!**

How to Navigate To and From Cudjoe Gardens (Andrew Daley): This article is for information purposes only and should not be used as a navigation tool).

The first couple of trips to and from the two entrances aCudjoe Gardens can be confusing. There is the main channel (from the entrance to the bridge), an auxiliary channel (to and from the marina) and the locally maintained “sailboat channel” on the western side of the neighborhood.

Let’s start inbound from the entrance. The entrance channel is well marked. There are some places that are subject to shoaling but for most boats with less than 4 ½ draft there should be no problems. Remember—the channel markers from Daymark 1 to Daymark 10 are maintained by the Coast Guard. From Daymark 11 on they are maintained by Monroe County. So far, so good. You are inbound and want to go to either the marina or western entrance. You should see a “Marina” arrow on Daymark 16. Turn to the right just before you get to the Daymark and keep it to port. Head directly for the leading markers for the auxiliary channel (1A and 2A). Remember—you are now in a new channel, inbound, so Red Right Returning (from the sea). If you want to go to the marina, make the indicated 90 degree turn to the right and proceed between the buoys (locally maintained). Slow to idle before entering the canal. If you want to go to the western entrance go through the end of the channel (don’t turn to the marina) and gradually turn toward the white house with the deep-blue roof. Be aware that there are the remains of an old daymark that are difficult to see to your left, so exercise caution.

If you live on the west side and have a trawler or sailboat, you should use the “sailboat channel”. Continue down the main channel until you get to Daymark 21. Turn to the right, following the buoys. You will be making a sharp right turn as you approach

the mangrove barrier, then follow until the last green, then turn left and make the entrance. The buoys will (very) occasionally be off station, so you need to proceed slowly and read the water until you are thoroughly familiar with the channel. We will mark the GPS positions of all the daymarks and buoys as soon as we can (due to Covid issues) and provide them to everyone in the CGPOA.

Remember---there are flats between the main channel and the western entrance. Unless you use the sailboat channel you will do some real damage to the seagrass, run aground, or both. Don't do it! Stay in the marked channels.

One additional note---GPS is a wonderful tool, but it is no substitute for keeping a watchful eye open for what is ahead of you. Also, every GPS unit is subject to error due to a variety of factors, sometimes up to 50 feet. At sea that is no problem. In a 50-foot-wide channel at night it certainly can be. Be aware of your surroundings and old piece of nautical wisdom: don't go faster than the speed with which you want to collide with a solid object. If visibility is bad or if you are not familiar with your surroundings, SLOW DOWN.

Late Wednesday, Put out Household Trash
for **Thursday** morning pick-up

Please ask your yard service crew to have all yard trash in the bins for pick-up on Wednesday morning,

so that the bins can be removed from the street the rest of the week. **Thank you!**
