Message from the Board (Kathy Winters): Folks, your Cudjoe Gardens Property Owners Association has been busy. First, you will be hearing more from me, Kathy Niemann, this year. As with any organization, we needed someone who could speak on behalf of the CGPOA as a whole and I agreed to assume that responsibility. I feel it is a deep honor to serve in this way. We spent our last meeting organizing for the new year and assessing where we stood on outstanding items. Here are some of the active issues.

- FKAA has not complied with Deep Well use for treated sewage. Through FOLKS (Friends of the Lower Keys) we agreed to support the issue of not using shallow wells.
- As with any new year and volunteers, we needed to add an additional signatory on our checking account.
- The sign at the entrance is still in progress. We are waiting on a permit from the county.
- We have received complaints about houses within the garden begin rented for less than 28 days. Through a letter, we reminded everyone we knew of that has short term rentals of that restriction. Did you know that the county is very active in this area? Last year, there were \$155,000 in fines on Cudjoe. Of course, those were not all in the gardens.
- We are continuing to work on acquiring no wake zone signs from FWC.

- We also decided to continue our support of FIRM (Fir Insurance Rates for Monroe) through a \$500 donation.
- We need your help, if you know what is happening with the old restaurant near the marina, please contact one of the board members.

The board is here to serve the community. If you know of something going on in the community or the area that needs our attention, please contact one of the board members. Thank you on behalf of the Board. Kathy

Short Term Rental List: (Kathy Winters): I have been contacted several times about any potential rental houses in the Gardens. It occurred to me that it would be good to have a list of available short-term rentals. If you have a short-term rental and would like to include your property, please send your address and best to contact you. This is strictly voluntary.

Dig Deep Cudjoe (Jan Edelstein): Good news – After over 6 years of vigilance, litigation, and public advocacy, we have reached an agreement in principle with DEP for it to issue a permit that restricts the operation of the shallow wells at the Cudjoe Regional Wastewater Treatment Plant. No longer will the shallow wells be authorized for primary use, but only for backup use in the case of emergency or repair to the deep well, and only for limited time periods.

We can congratulate ourselves as an effective association. Along with the Sugarloaf Shores Property Owners Association, we joined, in 2014, with two individual fishermen and their pro-bono attorney, Caron Balkany, to wage this fight for clean water. Our POAs provided the funding for the initial joint legal challenge, and for expert witnesses, along with hundreds of hours of advocacy, citizen science, and pro-bono legal work. We thank Ms. Balkany,

and her clients, and particularly the POAs' lawyer, Diana Davis, who worked tirelessly for us for a very small fee.

We also thank the co-founders of Dig Deep Cudjoe, Jan Edelstein of Cudjoe Gardens and Jan Diamondstone and Diane Johnson of Sugarloaf Shores. Dig Deep advocated for a dye tracer study by the National Marine Sanctuary's principal investigator for water quality, Dr. Henry Briceno. Finally, we thank Kirk Zuelch, the former FKAA Director, for his leadership in engaging an unbiased academic to study the hydrogeology of the area, which led to FKAA's decision to build a deep well, even when DEP refused to require it.

Unfortunately, in many other Keys communities, DEP continues to permit the shallow well disposal of millions of gallons of partially treated wastewater. But that is a battle for another day. In the meantime, let us always remember: "Never doubt that a small group of thoughtful, committed citizens can change the world: indeed, it's the only thing that ever has." - Attributed to Margaret Mead, anthropologist, recipient of the Planetary Citizen of the Year Award in 1978.

Deed Restrictions (Cindy Dresow): Deed restrictions are what help to make Cudjoe Gardens such an attractive neighborhood. Our new CGPOA President, Kathy Neiman asked that each Board Member choose a month and a Deed Restrictions to focus on for an e-minder. My choice is #8. Nuisances - The last line reads," Line fences and hedges must not exceed four feet in height." As you drive up and down the Keys, take note of hedges or fences that exceed our four-foot limit.

They are rarely attractive, and certainly not "neighborly" in appearance. Our four-foot limit is a really good idea!
