REMINDERS

Please make sure you are physically counting each pill and writing down the number you counted on your controlled drug sheets.

Do not assume the amount written on the bubble pack is accurate.

The physical count should **always** match the count on the drug sheets since you're simply recording what was counted.

No addition or subtraction is needed if you're counting the pills and recording that count.

Do not assume your own count is accurate from the previous count.
