- Double check that prescribed medications are the same on the doctor's note, prescriptions, and MAR before giving the medication.
- Please remember to check
 your mailbox every time you
 come in to the office. There
 could be documentation
 needing signature,
 competencies, performance
 evaluations, or quarterlies for
 your review.
