

# MUTTON BUSTIN' COMPETITION 2026

Mutton Bustin' will be presented during each of the three performances of the Coulee City Last Stand Rodeo – Friday, May 22<sup>nd</sup> at 7pm; Saturday, May 23<sup>rd</sup> at 7pm; and Sunday, May 24<sup>th</sup> at 5pm.

Mutton Bustin' is open to children ages 3-8 years old with a maximum weight of 60 lbs. All participants will be required to weigh-in at the Rodeo Grounds the night of the competition – NO EXCEPTIONS!

Participants will be limited to 8 per performance and will be signed up for each day on a first-come, first-serve basis. Please state below your first, second, and third preference for which day you would like your child to ride. You will be contacted when your participant has been assigned a day. (Methods of payment accepted: check made out to Coulee City Rodeo Association, cash, or PayPal/Venmo/ApplePay available upon request.) **Participants, plus one adult, will be given wristbands upon check-in for entry into the rodeo!**
