

Historian's Corner

As I sit here amidst the wind and the rain of Hurricane Irene I got a chance to look through an old TCA national Officer's Reporter, Vol. 5, No. 4 dated March 31 1984.

This document's editor was John Parker, Who was serving as National Secretary. John is a Charter Member of TCA and is currently still residing in the Western Division. He served for several years as the TCA Historian. The report speaks to a number of issues facing TCA including Membership complaints, guidelines for open meets, and a report from the budget and finance committee. As has been said before, much of this is still relevant today.

Of note in this report was the announcement of Honorary Membership made for then President Ronald Reagan. There is a moving story behind this nomination and acceptance. Bob (Robert Strauss, 77-12013) a school teacher from Raritan, NJ, and his students put together a white and gold Lionel campaign train that was presented to the President. When the presentation was arranged, Bob contacted the TCA Board of Directors (BOD) for approval on Honorary Membership. John, as Secretary, sent out a ballot to the BOD and an expedient approval was forthcoming. On March 18, 1984, the train was accepted by Maureen Reagan, daughter of the President, on his behalf, and confirmation of the acceptance of his Honorary Membership. A celebration of Mr. Reagan's second term and quite a point of pride for our association.

Housed at the National Toy Train Museum are trains on permanent loan from the White House Gift Unit representing President Reagan's love for toy trains. Included is a Western Coil and Electric Burlington Zephyr streamline engine and cars which you can find on display in the Streamliners display across from the mint Car and beside the 1928 Dealer Display.

View from the Observation Car by George Tsakiris

Architect E. Francis Baldwin and the Mount Clare Passenger Car Shop (B&O Museum)

In a previous installment of View from the Observation Car, the Point of Rocks railway station and an overview of it's renowned architect, E. Francis Baldwin was discussed. Mr. Baldwin designed over 500 buildings in his lifetime and his work can be found from New York to Georgia. However, most of his buildings were in Maryland including many railroad stations and other railroad buildings during his 25 year association with the B&O. He began working for the B&O in 1872. One of the most known and visible of his buildings is the Mount Clare Roundhouse better known these days as the B&O Railroad Museum.

This site is full of history, the first commercial railroad track was laid within the Mount Clare complex in 1829. The first passenger service occurred in 1830 and consisted of horse drawn rail cars; the cars were basically converted stage coaches! The first telegraph message was sent from here to Washington DC in 1844. A new brick Mount Clare Station was built in 1852 (currently part of the museum) and is adjacent to the roundhouse.

Locomotive, freight car, and passenger car manufacturing and maintenance were conducted at the Mount Clare complex. This 40+ acre complex is the oldest railroad manufacturing facility in the US and at its peak employed over 3,000 people.

The Mount Clare Roundhouse was built in 1884 to service B&O passenger cars. When completed it was the largest circular industrial building in the world at 235 feet in diameter and 123 feet in height. What a magnificent structure! This building is prominent in downtown Baltimore and can easily be seen from the highways or Orioles Park at Camden Yards.

Technically, it is not a roundhouse (used to store and service locomotives) but a circular railcar service facility. The roundtable within the car service facility is so efficient that two men could turn the turntable without the aid of a motor or animal. Air conditioned passenger cars were developed here in the 1920s.

The last B&O steam locomotive was built at Mount Clare in 1948. With the advent of diesel locomotives several of the service facilities at Mount Clare were no longer needed, including the roundhouse (Mount Clare Passenger Car Shop). Luckily through the years the B&O had a good

sense of its history and collected locomotives, railcars and artifacts. The former car shop at Mount Clare was selected to hold the B&Os collection and the B&O Transportation Museum at Mt. Clare opened July 4, 1953.

Ironically, the museum outlived its namesake company and was, thankfully, maintained by successors Chessie and CSX. The museum with E. Francis Baldwin's car shop as the centerpiece was designated a National Historic Landmark in 1961. In 1990 CSX deeded the facility to not-for-profit museum organization which then became affiliated with the Smithsonian.

In 2003 a large snowfall caused portions of the roof to collapse and cause considerable damage to some of the collection. The building was beautifully restored, visitor facilities expanded, and display of the collection was improved. Repair to the damaged collection continues to this day.

Rail fans this is the beginning of railroads in the US and E. Francis Baldwin's car shop is the centerpiece!



FINALLY GETTING STARTED

When construction finally got started in 1975, the Mass Transit Authority took the least expensive route. They took the least expensive route. It ran from Owing Mills to Charles St. and Baltimore St, and later on to John Hopkins Hospital. The route to Glen Burnie came much later. The original route was to use the Western Maryland right of way, which made it least expensive. Then the second phase took portion of the Baltimore & Annapolis Railway... right of way. Even this wasn't cheap, the Federal Government for 80% of the construction.

In 1979, the order 72 Budd cars along with 136 cars with Mamie Florida for a grand total of 208; the price was cheaper when they ordered more. The cars were 75 feet long and seat 76 people and could accommodate 70 people standing. They were made of unpainted stainless steel for easier maintenance. The had 75 hp and could reach a speed of 70 mph.

There were complaints all over the construction about loud noise and dirt. But the most prevalent was the future Charles St. Station. When the digging got in full force, the dump company that was hired to remove the dirt 2 miles had spilled dirt up to 1/2 to 2 inches in height on the roadway. Baltimore City contacted the traffic division to levied the problem. The traffic division assigned 2 police officer to levied the problem, with instruction to give citation on any violation the dump trucks they made. After 3 days there were only 2 truck working the site the rest of the truck driver refused to work. They had the dump truck fixed and about a month later all traffic citations were heard in court. I should know I was one of those police officers. TO BE CONTINUED...
