

#### Items that the Board discussed included the following:

- Treasurer Glenn MacKinnon reported that the checking account balance as of May 28th is \$12,025.87 and the CD has a balance of \$2,085.97. We have made a \$4000 disbursement to the 2010 convention.
- Membership Director Carol McGinnis reported that we currently have 330 members; and that 31 members have not renewed from 2007.
- Art mentioned how the Chapter Newsletter has received many accolades from many divisions where they want to model their newsletters off of ours; we should be proud of the chapter's accomplishments.
- The board reviewed topics for the General Membership meeting.
- Nicholas, Glenn, and David were appointed to review and recommend revisions to be made to the WB&A By-Laws.
- The Annapolis Meet will be held February 14th, 2009. Pete Jackson discussed the options for the meet in Virginia, where Kena was the most promising. It was decided to keep Kena as our December venue signing a contract for 5 years for \$2000 on the 2nd Saturday of December.
- Nicholas reported on the success of the trip to Altoona as well as the upcoming planned outing to Roanoke, VA August 30th—31st. There was discussion of options for a holiday chapter outing.
- Mary reported there were 86 kids register this pas April York Kids Korner. Need everyone's help in October.
- Dan Danielson volunteered to head up the Nominating committee for the 2009-2010 Elections to fill 3 Board of Director positions and the Eastern Division representative.

Meeting adjourned at 11:00 PM. Next meeting will be August 20, 2008 at the home of Pete and Mary Jackson. The Secretary's Report was accepted as Published.



## In the Danger of Peril....

On a day that promised to be cold, wind blown, zero visibility, and with a chance of thunderstorms we were delighted to encounter clear, sun drenched scenery, only to be sidetracked by being a part of an historic derailing of the cog railway. WB&A members Dave and Jeanne Sealing, Chuck and Carol McGinnis were among 50 TCA members at the Burlington convention on board the Cog Railway in Bretton Woods, New Hampshire on the afternoon of Sunday, June 29, 2008.

For those who have never been, the cog railway works by having a cog attached beneath an 1800's steam engine that pushes a coach loaded with people up a track positioned on a sloping trestle to the top of Mt. Washington. There are three cog switches on the track that are thrown as trains ascend and descend, each requiring the control of 9 separate moving parts. After spending 20 minutes at the summit, the train comes back down with the engineer braking the engine and a brakeman in the coach braking that car. The two vehicles at this point can, and often do, create a gap between them. There are usually three trains climbing and descending the mountain at any one time. Coming down on our trip the engine passed safely through the Waumbek switch and with no warning, the right front wheel on the trailing coach derailed. The clunk was obvious, and the train came instantly to a complete stop. Our able brakeman, Alex, assured us that we were safe, and we should remain in the car, and he stepped outside to examine the damage. The crew radioed down to the base station and they sent up another train that commenced to "rescue" us. We were all calm, content, and enthralled.

With the assistance of the crew we climbed down one ladder to the track, across the outside track, then down another ladder to the ground. The crew then shifted to the rescue train, unloaded the equipment for right the stranded coach, and brought us up another ladder and aboard. Those of us who were on the train, stuck at 4200 feet above sea level, on the side of Mt. Washington the highest peak in New Hampshire, with 46 other TCA members, will never forget this adventure.

## Tall Tales, Mainly They Were True... by Boxcar Brian


#### UNCOMMONLY GOOD SENSE?

## Stan's Trolley Tidbits UNITED RAILWAY COMPANY

The United Railway Company is remembered for building eight car barns. The first one was located in West Baltimore at Edmondson Avenue and Popular Grove Street. Today the building is still there, which is now owned by the city of Baltimore, being used as a storage warehouse. Another one was located at North and Gay Streets, though it has been gone for a long time. The next one was built at Lombard and Have Streets in July of 1908. This building stood vacant for a long time and was then converted to housing for senior citizens, which is still in use today. The last one was built in 1910 as a modern fireproof car barn with offices at Harford Road and Monticello Street which has been gone for quite some time now.

There were other innovations for United Railway in 1910. On Christmas Day the first day of the Pay As You Enter abbreviated to P.A.Y.E was put into service.

The company started the task of enclosing the platform of all of their cars with a permanent vestibule.

A human touch was furnishing a seat for the motorman, but he was required to get up from his wooden stool whenever the street car entered the downtown where the traffic was heavy.


A lesser known service was discontinued by United Railway which was started by the Baltimore and Northern Railway, an express delivery service of delivering packages in some areas of Baltimore City and County.

## The First 2010 Convention Die Cast Truck is Available !!!



## Sam's Train Wrecks By Sam Geiser

A serious rear-end collision occurred on the Lackawanna Railroad on July 4th, 1912. An excursion train bound for a holiday at Niagara Falls had to stop because of a stalled freight near Corning, New York. A thin fog was creeping up from a nearby river as a flagman went back a half mile to protect his train. Automatic block signals also operated to protect the halted excursion during its sojourn. About a quarter of an hour after the halt, the rear flagman saw a passenger express comes down on him fast. He waved and shouted but the express tore by at sixty-five m.p.h. In another moment heard it crash into the rear of the standing train. Thirty-nine passengers lost their lives and eighty-six were injured.

The old wooden coach at the rear of the train was totally destroyed. Although the next car was a steel construction, its vestibules and platforms were badly crushed at both ends. In fact, the damage done to this steel car continued well into the seating area. The third car from the rear, the wooden sleeping coach was telescoped two-thirds of its length by the steel car. Both cars then fell on their sides into a culvert. The wooden sleeping coach was so badly smashed up that the wreckage was burned on the site.

What caused the accident? Evidently, the engineer of the rear train did not see the signals which told him to stop. Investigation found the signals in good working order. The guilty engineer had been employed by the Lackawanna for forty-two years; yet he disregarded the signals showing danger ahead. He must not have seen the signals at all. He of course testified that fog obscured the signal, but most witnesses said the fog was too light to cause any obstruction. The Engineer was quickly removed from the company after the investigation concluded that it was not human error.




## Eastern Division President's Message Sam Geiser
