From the Eastern Shore, take U.S. 50 West. Merge onto MD-665 E/Aris Allen Blvd E via EXIT 22 to MD-2 N/Solomons Island Road exit toward Parole. At the traffic signal, stay straight to go onto Pythian Dr. Bear left.
