A meeting member asked: What do bylaws say about giving money to students?

Answer: Nothing, but money is giving under Lizanne's guidance/approval

A meeting member asked: Will we accept donations to help offset costs?

Answer: Yes, we will.

A meeting member commented: Bylaws needs to be public, accessible, and up to date re: donations

Answer: All requests go through Lizanne. Club moderators know to ask Lizanne for donations, if needed. Lizanne noted donations from SHAA go

to the operating budget. The operating budget would pay for the trip.

A meeting member suggested that moderators attend SHAA meetings.

A meeting member asked: Does SHAA have discretionary funds? Why doesn't money go to alumnae, not just the school?

Answer: We fundraise and give gifts to school mid-year and at the end of year, leaving money for startup for next year.

From the inception of SHAA, funds raised support the school and the sisterhood. Most, if not all, alumni associations use the money in this manner.

Lois commented: we need a bylaws committee. The officers will discuss.

A meeting member commented: we don't raise a lot of money, what we do raise needs to go to school

A meeting member asked: Why aren't we raising more? 29,000 alum – we should raise a lot more.

A meeting member commented: just "giving money to school" isn't enough. Where does it go?

A meeting member commented: it's not about the dollars, it is about the students

A meeting member commented: SHAA will die off without growth
