

## **APPLICATION FOR DRIVER'S LICENCE**

Sault Ste. Marie Police Services Board Bylaw #2011-161

## **INSTRUCTIONS TO APPLICANTS**

- 1. Read the requirements for a licence carefully.
- 2. If you can meet all the requirements, complete the application form in full.
- 3. An authorized representative of the company you want to work for must complete the "Certificate of Intent".
- 4. Bring the completed application form to the Sault Ste. Marie Police Service, 580 Second Line East, Sault Ste. Marie, Ontario.
- 5. If you are granted a licence, you will need to provide two (2) passport size photographs. (50mm x 70mm)

## REQUIREMENTS FOR LICENCE

- 1. Be at least 18 years of age.
- 2. Have a valid unrestricted class "G" driver's licence with no more than nine (9) demerit points issued under the authority of the *Highway Traffic Act of Ontario*.
- 3. New applicants must complete the Police Criminal Records and Judicial Matters check (PCRJMC level 2 records check) online. Payment is by credit card.
- 4. Not have been found guilty of an offence under the *Liquor Licence Act of Ontario* pertaining to the illegal sale or purchase of liquor within the preceding three (3) years.
- 5. Not be suffering from any condition that might render you unfit to drive.
- 6. Provide "Certificate of Intent" from your employer.
